

Saint Mary, Sandwich, together with the interest accrued upon the sums in question, shall cease to form part of the endowments of the said Benefice of Saint Mary, Sandwich, and shall be held by the Governors of Queen Anne's Bounty in trust for, and for the benefit of, the Incumbent of the said Benefice of Saint Clement, Sandwich, and as part of the endowments of that Benefice.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Canterbury.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of "The Ecclesiastical Commission Act, 1868," duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 14th day of January, in the year 1915, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of 'The Ecclesiastical Commission Act, 1868,' Section 3, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme relating to the Dean and Chapter of the Cathedral Church of Lichfield:

"Whereas under and by virtue of an Order in Council of Her late Majesty Queen Victoria, bearing date the 27th day of June, 1876, and duly published in the London Gazette of the 7th day of the following month, as varied by an Order in Council of His late Majesty King Edward the 7th, bearing date the 29th day of January, 1904, and duly published in the London Gazette of the 2nd day of the following month, and by another Order in Council of Your Majesty, bearing date the 19th day of July, 1912, and duly published in the London Gazette of the 26th day of the same month, there is now payable by us to the Dean and Chapter of Lichfield an annual sum of £5,441 Os. 4d. until the said Dean and Chapter shall have been put into possession, in fee simple, of real estates sufficient to secure to them a clear annual income therefrom, after deducting rates, taxes, the cost of agency, and other outgoings, amounting to £5,441 Os. 4d.:

"And whereas the said Dean and Chapter

have not yet been so put into possession of such real estates in substitution for the said annual sum of £5,441 Os. 4d., but the said annual sum continues payable by us under the provisions of the said Orders in Council:

"And whereas there are situate in Gaia Lane, Lichfield, certain premises, known respectively as Nos. 32, 34, 36, 38, and 40, Gaia Lane, together with certain land adjoining the same, the whole containing an area of 629 square yards or thereabouts, lately purchased by us, overlooking the garden attached to the Deanery of the said Cathedral Church, and also certain other property belonging to the said Dean and Chapter, which said premises are shown upon the tracing annexed hereto, and are coloured red thereon:

"And whereas it is desirable that the premises aforesaid should be in the ownership of the said Dean and Chapter, and they have applied to us and we have agreed to transfer to them our interest therein in consideration of the reduction by the sum of £10 Os. 4d. of the annual sum of £5,441 Os. 4d. aforesaid:

"And whereas the terms of such transfer are in our opinion fair and reasonable:

"Now, therefore, we humbly recommend and propose, with the consent of the Dean and Chapter of the Cathedral Church of Lichfield, and with the consent of the Right Reverend John Augustine, Bishop of Lichfield, as Visitor of the said Dean and Chapter, testified by their having hereunto affixed their respective corporate seals, that upon and from the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, and without any further conveyance or act in the law, the premises coloured red upon the said tracing annexed hereto, with their appurtenances, shall, subject always to the liabilities and charges, if any, to which the said property may now be specifically liable, be transferred to the said Dean and Chapter in the manner contemplated by the said Act, and that they shall be entitled to the rents, profits, and proceeds of the property known as Nos. 32, 34, 36, 38, and 40, Gaia Lane, Lichfield, together with the land adjoining, as from the 11th day of November, in the year 1914, and that in consideration of such transfer as aforesaid the payment of the said annual sum of £5,441 Os. 4d. shall be reduced by the sum of £10 Os. 4d. as from the said 11th day of November, in the year 1914.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:
