Widenings of Mitcham-lane and Southcroft-road authorized by the London County Council (Tramways and Improvements) Act, 1909.

Widenings of Belvedere-road, Lambeth, and Church-street, Kensington, authorized by the London County Council (General Powers) Act, 1910.

Widenings of Green-lanes, Balls Pond-road, Southgate-road, High-street, Putney, Putney Bridge-road, High-street, Wandsworth, New North-road, Canonbury-road and St. Paul's-road authorized by the London County Council (Tramways and Improvements) Act, 1910.

Widenings of London-road, Devonshire-road, Waldram-road, Stanstead-road, Catford-hill, Catford-road, Dalston-lane and Graham-road authorized by the London County Council (Tramways and Improvements) Act, 1911.

Widenings of Norton Folgate, Dockyard Rails, High-street, Woolwich, Bromley-road, Green-lanes and Seven Sisters-road authorized by the London County Council (Tramways and Improvements) Act, 1912.

Widenings of High-street, Wandsworth, East-hill, Wandsworth, and Strand (between Adam-street and Durham House-street) authorized by the London County Council (Tramways and Improvements) Act, 1913.

Widenings of High-street, Eltham, and Eltham-road and Piccadilly authorized by the London County Council (Tramways and Improvements) Act, 1914.

Widenings of Spring-gardens, the Mall-approach and Charing Cross authorized by the Mall Approach (Improvement) Act, 1914.

(f) Asylums and institutions and the care of the insane or mentally afflicted and mentally deficient.

(g) Extension of gasmeter testing office, purchase of property for new gasmeter testing office and provision of appliances for testing gasmeters.

(h) The new County Hall in Belvedere-road.

(i) Accommodation for Quarter Sessions and additional accommodation for Stores Department.

(j) The acquisition of lands, provision of schools, reconstruction, adaptation and extension of divisional offices and other purposes of the Acts relating to education (including rehousing persons of the working classes displaced).

(k) The purchase, construction, reconstruction, and equipment of tramways; the provision of buildings, power stations, machinery and rolling stock; the purchase of lands and other purposes in connection with Acts relating to tramways.

(l) Pumping stations, outfalls, machinery, sewers, sludge vessels, and other purposes of main drainage.

(m) Provision of appliances for testing electricity meters.

(n) Establishment of ambulance service.

(o) New Coroner's Court at Wandsworth.

(p) The execution of any powers which may be conferred upon the Council by any Acts passed by Parliament in the present Session.

(q) Generally all other subjects in respect of which capital expenditure may be necessary.

To define the bodies and persons to whom and the extent to which the Council may during the said periods respectively lend money in accordance with the principal Act.

To incorporate or apply all or any of the provisions of the principal Act and of the London County Council (Money) Act, 1914.

To vary and extinguish all rights and privileges which would interfere with the objects of the intended Act or any of them and to confer other rights and privileges.

Printed copies of the proposed Bill will be deposited in the Private Bill Office of the House of Commons, in accordance with the provisions of the Standing Orders, on or before the 14th day of April next.
