

## Distinguished Conduct Medals—Continued.

Regimental No.	Rank.	Name.	Corps.	Action for which commended.
9227	Serjeant ...	Roberts, F. J. C. ...	1st Battalion, Duke of Cornwall's Light Infantry	For conspicuous gallantry on 21st November, 1914, near Lindenhoeck, in extricating men who had been buried by howitzer shells, whilst exposed to heavy fire. At St. Ouen on 8th September and at Lorgies on 21st October, he was brought to notice for gallantry and ability.
6730	Sergeant ...	Roberts, J. ...	1st Battalion, Rifle Brigade	For very great gallantry and devotion to duty. With his company he advanced to cover a section of Royal Field Artillery, and, although shot in five places, kept control of his men. When the guns were withdrawn he was unable through his wounds to come back with his company, but seeing another wounded man he crawled up to render him assistance.
S/4954	Corporal ...	Roe, F. E. ...	1st Battalion, Rifle Brigade, (New Army attached)	For gallant conduct on 18th December, 1914, in voluntarily going to reconnoitre the enemy's trenches and remaining out for a period of three hours in a position of danger.
13573	Second-Corporal	Rogers, C. ...	17th Company, Royal Engineers	For gallant conduct at Givenchy on 25th October, 1914, in leaving his trench and assisting a severely wounded officer into cover, under a heavy shell fire.
1946	Private ...	Rogers, L. ...	2nd Battalion, Welsh Regiment	For conspicuous gallantry at Givenchy on 25th January, 1915, when he located eight Germans in a house, and, after obtaining the assistance of two men, captured four of them and wounded the remainder.
23419	Serjeant ...	Rouse, A. ...	3rd Signal Company, Royal Engineers	For conspicuous gallantry, coolness, and ability throughout the campaign. He succeeded in keeping up telephone communication by constantly repairing the lines under heavy fire between 5th and 20th November, 1914. Six men of his party of thirteen were killed or wounded during this period.
4810	Private ...	Russell, H. ...	2nd Battalion, Scots Guards	For gallantry in conveying messages whilst exposed to very heavy fire.
4811	Acting-Company-Serjeant-Major	Rye, J. ...	1st Battalion, Royal Scots Fusiliers	For gallantry and ability in leading the night attack of 12th November, 1914, and for effecting the removal of our wounded men whilst exposed to a heavy fire.
9555	Acting-Company-Serjeant-Major	St. John, T. ...	1st Battalion, East Lancashire Regiment	For conspicuous gallantry at Le Gheer on 15th January, 1915, in voluntarily going a distance of 35 yards in front of his trench in daylight and assisting in the rescue of a wounded man (who was still being fired at) and conveying him into cover, whilst exposed to heavy fire.
9127	Private ...	Saltmarsh, H. A. ...	2nd Battalion, Devonshire Regiment	For gallant conduct on the night of 20th-21st November, 1914, when on patrol duty in front of the trenches his comrade was shot, and Private Saltmarsh remained with him under a heavy fire, eventually bringing him away to cover of the trenches.
2151	Lance-Corporal	Sanderson, H. L. ...	14th Battalion, The London Regiment (London Scottish T.F.)	For conspicuous gallantry at Givenchy on 22nd December, 1914. Fired upon by two snipers, at a range of 20 yards, he rushed at the men presenting a pair of wire nippers, which they took to be a revolver, and made prisoners of both—notwithstanding that he was quite unarmed.
10126	Private ...	Sargeant, H. ...	4th Battalion, Middlesex Regiment	For gallant conduct on 14th December, 1914, near Kemmel, in voluntarily going out for 50 yards in front of his trench to help a wounded man. Private Sargeant was exposed to close fire for fifteen minutes but succeeded, with the greatest difficulty, in saving his comrade.
