The period (if any) during which contributions were paid during the insurance year by the Crown in respect of the workman by virtue of section 98 of the Act, and one half the total value of such contributions.

One half the total value of the contributions (if any) paid during the insurance year by the employer in respect of the workman and refunded to him under section 96 of the Act.

The period in respect of which the employer and the workman were exempted from unemployment insurance contributions during the insurance year by virtue of section 7 of the Amending Act, and one half the total value of the stamps which would have been affixed to the workman's unemployment book by the employer in respect of that period if such exemption had not been granted.
