In the Matter of LADOGA Limited, and in the Matter of the Companies (Consolidation) Act, 1908.

NOTICE is hereby given, that a petition was, on the 6th day of May, 1915, presented to the High Court of Justice by the above named Company to confirm an alteration of the said Company's objects, proposed to be effected by a Special Resolution of the Company, unanimously passed at an Extraordinary General Meeting of the said Company, held on the 14th day of April, 1915, and subsequently confirmed at an Extraordinary General Meeting of the said Company, held on the 30th day of April, 1915, and which Resolution is as follows:—
