

Stephen, Hampstead, shall be altered so that (firstly) all those portions of the said Parish of Hampstead, and of the said New Parish of Saint Stephen, Hampstead, which are described in the First Schedule hereunder written, and are delineated and set forth upon the Map or Plan hereunto annexed, and are thereon coloured pink, shall be dissevered from such Parish and New Parish respectively, and shall be annexed to, and shall in future form part of, the said New Parish of Christ Church, Hampstead, (secondly) all that portion of the said New Parish of Christ Church, Hampstead, which is described in the Second Schedule hereunder written, and is delineated and set forth upon the said Map or Plan hereunto annexed, and is thereon coloured purple, shall be dissevered from such New Parish and shall be restored to, and shall in future form part of, the said Parish of Hampstead, and (thirdly) all that portion of the said Parish of Hampstead which is described in the Third Schedule hereunder written, and is delineated and set forth upon the said Map or Plan hereunto annexed, and is thereon coloured green, shall be dissevered from such Parish and shall be annexed to, and shall in future form part of, the said New Parish of Saint Stephen, Hampstead.

"And we further represent, recommend, and propose, that nothing herein contained shall prevent us from representing, recommending, and proposing, any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"The SCHEDULES to which the foregoing Scheme or Representation has reference.

"THE FIRST SCHEDULE.

"The territory to be annexed to the New Parish of Christ Church, Hampstead, in the County of Middlesex, and in the Diocese of London, being:—

"I. All that portion of the Parish of Hampstead, in the said County and Diocese, which is bounded upon the west and upon the north-west by the New Parish of All Saints, Childs Hill, Hendon, in the said County and Diocese, upon the north-east and upon the east by the said New Parish of Christ Church, Hampstead, and upon the remaining side, that is to say, upon the south, by an imaginary line commencing at the point where the boundary which divides the said New Parish of Christ Church, Hampstead, from the said Parish of Hampstead, crosses the middle of West Heath Road at or near its junction with the road called The Grove, and extending thence first north-westward and then in various directions along the middle of West Heath Road for a distance of 42 chains or thereabouts to the boundary which divides the said Parish of Hampstead from the said New Parish of All Saints, Childs Hill, Hendon.

"II. Also all those isolated portions of the said Parish of Hampstead which are bounded upon all sides by the said New Parish of Christ Church, Hampstead, and which include the Workhouse belonging to the Borough of Hampstead with the garden attached thereto (part of which was formerly the site of the Hampstead National School for

Boys) and also the Hampstead Provident Dispensary.

"III. And also all those contiguous portions of the said Parish of Hampstead, and of the New Parish of Saint Stephen, Hampstead, in the said County and Diocese, which, taken together, are bounded upon the north by the said New Parish of Christ Church, Hampstead, and upon the remaining sides, that is to say, upon the south-east, upon the south-west, and upon the west, by an imaginary line commencing upon the boundary which divides the said New Parish of Christ Church, Hampstead, from the said New Parish of Saint Stephen, Hampstead, at the junction of Willow Road with Willoughby Road, and extending thence south-westward along the middle of Willoughby Road for a distance of 6 chains or thereabouts to its junction with Rudall Crescent, and extending thence first westward, then southward, and then south-eastward along the middle of Rudall Crescent for a distance of 8 chains or thereabouts to the point where it rejoins Willoughby Road, and extending thence south-westward along the middle of Willoughby Road for a distance of 5 chains or thereabouts to its junction with High Street, upon the boundary which divides the said New Parish of Saint Stephen, Hampstead, from the said Parish of Hampstead, and extending thence north-westward along the middle of High Street (thereby following in part the last-mentioned boundary) for a distance of 17 chains or thereabouts to its junction with Heath Street, and extending thence northward along the middle of Heath Street for a distance of 3½ chains or thereabouts to its junction with Back Lane, upon the boundary which divides the said Parish of Hampstead from the said New Parish of Christ Church, Hampstead.

"THE SECOND SCHEDULE.

"The territory to be dissevered from the said New Parish of Christ Church, Hampstead, and to be restored to the Parish of Hampstead, being:—All that portion of the said New Parish of Christ Church, Hampstead, which lies to the west of the middle of the roads called The Heath and Heath Street and to the south of the middle of West Heath Road, and which is bounded upon all other sides by the said Parish of Hampstead; which said portion of the said New Parish of Christ Church, Hampstead, consists chiefly of the houses and premises known as Tudor House and Upper Terrace House.

"THE THIRD SCHEDULE.

"The territory to be dissevered from the said Parish of Hampstead and to be annexed to the said New Parish of Saint Stephen, Hampstead, being:—All that portion of the said Parish of Hampstead which is bounded upon part of the south-west by the New Parish of the Trinity, West Hampstead, upon the south-east by the New Parish of Saint Peter, Belsize Park, both in the said County and Diocese, upon the north-east by the said New Parish of Saint Stephen, Hampstead, and upon the remaining sides, that is to say, upon the north, upon the north-west, and upon the remaining part of the south-west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Stephen, Hampstead, from the said Parish of
