Warsaw, October 26. The King of Poland continues still at Zolkiew. The Circular Letters are sent out for the summoning of a General Dyet, to meet here on the 20th of December. The Forces of this Crown are separated, and marched to their Quarters, and the Generals are come to Lemberg, where they are to hold a Council of War to Consider about providing for their Subsistence during the Winter.

From General Veterani's Camp at Kapalnas on the Frontiers of Transylvania, October 25. After we had lain some time at Lugos we received advice that a Body of Turks and Tartars was marched towards the River Maros, upon which we decamped on the 18th, and came on the 21st to this place; The design of our several Marches and Encampments being, according to the account we had of the Enemies Motions, to Cover the Principality of Transylvania against their Incursions. Since our coming hither, we understand that the Enemy, after having plundered and burnt 14 or 15 Villages about *Deloccan*, are returned to *Temiswasser*; and that from thence the Tartars intend to go home, and the Furks to their Winter-Quarters, which has made our General resolve to separate his Forces likewise, and to send them to the several Garisons in *Transylvania* where they are to Winter.

Vienna, November 7. All the Advices from the Turkish Frontiers say, that the Grand Visier is returned towards *Adrianople*, having left a strong Garison in *Belgrade*, and posted several thousand Men along the *Sava*. The General Count *de Haydrshelm* is arrived at *Ofen* or *Buda* to adjust Matters with the Deputies of the States of *Hungary* about the Subsistence of the Imperial Forces in their Winter-Quarters. The Imperial Court is returned hither from *Neustadt*.

Frauncefort, November 15. Prince Lewis of Baden continues still at *Herrenberg*, but intends so soon as the Confederate Troops are all in their Winter-Quarters, and that he has given the necessary Orders for the security of the Country on this side the *Rhine*, to go from thence to *Nuremberg* and *Ulma*, to Consult with the States of *Fraxconia* and *Suabia*, about the Preparations for the next year; and in the mean time he hath by Letters represented to them the great necessity there is of hastning the said Preparations, and of providing in time good Magazines, seeing the Enemy have already begun to recruit their Troops, and are laying up great quantities of Provisions and Ammunition at *Philipsburg*, *Landau*, and other Frontier Places.

Cologne, November 17. Our Elector has caused new and strict Orders to be published against supplying the French with Corn or Horses from these parts. They write from the *Upper-Rhine*, that the French have put strong Garisons into *Neustat*, *Landau*, and *Keyserlauterne*, as well as into the City of *Strasbourg*; The rest of their Troops, that served this Summer in the Army commanded by the *Mareschal de Lorge*, are quartered in the *Lower-Alface*, *Suntgow*, and *Burgandy*.

Hamburg, Nov. 17. The Letters from *Berlin* tell us, that new Levies are making for the Elector of *Brandenburg*, within his own Territories. The Electoral Prince of *Hanover* passed through *Minden* on the 11th Instant in his return home from the Campaign in *Flanders*.

Hague, Nov. 20. N. S. They write from *Paris*, that the People there suffer extremely through the scarcity of Corn, which occasions a great cry among them; insomuch that some Commotion is feared: The French King to appease them offers

fers 80 thousand Crowns a month to provide Bread for the poorer sort, but double this Sum will not suffice; The first President of the Parliament is ordered to seek out some Expedient to remedy this growing Evil; which he finds very difficult to do; besides Money becomes very scarce in France, and their Commerce is quite ruined. The City of Paris, to comply with the Kings demand, has promised to furnish Five Millions of Livres, and they are going to raise it by a Poll-Tax. The Letters from Basil of the 8th Instant say, they had advice from Piedmont that the French had quitted their design against Coni, the heavy Cannon that was brought to Saluffes, as they gave out, for that Siege, being sent back to Pignero!

*Plymouth, November 14.* Yesterday arrived here the *St. John Baptiste*, *Sebastian Rodrigues* Master, and from *Cadiz*, laden with Fruit, Oyl, and Wine; The *Richard* and *Michael*, *John Williams*, and the *Swallow*, *Richard Gringe*, both from the *Barbadoes*, and bound for *London*. This day came in the *Golden-Port*, Captain *John Place* Commander, from the *W. I. Indies*; and the *Falcon* of *London*, *George Walker* Master, from *Virginia*; and the *Adventure of London*, *Richard Williams*, from *Barbadoes*.

*Deale, Nov. 17.* On the 15th came into the Downs the *Sterling-Castle* Man of War, with several other Ships from the Northward; who sailed again yesterday in the afternoon with the *Play-Prize*, and the Merchant Ships bound to the Westward. The same day came in the *Hope of London* from the *Barbadoes*, having been 8 weeks in his passage; and a *Portuguese* from *O-Porto*.
