His Majesty the KING has been graciously pleased to award the Victoria Cross to the undermentioned Officers and Non-commissioned Officers:—

Captain Eustace Jotham, 51st Sikhs (Frontier Force).

For most conspicuous bravery on 7th January, 1915, at Spina Khaisora (Tochi Valley).

During operations against the Khostwal tribesmen, Captain Jotham, who was commanding a party of about a dozen of the North Waziristan Militia, was attacked in a nullah and almost surrounded by an overwhelming force of some 1,500 tribesmen. He gave the order to retire, and could have himself escaped, but most gallantly sacrificed his own life by attempting to effect the rescue of one of his men who had lost his horse.

Second Lieutenant George Raymond Dallas Moor, 3rd Battalion, The Hampshire Regiment.

For most conspicuous bravery and resource on 5th June, 1915, during operations south of Krithia, Dardanelles. When a detachment of a battalion on his left, which had lost all its officers, was rapidly retiring before a heavy Turkish attack, Second Lieutenant Moor, immediately grasping the danger to the remainder of the line, dashed back some 200 yards, stemmed the retirement, led back the men, and recaptured the lost trench.

This young officer, who only joined the Army in October, 1914, by his personal bravery and presence of mind, saved a dangerous situation.

No. 465 Lance-Corporal Albert Jacka, 14th Battalion, Australian Imperial Forces.

For most conspicuous bravery on the night of the 19th-20th May, 1915, at "Courtney's Post," Gallipoli Peninsula.

Lance-Corporal Jacka, while holding a portion of our trench with four other men, was heavily attacked. When all except himself were killed or wounded, the trench was rushed and occupied by seven Turks. Lance-Corporal Jacka at once most gallantly attacked them single-handed, and killed the whole party, five by rifle fire and two with the bayonet.

No. 10073 Lance-Corporal Joseph Tombs, 1st Battalion, The King's (Liverpool Regiment).

For most conspicuous gallantry near Rue du Bois, on 16th June, 1915. On his own initiative he crawled out repeatedly under a very heavy shell and machine gun fire, to bring in wounded men who were lying about 100 yards in front of our trenches. He rescued four men, one of whom he dragged back by means of a rifle sling placed round his own neck and the man's body. This man was so severely wounded that unless he had been immediately attended to he must nave died.

His Majesty the KING has been graciously pleased to approve of the undermentioned rewards for gallantry and devotion to duty in the Field:—

To be Companions of the Distinguished Service Order.

Lieutenant-Colonel James Thomas Rankine Wilson, 1st/5th Battalion, The Royal Scots (Lothian Regiment) (Queen's Edinburgh Rifles), Territorial Force.

For conspicuous ability and resource on 19th June, 1915, during operations in the neighbourhood of Krithia, Dardanelles, where he reorganised and carried out the recapture of a Turkish trench from which the troops of another division had been forced back. The success gained was due to Lieutenant-Colonel Wilson's skilful and bold leading and his prompt assumption of responsibility.

Captain Charles Leathley Armitage, 6th Battalion, The Worcestershire Regiment (attached 2nd Battalion).

For conspicuous coolness and gallantry in an assault on the German lines at Richebourg on the night of 15th May, 1915. He led the assault in the face of a very heavy rifle and machine gun fire, and, after his assault had been forced back he skilfully withdrew and reorganised the attack behind our breastworks. He also showed conspicuous ability in organising the rescue of the wounded under heavy fire throughout the night.

Captain Alec Walter Saumarez Brock, 2nd Battalion, The Leicestershire Regiment.

For conspicuous gallantry, near Neuve Chapelle, on May 1st, 1915, when in command of a company containing 50 per cent. of reinforcements who had not previously been under fire. His trench was heavily bombarded and several casualties occurred, while he himself was knocked down and badly bruised by the explosion of a big shell. It was owing to his coolness and skill in getting his men under cover that the casualties were not much heavier and that his company was ready to receive and repulse an infantry attack made later by the enemy. Captain Brock displayed the highest qualities of a company commander under very trying circumstances.

Captain Harold Brown, 5th Battalion, Alexandra, Princess of Wales's Own (Yorkshire Regiment) Territorial Force.

For conspicuous gallantry and ability on several occasions, notably near Hooge, on the night of June 11th, 1915, when he made a very successful reconnaissance of the German trenches. He remained out close to the German barbed wire for 1½ hours, although fired at several times.

Both before and since this occasion Captain Brown has made similar daring and

successful reconnaissances.

Captain William Malcolm Lingard Escombe, 20th (County of London) Battalion, The London Regiment (Blackheath and Woolwich) Territorial Force.

For conspicuous gallantry and skill in establishing himself on the crest of the Givenchy bluff on May 28th, 1915, under very heavy fire, and from there directing bomb-throwers with great success for an hour. His prompt action not only repelled a hostile attack, but secured fresh ground, which was consolidated.

Captain Lewis Pugh Evans, 1st Battalion, The Black Watch (Royal Highlanders).

For conspicuous gallantry and devotion to duty on June 16th, 1915, at Hooge, when, after troops had become much mixed up, he continually moved up and down the firing line under heavy fire from 10 a.m. till midnight reorganising units and bringing back their reports.

Captain Harry Granville Lee-Warner, 9th Battery, Royal Field Artillery.

For conspicuous gallantry and devotion to duty during the operations near Rue du Bois, from 9th to 19th May, 1915. Although wounded on the 9th he remained in command of his battery till forced to give in on the 19th, and during this period he was indefatigable in reconnoitring and reporting on the situation. He was twice shelled out of his observation stations, and did excellent work under heavy shell fire.

Captain Maurice Clive Radford, 1st Battalion, Princess Charlotte of Wales's (Royal Berkshire Regiment).

For conspicuous gallantry and devotion to duty at Cuinchy on the night of 21st June, 1915, when the Germans pumped gas into a mine in which four of our men were on listening post. Under direction of Captain Radford, who displayed great gallantry and resource, the efforts of two N.C.O.'s and two men, who bravely went down the mine, were successful in getting the men out. At about 4.15 a.m. on 22nd June, following their gas attack, the Germans exploded a mine in front of our own, in which were a sergeant and about eight of our men, but owing to the gallant efforts of Capt. Radford, another officer and a few men, who repeatedly went down among the fumes, all the men were rescued, though the rescuers suffered considerably.

Captain Charles Douglas Roe, 1st/4th Gurkha Rifles.

For conspicuous gallantry and resource near the Bois de Biez on 2nd and 4th July, 1915, when reconnoitring the enemy's positions by day. He collected information of great value, and, on one occasion, though opposed by overwhelming numbers, he kept them at bay by bombs and rifle fire, and brought back his party with only one wounded after inflicting considerable loss on the enemy.

Captain James Morison Scott, 7th Battalion, Princess Louise's (Argyll and Sutherland Highlanders), Territorial Force.

For conspicuous gallantry and resource on many occasions. He was the only officer left with his battalion at the end of the day on 24th May, 1915, near Wieltje, where his conduct, when in charge of machine guns, was marked by the highest ability and bravery.

Captain Charles Herbert Mansfield Sturges, 1st Siege Battery, Royal Garrison Artillery.

For conspicuous gallantry and general good work as an observing officer throughout the campaign, notably during the attack on Givenchy on March 19th, 1915, the attack at the Rue du Bois on May 9th, and during attacks on May 15th and 16th. During these last attacks he was shelled out of two houses in succession, but proceeded to a third, where, although blown down the ladder by the force of a shell, he still continued to observe and correct the fire of his battery.

Captain Austin Bradford Woodgate, 3rd Battalion, The King's Own (Royal Lancaster Regiment) (attached 1st Battalion).

For conspicuous gallantry on 24th May, 1915, when, after the Germans had captured the trenches held by the battalion on his right, he with another officer and three men held up the enemy from working along the trench. Although the enemy was in force and with an unlimited supply of hand grenades, he not only held them up, but succeeded under heavy shell fire in capturing two traverses and a German flag which had been put up to mark their position.

Captain Woodgate also rendered in-

Captain Woodgate also rendered invaluable service throughout the winter, especially during the underground fight in

the mine gallery at Le Toquet.

Awarded the Military Cross.

Captain Herbert Davies, 1st/8th Battalion, The Royal Warwickshire Regiment, Territorial Force.

For conspicuous gallantry and resource on many occasions when on patrol duty in front of the trenches, notably on the night of 20th/21st June, 1915, when he carried out a very daring reconnaissance close to the River Douve. From his knowledge of German he obtained very valuable information from the enemy's conversation after passing over ground lit by flares and constantly swept by machine-gun fire.

Lieutenant Arthur Brooks Close-Brooks, 3rd Battalion, The Manchester Regiment (attached 2nd Battalion).

For conspicuous gallantry at Ypres on 10th June, 1915, in attempting to rescue a Non-commissioned Officer belonging to his

regiment. The Non-commissioned Officer was lying 35 yards in front of the enemy's trench, but Lieutenant Close-Brooks crawled out to him in broad daylight. When he found that he was already dead he attached a cord to his body, which was recovered.

Lieutenant Armar Valentine Lowry Corry, 2nd Battalion, Grenadier Guards.

For conspicuous gallantry and ability in the attack at Rue du Bois on 18th May, 1915. When his Company Commander was killed and all the other Officers wounded he reorganised and commanded the Company with great coolness. He has also done good work with patrols near Givenchy.

Lieutenant Thomas Barrie Erskine, 4th Battalion, Princess Louise's (Argyll and Sutherland Highlanders), attached 1st Battalion, The Gordon Highlanders.

For conspicuous gallantry and ability. Between 12th and 20th May, 1915, he obtained definite information of the enemy's dispositions near "Hill 60" by personal reconnaissance by day and night, and, after locating the enemy's nearest occupied trench from a distance of 10 to 20 yards, he checked their activities by incessantly bombing their working parties. His work was marked by equal boldness and judgment.

He has also shown since conspicuous energy and skill in the construction of de-

fences in Hooge Village.

Lieutenant William Kelsey Fry, Royal Army Medical Corps.

For conspicuous gallantry and devotion to duty at Festubert between 16th and 18th May, 1915, while carrying out his work under heavy fire. He was himself wounded while attending to others.

Lieutenant Henry Malkin Hance, Indian Army, Reserve of Officers, attached 176th (Mining) Company, Royal Engineers.

For excellent work and great determination in the preparation of a mine which was successfully sprung at Duck's Bill (near Givenchy) on 15th June, 1915. The success of the mine was largely due to Lieutenant Hance's personal efforts and his fine example under very difficult circumstances.

Lieutenant Maurice Luby, 2nd Field Company, Royal Engineers.

For conspicuous ability and coolness between 26th April and 6th May, 1915, while superintending by night the construction of an advanced trench within from 100 to 200 yards of the enemy. His working party was constantly subjected to sniping, and occasionally to machine gun fire, and it was mainly owing to his coolness and careful instructions that it was possible to complete the work.

Lieutenant Eric Grant Miles, The King's Own Scottish Borderers (attached 5th Signal Company, Royal Engineers).

For conspicuous gallantry. During a critical period in the attack on "Hill 60" and neighbouring trenches on May 1st, 1915, he succeeded in mending the telephone wire along the railway cutting under such heavy

shell fire that messengers were unable to get through.

Lieutenant Denys Max Thomson Morland, 3rd London Field Company, Royal Engineers, Territorial Force.

For conspicuous gallantry on 25th May, 1915, at Givenchy, when he accompanied a London battalion in an assault on the German trenches, and, finding the entrance of a mine, explored it alone, making prisoners of 18 Germans who were hiding in it. Throughout the night he displayed great energy and bravery in endeavouring to consolidate the newly-won position.

Lieutenant David James Sheires Stephen, M.D., Royal Army Medical Corps.

For conspicuous gallantry and devotion to duty in attending to the wounded under heavy shell fire on several occasions, notably on the night of 23rd April and on the 8th May, 1915.

He has usually performed his gallant work single-handed, and by his cheerfulness and pluck has encouraged all around him.

Lieutenant Lord Alistair St. Clair Sutherland-Leveson-Gower, Royal Horse Guards.

For conspicuous gallantry near Ypres on 13th May, 1915, when he led up his men to the enemy's trench, and, although wounded, continued to direct their fire and movements.

Lieutenant Oscar Taunton, 1st East Lancashire Field Company, Royal Engineers, Territorial Force.

For conspicuous gallantry on June 4th, 1915, during operations S. of Krithia, Dardanelles, when he held back the enemy from advancing along a trench on the left flank, which was much exposed. By means of bombs and hand grenades he personally held his position for over two hours. He picked up several of the enemy's bombs and threw them back before they exploded.

Second Lieutenant John Hugh Vaudrey Barker-Mill, 1st Battalion The Duke of Edinburgh's (Wiltshire Regiment).

For conspicuous gallantry on 16th June, 1915, at Hooge, when, after leading an assault with great dash, he succeeded in taking some 300 yards of the enemy's trench, capturing many prisoners and two machine guns. Although wounded he remained with his company consolidating the position gained.

Second Lieutenant Edward William Bryan, 1st Battalion, The Welsh Regiment.

For conspicuous gallantry and devotion to duty on 7th and 8th of May, 1915. His company dug a trench during the night of the 7th, and held it all next day under such heavy shell fire that the trench became obliterated, and two machine guns were buried. He not only kept his company in hand and cheerful, but rendered assistance to another regiment, and, on being relieved, refused to quit his position till the machine guns, one of which was 12 feet underground, were dug out. This work was done under heavy fire.

Second Lieutenant Eric Krabbe Colbourne, 3rd Battalion, Princess Charlotte of Wales's (Royal Berkshire Regiment) attached 1st Battalion.

For conspicuous gallantry and devotion to duty at Cuinchy on the early morning of 22nd June, 1915. The Germans, following a gas attack, exploded a mine in front of one of our own, in which was a sergeant and about eight of our men, but, owing to the gallant efforts of Second Lieutenant Colbourne, another officer and a few men, who repeatedly went down among the fumes, all the men were rescued, although the rescuers suffered considerably.

Second Lieutenant Herbert Cutbush, 47th Battery, Royal Field Artillery.

For conspicuous devotion to duty at Givenchy on 24th and 25th May, 1915, when our front trenches were heavily shelled and many casualties had occurred. On both days he rendered great assistance in rallying the infantry, in re-establishing the front line of trenches, and in tending and getting away the wounded.

Second Lieutenant Carlton Griffith Davies, 24th (County of London) Battalion, The London Regiment (The Queen's) Territorial Force.

For excellent work on 25th and 26th May, 1915, at Givenchy, in leading bombers and himself throwing bombs up a trench, thereby keeping the enemy's bombers at bay at a critical moment. Subsequently he took a leading part in capturing 20 Germans in a mine.

Second Lieutenant Leonard Alsager Elgood, 1st/5th (Angus and Dundee) Battalion, The Black Watch (Royal Highlanders) Territorial Force.

For excellent work when in charge of a working party clearing away wire previous to the attack on May 9th, 1915, near Rouges Bancs. For four nights his party worked in spite of machine gun and rifle fire, and in the last night continued to work all night although suffering heavy casualties.

Second Lieutenant Oliver Dwight Filley, Royal Flying Corps (Special Reserve).

For conspicuous gallantry on July 6th, 1915, when he and his observer were cooperating with our artillery. On two occasions, although they were not in a special fighting machine, they attacked German aeroplanes and, after driving them away, resumed their artillery work. Finally two hostile aeroplanes came up simultaneously, and, although they had only five rounds of ammunition left, they at once proceeded to attack. In this encounter the observer was killed in the act of firing, and the engine damaged, but Second Lieutenant Filley landed safely in our lines.

Second Lieutenant Richard Percival Gatehouse, 24th Battery, Royal Field Artillery.

For conspicuous gallantry and skill as forward observing officer in the attack on Bellewaarde trenches on 16th June, 1915. He succeeded at great personal risk in ob-

taining and getting back valuable information to his battery and to the infantry battalion with which he was working. When his wires were cut and his signallers wounded or away with messages, he himself personally took back information, thus enabling fire to be brought on objectives as they presented themselves.

Second Lieutenant Geoffrey Malcolm Gathorne-Hardy, 1st/4th Battalion, Princess Charlotte of Wales's (Royal Berkshire Regiment), Territorial Force.

For excellent reconnaissance work along the German front, whereby much very valuable information has been obtained, notably on 18th June, 1915, when, with a lance-corporal, he crawled out by day and brought back most useful information regarding the German lines.

Second Lieutenant Edward Longsdon Jerwood, 1st Battalion, Princess Charlotte of Wales's (Royal Berkshire Regiment).

For conspicuous gallantry and devotion to duty during an attack on the enemy's trenches south of Richebourg l'Avoué on the night of May 15th, 1915, when in charge of machine guns. He established a machine gun in position in the second captured German trench under rifle and machine gun fire, and also recovered a machine gun that had been lost between the first and second German trenches.

On 17th May he gallantly led a section which established two machine guns in the firing line under shell fire, and set a fine example to the men under his command.

Second Lieutenant Charles Claude Edmonstoune Manson, Indian Army, Reserve of Officers, attached 1st/4th Gúrkha Rifles.

For conspicuous gallantry and coolness on reconnaissance duty by day near Bois de Biez, when assistant to another officer on 2nd and 4th July, 1915. By his prompt action on one occasion he enabled his patrol to retire without loss after acquiring very valuable information.

Second Lieutenant Lawrence William McArthur, Honourable Artillery Company, Territorial Force.

For conspicuous gallantry on June 16th, 1915, at Hooge. When our troops were forced to retire from the 3rd line of German trenches he rallied part of the retiring troops and reoccupied and held the vacated trench under heavy fire until he was himself forced later to withdraw owing to retirements on his flanks. He was severely wounded on this occasion.

Second Lieutenant Hilgrove McCormick, 1st Battalion, The Prince of Wales's Leinster Regiment (Royal Canadians) (formerly Captain 3rd Battalion).

For conspicuous gallantry and devotion to duty. During the second battle of Ypres, under heavy fire, and when himself suffering from the effects of gas, he personally assisted in the removal of the wounded, and materially helped to repulse an attack by moving single-handed his

machine-gun from a damaged emplacement

and mounting it elsewhere.

Also at Le Toquet, during the nights of 30th and 31st May, 1915, he made a gallant and very useful reconnaissance in front of our trenches.

Second Lieutenant John Brown Savage, 1st Battalion, The Royal Welsh Fusiliers.

For conspicuous gallantry at Festubert, on May 16th, 1915, when, as Acting Adjutant of his battalion, he displayed the greatest bravery in cheering his men forward although severely wounded near the German parapet. At Neuve Chapelle also he displayed marked ability and courage.

Second Lieutenant Hugh Urquhart Scrutton, 1st Battalion, The Northumberland Fusiliers.

For conspicuous gallantry and devotion to duty at Hooge on 16th June, 1915. He led his platoon with great dash under heavy fire against the enemy's line, and later, though wounded in the head, continued to direct the work of a bombing party. Although again wounded in the head, knocked down and rendered deaf, he returned to his trench after his wounds had been bound up, and remained at his post till dark.

Second Lieutenant Carleton Stuart Searle, Unattached List, Indian Army, attached 1st Battalion Princess Charlotte of Wales's (Royal Berkshire Regiment).

For conspicuous gallantry and devotion to duty on several occasions, notably on the night of 15th May, 1915, near Richebourg L'Avoué, when, although wounded, he took over command of his company and remained at his post all night and all the next day consolidating a captured trench. He has also displayed great coolness and skill in handling patrols, especially at Cuinchy on the night of 27th April.

Second Lieutenant Francis Arthur Sutton, Royal Engineers.

For conspicuous gallantry during operations west of Krithia, Dardanelles, on 22nd May, 1915, when attached to the Royal Inniskilling Fusiliers. During a counterattack, which he led, he picked up and threw back into the enemy's trenches, at great personal risk, a number of bombs, thereby probably saving many lives. He threw six bombs, and the seventh exploded in his hand.

Second Lieutenant Alfred Marshall Thom, 1st Battalion, The Gordon Highlanders.

For excellent reconnaissance work on many occasions, notably between May 12th and 20th, 1915, north of "Hill 60," between May 26th and June 8th in front of Hooge, and also between 14th and 16th June, near Hooge. He has since been severely wounded.

Second Lieutenant Thomas Wallace, 3rd Battalion, The Border Regiment.

For conspicuous gallantry on the night of June 10th-11th, during operations S.W. of Krithia, Dardanelles, when he volunteered to lead a party to clear the enemy out of a trench in which they were constructing a

sap. He advanced under a heavy fire, and rushed the trench at the head of his men, bayonetting some and driving the remainder away. He afterwards led his men down a communication trench, showing great coolness, and remained there until the enemy evacuated it. The success of this enterprise was mainly due to his personal bravery and gallant leading.

Second Lieutenant (temporary Lieutenant) Nevile West, 2nd Battalion, Princess Charlotte of Wales's (Royal Berkshire Regiment).

For conspicuous gallantry on the 9th May, 1915, near Rouges Bancs. When the leading line of his battalion was unable to advance, all the officers having been shot, he rushed forward and attempted to lead the men on. He was almost immediately shot down, but, picking himself up, he went forward again till he was hit a second time.

Second Lieutenant (temporary Lieutenant) Ernest Hamilton Whitfeld, 2nd Battalion, The Oxfordshire and Buckinghamshire Light Infantry.

For conspicuous gallantry on 16th May, 1915, at Richebourg L'Avoué, when, with a small party, he entered the German trenches, and, after being wounded, attacked a detachment still working a machine gun, killing seven men, taking three prisoners, and capturing the gun.
