LIGHT RAILWAYS ACTS, 1896 AND 1912.

DEARNE DISTRICT LIGHT RAILWAYS ORDER.

The Light Railway Commissioners have re-submitted to the Board of Trade for confirmation, under the above-mentioned Acts, an Order made by them authorising the construction of Light Railways in the County Borough of Barnsley, in the Urban Districts of Ardsley, of Worsborough, of Wombwell, of Wath-upon-Dearne, of Swinton, of Bolton-upon-Dearne, and of Thurnscoe, in the parish of Brampton Bierlow, in the Rural District of Rotherham and in the Parish of Adwick-upon-Dearne, in the Rural District of Doncaster, all in the West Riding of the County of York.

DEFENCE OF THE REALM (LIQUOR CONTROL).
