or other officer of the Board or of a Local Authority, produce and show to him the Licence, if any, necessary for the movement, and shall allow it to be read, and a copy of or extract from it to be taken by the person to whom it is produced.

(2.) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or

other officer.

Offences.

- 16.—(1.) If an animal is moved in contravention of this Order, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the animal is moved shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
- (2.) If a person in charge of an animal being moved, where under this Order a Movement Licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.
- (3.) If any person, with a view unlawfully to evade or defeat the operation of this Order, by washing, or in any other manner, takes out, effaces, or obliterates, or attempts to take out, efface, or obliterate, any mark painted on any animal as required by this Order, the person doing the same, and the person causing, directing, or permitting the same to be done, and the owner of the animal, and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(4.) If any person enters any field, shed, or other place in contravention of this Order, or of a notice served thereunder, such person shall be deemed guilty of an offence against the Act

of 1894.

Revocation.

17. The Pembrokeshire (Foot-and-Mouth Disease) Order of 1915 is hereby revoked.

Interpretation.

18. In this Order-

"The Act of 1894" means the Diseases of Animals Act, 1894.

- "The Board" means the Board of Agriculture and Fisheries.
- "Animals" means cattle, sheep, goats and swine.
- "Slaughterhouse" means any premises where animals are habitually slaughtered, and includes a bacon factory.

Other terms have the same meaning as in the Act of 1894.

Commencement.

19. This Order shall come into operation on the fourth day of November, nineteen hundred and fifteen.

Short Title.

20. This Order may be cited as the Pen-BROKESHIRE (FOOT-AND-MOUTH DISEASE) ORDER OF 1915 (No. 2).

FIRST SCHEDULE.

ZONE I.

A zone in the administrative county of Pembroke, comprising the parishes of Angle, Rhoscrowther, Hundleton, and Pwllcrochan.

Zone II.

A zone in the administrative county of Pembroke, comprising:—

The borough of Pembroke; and

The parishes of Castlemartin, Warren, St. Twynnell, Bosherston, St. Petrox, Stackpole Elidor, Lamphey, Hodgeston, Nash, Cosheston, and Upton.

ZONE III.

A zone in the administrative county of Pembroke, comprising:—

The petty sessional division of Roose (excluding the parishes of Treffgarne, Camrose, Roch, Nolton, Lambston, and Hamlet of St. Martin, but not excluding the detached parts of the last mentioned parish).
