The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

- 1. The Somerset and District (Foot-and-Mouth Disease) Orders of 1915 (Nos. 1-5) shall be read and have effect as if the area described in the Schedule hereto formed part of the Zone I described in the Schedule to Order (No. 5) instead of forming part of the Zone II therein described.
- 2. If any farm (except any detached part) is partly within the area described in the Schedule hereto and partly within the Scheduled District to which the Somerset (Glastonbury District) (Foot and Mouth Disease) Order of 1915 applies, the whole shall be deemed to be within the said Scheduled District.
- 3. This Order may be cited as the Somerset and District (Foot-and-Mouth Disease) Order of 1915 (No. 6), and shall be read with the Orders referred to in Article 1.
