Now, therefore, His Majesty, by virtue and in exercise of the powers in this behalf by the Foreign Jurisdiction Acts, 1890 and 1913, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the Colonial Probates Act, 1892, shall, from the date of this Order, apply to the Sierra Leone Protectorate, and the Uganda Protectorate, as though each of the said Protectorates were a British Possession.

And the Right Honourable Andrew Bonar Law, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.
