Provided always, and it is hereby declared, that this prohibition shall not apply to any such goods which are imported under licence given by or on behalf of the Board of Trade, and subject to the provisions and conditions of such licence.

This Proclamation may be cited as the Prohibition of Import (No. 7) Proclamation, 1916.

And whereas by Order in Council dated the 29th day of February, 1916, His Majesty was pleased to order that The Military Service Act, 1916, should extend to the Isle of Man, subject to the adaptations therein contained:

And whereas the said Military Service Act, 1916, has been amended and further enactments made by the Military Service Act, 1916, (Session 2):

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the Military Service Act, 1916, (Session 2), shall extend to the Isle of Man subject to the following adaptations:—

1. For the words "*Great Britain*" there shall be read "*The Isle of Man*."

For the expression "*The Military Service Act, 1916*" there shall be read "*The Military Service (Isle of Man) Act, 1916*."

2. For Paragraph 3 of Sub-section 1 of Section 1 the following provision shall be substituted:—

"*The appointed date shall, as respects men who come within the operation of this Section on the date of the Order in Council extending this Act to the Isle of Man, be the thirtieth day after the date of such Order, and as respects men who come within the operation of this Section after the said date, be the thirtieth day after the date on which they so come within the operation of this Section.*"

3. For Sub-section (1) of Section 17 the following provision shall be substituted:—

"17 (1) *This Act may be cited as 'The Military Service (Isle of Man) Act, 1916, No. 2,' and the Principal Act and this Act shall be read together and may be cited together as 'The Military Service (Isle of Man) Acts, 1916.'*"
