PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Order in Council dated the twenty-eighth day of November nineteen hundred and fourteen, His Majesty was pleased to make Regulations (called the "Defence of the Realm (Consolidation) Regulations, 1914") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm:

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915:

And whereas the said Regulations have been amended by various subsequent Orders in Council:

And whereas it is expedient further to amend the said Regulations in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the fol-

lowing amendments be made in the said Regulations:—

1. After regulation 8c the following regulation shall be inserted:—

"8cc. It shall be lawful for the Admiralty or Army Council or Minister of Munitions, with a view to the more efficient or increased production of war material, to require any person to communicate to a person nominated for that purpose by the Admiralty, Army Council, or Minister of Munitions, all such particulars as may be in his possession of any invention, or process or method of manufacture, or of any article manufactured or proposed to be manufactured, and to furnish drawings, models, or plans thereof, and to explain and demonstrate the same to such person, in all or any of its uses and workings; and if any person fails or neglects to comply with any such requirement he shall be guilty of an offence against these regulations; and if the requirement is addressed to a company, every director, manager, or officer of the company who fails or neglects to comply with such requirement shall also be guilty of an offence against these regulations.

"If any person, except as authorised by the Admiralty or Army Council or Minister of Munitions, discloses or makes use of any information obtained in consequence of any re-

quirement made under this regulation or communicated to him by the person by whom it was so obtained, he shall be guilty of an offence against these regulations.

"No communication of an invention made in consequence of any requirement under this regulation, or the use thereof by any person authorised under this regulation to use it, shall prejudice any right of the inventor or owner thereof subsequently to apply for or obtain a patent for the invention."

2. After regulation 19 the following regulation shall be inserted:—

"19A. If any person, having in his possession or under his control any document, note, photograph, sketch, plan, design, model, pattern, specimen, or article (including any key or other instrument affording means of access to information) of such a nature as is calculated to be, or might be, directly or indirectly useful to the enemy,—

"(a) without lawful authority destroys, makes away with, or allows any person to inspect or to be in possession of such document, note, photograph, sketch, plan, design, model, pattern, specimen, or article as aforesaid; or

"(b) loses, fails to take reasonable care of, or so conducts himself as to endanger the safe custody of, such document, note, photograph, sketch, plan, design, model, pattern, specimen, or article as aforesaid; or

"(c) retains such document, note, photograph, sketch, plan, design, model, pattern, specimen, or article as aforesaid in his possession or control when he has no right to retain it, or when it is contrary to his duty to retain it; or

"(d) fails to comply with any directions issued by lawful authority with regard to the custody, production, or the return of such document, note, photograph, sketch, plan, design, model, pattern, specimen, or article as aforesaid;

he shall be guilty of an offence against these regulations, and if any person, without lawful authority or excuse, has in his possession or under his control any document, note, photograph, sketch, plan, design, model, pattern, specimen, or article as aforesaid, he shall be guilty of an offence against these regulations."

3. After regulation 40B the following regulations shall be inserted:—

"40C. If any man of His Majesty's reserve forces not for the time being subject to the Naval Discipline Act or to military law, when under orders to report himself for medical examination, malingers or feigns any disease or infirmity, he shall be guilty of an offence against these regulations.

"If any such man produces any disease or infirmity in himself, or maims or injures himself, or causes himself to be maimed or injured, or takes or uses any drug or preparation, or does any other act, calculated or likely to render him, or to lead to the belief that he is, permanently or temporarily unfit for service, he shall be guilty of an offence against these regulations, unless he proves that he did not so act with the intent of escaping service.

"If any person—

"(a) wilfully produces any disease or infirmity in, or maims or injures, any such man of His Majesty's reserve forces, or any man belonging to any other of His Majesty's

forces, whether or not he knew that the man was such a man as aforesaid; or

"(b) with the intent of enabling any such man to render himself, or induce the belief that he is, permanently or temporarily unfit for service, supplies to or for such a man any such drug or preparation as aforesaid;

he shall be guilty of an offence against these regulations."

4. After regulation 42 the following regulation shall be inserted:—

"42A. If any person attempts to induce a member of any of His Majesty's forces to act in a manner which such person knows to be in contravention of the King's Regulations and Admiralty Instructions or Admiralty Orders as respects the Navy, or the King's Regulations or Army or other Orders as respects the Army, he shall be guilty of an offence against these regulations."

The KING has been pleased, by Warrants under His Majesty's Royal Sign Manual, each bearing date the 12th instant, to appoint Sir James Thomas Woodhouse to be Chairman, and Edward Shortt, Esq., K.C., to be a Member of the Defence of the Realm Losses Commission and of the Southern Division of the Defence of the Realm Licensed Trade Claims Commission, consequent upon the retirement of the Right Honourable Henry Edward Duke, on his appointment as Chief Secretary for Ireland.

AUTHORIZATION.

I, Andrew Bonar Law, His Majesty's Principal Secretary of State for the Colonies, hereby authorize the person for the time being holding the appointment of Staff Paymaster, New Zealand Expeditionary Force, and any person or persons authorized by him to perform on my behalf in accordance with the conditions laid down in the Regimental Debts Act, 1893, 56 Victoria, Chapter 5, and any Regulations prescribed under the said Act, any of the following functions, namely:—

(1) To receive any surplus arising under the Regimental Debts Act, 1893, of any member of the New Zealand Expeditionary Force who may die subject to military law during the present war, and all arrears of pay, batta, grants and other allowances in the nature thereof standing to the credit of the deceased.

(2) To pay out of the money so received any debts payable out of the same in accordance with the provisions of the said Act and regulations, and any expenses or charges which under the said Act, or any regulations prescribed thereunder, may be chargeable against the same.

(3) To pay or apply the monies so received, or any residue thereof remaining after payment of debts, charges and expenses as aforesaid, to the representative of the deceased in the United Kingdom, or in the absence of any such representative to pay or apply the same to or for the benefit of such persons in the United Kingdom as appear to be beneficially entitled to the personal estate of the deceased or to or for the benefit of any such persons.

(4) To transmit any balance in his or their hands not disposed of as aforesaid to the Minister of Defence at Wellington, New Zealand, for distribution.

And I hereby authorize the Minister of Defence at Wellington, New Zealand, and all persons duly authorized by him to dispose of and distribute on my behalf any part of the estate coming to his or their hands as aforesaid in accordance with the conditions in the said Act and any regulations prescribed under the said Act.

And I declare that for the purposes of exercising the powers delegated to them all persons authorized to act on my behalf shall have and exercise all such further or incidental powers as are by the said Act or any regulations prescribed thereunder conferred or vested in the Secretary of State.

And I hereby further declare that all receipts of money or effects of any member of the New Zealand Expeditionary Force deceased during the present war, and all payments out of monies so received, and all distributions, disposals and applications of such monies and effects had or made before the date hereof by the said Staff Paymaster or by any person or persons acting under his authority in pursuance of the said Act, and of regulations prescribed thereunder, have been had and made under the authority of and with the sanction of the Secretary of State.

DEFENCE OF THE REALM (LIQUOR CONTROL).

ORDER OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE EAST MIDLANDS AREA.

Any person contravening any provision of this Order or of the Liquor Control Regulations is liable to imprisonment for six months with hard labour and a fine of £100.

We the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:—

Limits of Area.

1. The area to which this Order applies is the East Midlands Area, being the area comprising the City of Nottingham, the County Boroughs of Derby, Leicester and Northampton, and the Counties of Derby (excepting the Boroughs of Chesterfield and Glossop, and the Petty Sessional Divisions of Buxton, Chapel-en-le-Frith, Bakewell, Eckington, Chesterfield and Glossop), Nottingham (excepting so much of the Petty Sessional Division of Worksop as is comprised in the West Riding Area as defined and specified in paragraph II of the Schedule to an Order in Council dated the 10th day of November, 1915), Leicester and Northampton.

Hours during which Intoxicating Liquor may be Sold.

A.—For Consumption ON the Premises.

2. (1) The hours during which intoxicating liquor may be sold or supplied in any licensed premises or club for consumption on the premises shall be restricted and be as follows:—

On Weekdays:—

The hours between 12 noon and 2.30 p.m. and between 6.30 p.m. and 9.30 p.m.

On Sundays:—

The hours between 12.30 p.m. and 2.30 p.m. and between 6 p.m. and 9 p.m.

Except between the aforesaid hours no person shall—

(a) Either by himself or by any servant or agent sell or supply to any person in any licensed premises or club any intoxicating liquor to be consumed on the premises; or

(b) Consume in any such premises or club any intoxicating liquor; or

(c) Permit any person to consume in any such premises or club any intoxicating liquor.

B.—For Consumption OFF the Premises.

(2) The hours during which intoxicating liquor may be sold or supplied in any licensed premises or club for consumption off the premises shall (subject to the additional restrictions as regards spirits) be restricted and be as follows:—

On Weekdays:—

The hours between 12 noon and 2.30 p.m. and between 6.30 p.m. and 8.30 p.m.

On Sundays:—

The hours between 12.30 p.m. and 2.30 p.m. and between 6 p.m. and 8 p.m.

Except between the aforesaid hours no person shall—

(a) Either by himself or by any servant or agent sell or supply to any person in any licensed premises or club or (except as hereinafter expressly provided) dispatch therefrom any intoxicating liquor to be consumed off the premises; or

(b) Take from any such premises or club any intoxicating liquor; or

(c) Permit any person to take from any such premises or club any intoxicating liquor.

Additional Restrictions as to Spirits.

3. In addition to the above general restrictions as to hours during which intoxicating liquor may be sold or supplied, the sale and supply of spirits in licensed premises and clubs shall be subject to the following special restrictions, that is to say:—

(a) No orders for spirits to be consumed off the premises shall be given by or accepted from any person actually present in any licensed premises or club except on Mondays, Tuesdays, Wednesdays, Thursdays, and Fridays, and during the hours between 12 noon and 2.30 p.m.

(b) Spirits to be consumed off the premises must not (except as hereinafter expressly provided) be dispatched from any licensed premises or club, nor must they be taken therefrom by the person to whom they are sold or supplied or by any person acting on his behalf, except on the days and during the hours aforesaid.

(c) Spirits to be consumed off the premises shall not be sold or supplied or taken from any licensed premises or club in any bottle or other vessel not bearing a label showing the name and situation of the premises or club, or in any vessel of a capacity less than one-

reputed quart, or in any less quantity than one reputed quart, or in any open vessel.

(d) No spirits to be consumed off the premises shall be sold or supplied in or taken from any refreshment room in any railway station.

Conditions as to Distribution.

4. No person shall either by himself or any servant or agent—

(a) Sell, supply, distribute or deliver any intoxicating liquor from any van, barrow, basket, or other vehicle or receptacle unless before the liquor is dispatched it has been ordered and the quantity, description and price thereof, together with the name and address of the person to whom it is to be supplied, has been entered in a delivery book or invoice, which shall be carried by the person delivering the liquor, and in a day book which shall be kept on the premises from which the liquor is dispatched.

(b) Carry or convey in any van, barrow, basket or other vehicle or receptacle while in use for the distribution or delivery of intoxicating liquor, any such liquor not entered in such delivery book or invoice and day book.

(c) Distribute or deliver any intoxicating liquor at any address not specified in such delivery book or invoice and day book.

(d) Refuse to allow any constable to examine such van, barrow, basket or other vehicle or receptacle or such delivery book or invoice.

(e) Solicit or canvass for orders for, or collect or receive payment for, intoxicating liquor except at the licensed premises.

(f) Send or cause to be sent or leave or cause to be left to or at any premises, or to or with any person, or order form for intoxicating liquor.

(g) Cause or permit any payment for intoxicating liquor to be made on his behalf by any person in the service or employment of the vendor of the liquor, or, being a person in such service or employment, make any such payment as the agent or on behalf of the purchaser of the liquor.

Hours of Opening for the Supply of Food and Non-intoxicants.

5. Notwithstanding any provisions of this Order or of the Law relating to licensing or the sale of intoxicating liquor:—

(a) Licensed premises may be opened for the supply of food and non-intoxicating liquor at the hour of 5.30 in the morning on all days and be kept open for this purpose from that hour until the evening closing hour prescribed by the general provisions of the Licensing Acts; and

(b) Refreshment houses may be kept open for this purpose at any time during which they may be kept open under the general provisions of the said Acts.

Saving Provisions.

6. Nothing in the foregoing provisions of this Order shall be deemed to prohibit, in cases where the same is otherwise lawful:

(a) The consumption of intoxicating

liquor by any person in any licensed premises or club where he is residing; or

(b) The consumption of intoxicating liquor at a meal by any person in any licensed premises or club at any time within half an hour after the conclusion of the afternoon and evening hours during which the sale or supply of intoxicating liquor is permitted by this Order; Provided that the liquor was sold or supplied and served during such hours at the same time as the meal and for consumption at the meal; or

(c) The sale or supply of spirits to any person producing a certificate in writing dated and signed by a duly qualified medical practitioner that the spirits are immediately required for medicinal purposes and specifying the quantity of spirits required; Provided that the quantity sold or supplied shall not exceed the quantity specified in such certificate; or

(d) The dispatch from licensed premises for delivery at a place more than five miles distant of any spirits or other intoxicating liquor in the forenoon of any day on which the sale of the same for consumption off the premises is permitted by Article 2 (2) and Article 3 of this Order as the case may be.

Treating prohibited.

7. No person shall either by himself or by any servant or agent sell or supply any intoxicating liquor to any person in any licensed premises or in any club for consumption on the premises unless the same is ordered and paid for by the person so supplied; nor shall any person order or pay for or lend or advance money to pay for any intoxicating liquor wherewith any other person has been or is to be supplied for consumption on the premises; nor shall any person consume in any licensed premises or club any intoxicating liquor which any other person has ordered or paid for or agreed to pay for or lent or advanced money to pay for;

Provided always that if such intoxicating liquor is supplied or served for consumption at a meal supplied at the same time and is consumed at such meal the provisions of this regulation shall not be deemed to be contravened if the person who pays for such meal also pays for such intoxicating liquor.

For the purposes of this regulation consumption on the premises includes consumption of intoxicating liquor in or on any highway open ground or railway station adjoining or near to the licensed premises or club in which the liquor was sold or supplied; and any person consuming intoxicating liquor in or on any such highway open ground or railway station shall be deemed to consume the liquor in such licensed premises or club as the case may be.

Credit Prohibited.

8. No person shall—

(1) (a) Either by himself or by any servant or agent sell or supply in any licensed premises or club or dispatch therefrom any intoxicating liquor to be consumed either on or off the premises; or

(b) Consume any intoxicating liquor in or take it from such premises or club;

unless it is paid for before or at the time when it is supplied or dispatched or taken away.

Provided always that if the liquor is sold or supplied for consumption at a meal supplied at the same time and is consumed at such meal, this provision shall not be deemed to be contravened if the price of the liquor is paid together with the price of such meal and before the person partaking thereof quits the premises.

(2) Introduce or cause to be introduced into the area any intoxicating liquor unless it is paid for before it is so introduced.

Long Pull Prohibited.

9. No person shall either by himself or by any servant or agent in any licensed premises or club sell or supply to any person as the measure of intoxicating liquor for which he asks an amount exceeding that measure.

Dilution of Spirits.

A.—Compulsory.

10. (a) No person shall on or after the second day of October, 1916, either by himself or by any servant or agent—

(1) Sell or supply to any person in any licensed premises or club for consumption on or off the premises or dispatch therefrom any whisky, brandy, rum or gin unless reduced to 25 degrees under proof.

(2) Introduce or cause to be introduced into the area any whisky, brandy, rum or gin unless reduced to 25 degrees under proof.

Provided always that the foregoing provisions of this Article shall not affect the sale or supply of whisky, brandy, rum or gin which is proved to have been bottled before the twenty-fifth day of September, 1916.

B.—Permissive.

(b) The sale of whisky, brandy, rum and gin reduced to a number of degrees under proof which falls between 25 and 50 is hereby permitted.

(c) In determining whether an offence has been committed under the Sale of Food and Drugs Acts by selling to the prejudice of the purchaser whisky, brandy, rum or gin not adulterated otherwise than by an admixture of water, it shall be a good defence to prove that such admixture has not reduced the spirit more than 50 degrees under proof.

Sale of Light Beer.

11. The Order of the Central Control Board (Liquor Traffic) made on the third day of July, 1916, with reference to the sale of light beer shall apply to the area and come into force on the twenty-fifth day of September, 1916.

Explanatory Provisions.

12.

(a) Nothing in this Order authorises any licensed premises to be kept open for the sale of intoxicating liquor except during the hours permitted under the general provisions of the Licensing Acts.

(b) The prohibition under this Order of the sale supply and consumption of intoxicating liquor except during certain hours is not subject to the exceptions provided for in the Licensing Acts with respect to *bonâ fide* travellers and the supply of

intoxicating liquor at railway stations or any other provisions in those Acts enabling intoxicating liquor to be supplied during closing hours in special cases.

(c) The expression "licensed premises" includes any premises or place where the sale of intoxicating liquor is carried on under a licence.

(d) This Order does not affect the sale or dispatch of intoxicating liquor to a trader for the purposes of his trade or to a registered club for the purposes of the club.

(e) This Order does not affect the sale or supply of intoxicating liquor to or in any canteen where the sale of intoxicating liquor is carried on under the authority of a Secretary of State or of the Admiralty.

Exhibition of Order.

13. The secretary of every club to which this Order applies and every holder of a licence for the sale of intoxicating liquor shall keep permanently affixed in some conspicuous place in the club or in each public room in the licensed premises a copy of this Order and any other notice required by the Board to be so affixed.

Commencement of Order.

14. This Order shall come into force on the twenty-fifth day of September, 1916.

DEFENCE OF THE REALM (LIQUOR CONTROL).

SUPPLEMENTAL ORDER OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE EAST MIDLANDS AREA WITH REFERENCE TO MEDICATED WINES AND NEW EXCISE LICENCES.

Any person contravening any provision of this Order or of the Liquor Control Regulations is liable to imprisonment for six months with hard labour and a fine of £100.

We the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm hereby make the following Order supplemental to the Order made on the 14th day of September, 1916, for the East Midlands Area.

Conditions as to the Sale of Medicated Wines.

1. On and after the second day of October, 1916, no person shall either by himself or by any servant or agent sell or supply to any person in any licensed premises for consumption off the premises or dispatch therefrom any intoxicating liquor in the form of or prepared as (a) medicated wine or (b) any mixture or preparation which contains any drug or medicament or is sold or advertised for sale as containing or purporting to contain medicinal properties except in a bottle or other vessel bearing a label correctly stating in clear and

legible words or figures the amount of proof spirit contained in such medicated wine or mixture or preparation. Provided always that nothing herein shall be deemed to affect the sale of—

(a) Any medicine mixture or preparation appearing in the British Pharmacopeia or the British Pharmaceutical Codex; or

(b) Any medicine mixture or preparation which is made up for a customer on the signed prescription of a medical practitioner; or

(c) Medicated or methylated spirits or spirits made up in medicine and sold by medical practitioners or chemists or druggists.

Provided also that in any case where such medicated wine or mixture or preparation is sold or supplied in a bottle or other vessel enclosed in a sealed packet and is so sold or supplied at any time before the 9th day of October, 1916, it shall be deemed a sufficient compliance with the terms of this Article if such sealed packet bears such label.

2. (a) The expression "licensed premises" in the foregoing Article includes any premises or place where the sale of intoxicating liquor for consumption off the premises is carried on under a licence.

(b) The foregoing Article does not affect the sale or dispatch of intoxicating liquor to a trader for the purposes of his trade.

Restrictions on the Sale of Intoxicating Liquor under new Excise Licences.

3. No person shall, except with the written authority of the Central Control Board (Liquor Traffic) and in accordance with the terms and conditions subject to which such authority may be granted, either by himself or by any servant or agent, sell or supply in any premises any intoxicating liquor under an excise licence granted in respect of such premises on or after the twenty-fifth day of September, 1916, unless an excise licence authorising such sale was in force in respect of such premises on the twenty-fourth day of September, 1916.

Provided always that nothing in this Article shall be deemed to affect the sale of intoxicating liquor under—

DEFENCE OF THE REALM (CONSOLIDATION) REGULATIONS, 1914.

SHIPS' LIGHTS.

In amplification of Their Order on the same subject dated the twenty-fourth day of June,

1916 (which is hereby cancelled), the Lords Commissioners of the Admiralty hereby make the following Order under the Defence of the Realm (Consolidation) Regulations, 1914, which shall come into force forthwith:—

1.—*Anchor Lights.*—No electrically-lit lanterns are to be employed as anchor lights. The normal brilliancy of all anchor lanterns is to be reduced by 50 per cent.

All anchor lanterns are to be fitted with overhead screens, so arranged as to cut off the light at an angle of between 20 and 25 degrees above the horizontal.

NOTE.—Specimen screens can be viewed at the Board of Trade Surveyor's Offices at Leith, North Shields, Hull, London, Plymouth, Cardiff, Liverpool, Glasgow and Dublin.

2.—*Bow and Masthead Steaming Lights.*—Vessels in estuaries, harbours, anchorages and channels, where navigation in the dark hours is permitted, are not to employ electrically-lit lanterns as bow or steaming lights, with the exception of those vessels specially mentioned in paragraph 5.

3.—*Other Lights.*—No light, either aloft, on deck or below, except those required by the Regulations for the Prevention of Collisions at Sea, and such as may be permitted to be visible from outboard. This applies to vessels whether under way or at anchor.

4.—The above order applies to vessels of every description, other than H.M. Ships and the vessels mentioned in the succeeding paragraph, in the waters of the United Kingdom except within three miles of the Irish Coast.

5. Vessels carrying volatile oil or spirits in bulk are, notwithstanding the above orders, to exhibit (in lieu of oil lamps) electrically-lit lanterns not exceeding in brilliancy 50 per cent. of the brilliancy of the normal oil lamps.

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS respecting Boy Clerks registered for temporary employment in Public Departments.

1. Two registers of Boy Clerks for temporary employment in Public Departments will be kept by the Civil Service Commissioners.

2. These Registers will contain the names of boys who, being either natural-born or

naturalized British subjects, are certified by the Civil Service Commissioners to be of good health and character, and duly qualified under the following Regulations (3 and 4). One register will contain the names of boys for service in London, Edinburgh, and provincial towns of England, Scotland, and Wales. The other will contain the names of boys for service in Dublin and provincial towns in Ireland.

3. The limits of age are 15 to 16. If an examination begins in one of the first three months of any year candidates must be of the prescribed age on the first of January in that year. If an examination begins in April or May of any year, candidates must be of the prescribed age on the first of April in that year. If an examination begins in June, July, or August of any year, candidates must be of the prescribed age on the first of June in that year. If an examination begins in one of the last four months of any year candidates must be of the prescribed age on the first of September in that year.

4. The subjects for examination are:—

1. Handwriting and Orthography.
2. Arithmetic, including vulgar and decimal fractions.
3. English Composition.
4. Copying Manuscript.

And any three of the following, except that not more than two languages may be taken:—

5. Geography.
6. English History.
7. Latin.
8. French.
9. German.
10. Mathematics.
11. Elementary Science.

No Candidate will be regarded as qualified who fails to obtain such an aggregate number of marks as may indicate in the judgment of the Civil Service Commissioners a competent amount of general proficiency.

5. Open Competitive Examinations for the purpose of testing the qualifications of Candidates in the above-mentioned subjects will be held by the Civil Service Commissioners from time to time as may be necessary, and a certain number, regulated by the probable demand from the Public Departments, of those who show sufficient proficiency will be placed upon the Registers kept by the Commissioners, and will be available for employment as their services are required. The competitions for the Irish service will, as a rule, be held at the same time as the competitions for service in Great Britain, and the list of successful candidates for Ireland will be separate from that of the successful candidates for service in Great Britain. Candidates can enter for both competitions, when they are held simultaneously, paying only one fee. If successful in both, they will be entered on the Register for Great Britain only, or on that for Ireland only, or on both Registers according to their choice.

6. The fee payable for attending an examination will be 5s.

7. Boy Clerks placed on these Registers will be summoned for employment in any of the Public Departments as they are wanted. When not wanted, they will have no claim to employment. Refusing to serve when called upon, except for reasons satisfactory to the Civil Service Commissioners, they will be removed from the Registers. The order in which they

may be employed, the Departments to which they may be assigned, and their retention generally on the Registers, will be determined by the Civil Service Commissioners; but they will be subject to the orders of the Departments in which they are serving during the time of their actual employment, and will be liable to dismissal from them by the authorities thereof, without notice, for inefficiency or misconduct.

Boy Clerks resigning, or procuring their own discharges from Departments, except for sufficient reasons proved to the satisfaction of the Civil Service Commissioners, will be removed from the Registers.

Their assignment for service will, as a general rule, be according to their order of merit in the examination; but exceptions to this general rule may be made when the engagement offered is very short, or for other sufficient reasons.

8. Boy Clerks will usually be engaged and paid by the week of 39 hours, viz.:—7 hours a day on Mondays, Tuesdays, Wednesdays, Thursdays, and Fridays, and 4 hours on Saturdays; and they will be paid 15s. per week during the first year of their service. After a year of approved service, an increase of pay to 16s. a week may be allowed.

In any case of absence without pay a Boy Clerk's increment shall be postponed one day for every day of such absence—absence without pay equally with the interval between two successive engagements not being reckoned as service for any purpose contemplated by the Regulations.

Boy Clerks may also be engaged and paid by the hour at the rate of 4½d. per hour during their first year of service; and at the rate of 5d. per hour thereafter. Any who may be engaged by the week and who may be required to attend for more than 7½ hours on Monday, Tuesday, Wednesday, Thursday, or Friday, or more than 4½ hours on Saturday, will be paid at the hourly rate for the overtime attendance in excess of the normal attendance for such day. But in no case must overtime attendance exceed 6 hours in any one week. They may also be paid by the piece at such rates as may be fixed by the Civil Service Commissioners, with the approval of the Lords Commissioners of the Treasury.

9. No service in the capacity of Boy Clerk will confer any claim to superannuation or compensation allowance; and Boy Clerks will not be retained, as such, after they shall have reached the age of 18; subject to the following provisos: (1) Boy Clerks who have had no opportunity of entering a Competition for Assistant Clerkships after reaching the age of 17½, may be retained until the next Competition takes place and, provided they enter the Competition, until the announcement of the result and for not more than one month afterwards. (2) Boy Clerks who reach the age of 18 after entering a Competition for Assistant Clerkships may be retained until the announcement of the result and for not more than one month afterwards. (3) A Boy Clerk who has been declared successful in a Competition for Assistant Clerkships may be retained as a Boy Clerk until he is assigned to a vacant post as Assistant Clerk, unless he be rejected by the Civil Service Commissioners as not duly qualified in respect of age, health, or character for the permanent situation.

10. If a public holiday, on which the office is closed, fall within the period of a Boy Clerk's engagement, he may be paid in respect of it as for a working day. Boy Clerks may, with the consent of the Department in which they are serving, or if not at the time serving, with the consent of the Civil Service Commissioners, be allowed holidays, with full pay in the proportion of 12 days a year. No Boy Clerk shall be allowed to take more than 12 days' leave under these conditions between the 1st day of January and the 31st day of December.

Holiday pay can only be allowed for holidays actually taken, not for days on which the Boy Clerk is drawing pay in respect of employment in any capacity in the Public Service.

11. Boy Clerks who may fall ill while serving in any Department, and whose illness may be attested by medical Certificate to the satisfaction of the authorities of such Department, may be allowed sick-leave at the full rate of pay for the official day, provided that no Boy Clerk shall be paid for sick-leave for more than 36 days within any one year, exclusive of public holidays.

12. Except in conformity with Regulations 10, 11, 14, and 15, Boy Clerks will only receive pay for the hours, or parts of hours, during which they actually attend.

13. Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer, are not eligible for employment as Boy Clerks until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

14. If any case of infectious disease should occur in the house where a Boy Clerk is living, he must immediately report the fact to the Officer under whom he is employed, and must, if required, at once discontinue his attendance. In cases of such enforced absence from his employment, it is in the discretion of the Head of the Department in which he has been serving to allow the Boy Clerk full pay at the usual rate for the period for which it is medically certified that his attendance at the office would be likely to be dangerous to his colleagues.

15. In any year in which the open Competition for situations as Assistant Clerk (Abstractor Class) in the Civil Service, for situations as Officer of Customs and Excise, for situations as Established Clerk to Surveyors of Taxes, or for Clerkships of the Second Division is held, a Boy Clerk who obtains from the Head of the Department in which he is serving leave of absence to attend such Examination may also, at the discretion of the Head of the Department, be allowed pay, at the usual rate, for the days during which he is attending the Examination.

16. Service Marks for each full period of three calendar months of actual approved service in the capacity of Boy Clerk, subject to a maximum of eight such periods, will be allowed to Candidates attending Examinations for the situations of

Clerk in the Second Division of the Civil Service,

Officer of Customs and Excise, who are serving or have served as Boy Clerks provided they shall have rendered not less than six months' approved service in that capacity; but the number of marks to be allowed for each period may be different at successive examinations.

17. In the promotions of permanent Civil Servants [Assistant Clerks (Abstractor Class) and others] under Clause 45 of the Order in Council of 10th January, 1910, not less than one year's and not more than two years' approved service as Boy Clerk may be allowed to reckon towards the six years' established service required by the said clause.

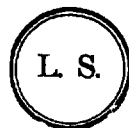
