#### DEFENCE OF THE REALM (CONSOLIDATION) REGULATIONS, 1914.

##### SHIPS LIGHTS.

Whereas by our Order made under the Defence of the Realm (Consolidation) Regulations, 1914, and dated 8th September, 1916, certain regulations were made with regard to lights carried by vessels in the waters of the United Kingdom except within three miles of the Irish Coast:

And whereas we consider it necessary that the said regulations shall apply to the whole of the waters of the United Kingdom:

We hereby cancel the words "except within three miles of the Irish Coast" which occur in the fourth paragraph of the above mentioned Order, and direct that the Order shall continue in force as if these words were not included.
