DEFENCE OF THE REALM (CONSOLIDATION) REGULATIONS, 1914-1916.

REGULATION OF THE SALE OF HAY AND OAT AND WHEAT STRAW IN GREAT BRITAIN AND IRELAND AND THE ISLE OF MAN.

In pursuance of the powers conferred on them by the Defence of the Realm (Consolidation) Regulations, 1914-1916, the Army Council do hereby Order:—

That on any sale of Hay, Oat Straw, or Wheat Straw in Great Britain, Ireland or the Isle of Man, the price shall not exceed such prices as are set out in the Schedules hereunder:—
