The Minister of Munitions gives notice (1) that in exercise of the powers conferred upon him by the Defence of the Realm (Consolidation) Act, 1914, the Defence of the Realm (Amendment) No. 2 Act, 1915, the Defence of the Realm (Consolidation) Regulations, 1914, and all other powers thereunto enabling him, he hereby prohibits as from the date of this Order the use of copper, whether wrought or unwrought, in any kind of manufacture except for the purposes of a contract or order for the time being in existence certified to be within Classes "A" or "B" of circular L.33 as to control of output issued by the Minister of Munitions on the 31st day of March, 1916.

(2) That the Order of the Minister of Munitions of the 6th November, 1916, relating to the manufacture of copper wire and cable containing copper is hereby cancelled.
