The KING was pleased, on Saturday, the 30th ultimo, at Buckingham Palace, to present to Second Lieutenant Walter Howden Lyell, 3rd Battalion, Gordon Highlanders, the Albert Medal of the Second Class which had been conferred upon him by His Majesty for gallantry in saving life, as detailed below:—

On the 4th May, 1916, Lieutenant Lyell was in command of a party under instruction in throwing hand grenades. One of the men threw a grenade on to the parapet directly in front of the party, thus placing them in great danger. Lieutenant Lyell at once ran up and just succeeded in throwing the grenade over the parapet before it exploded.

His prompt and courageous action in all probability saved the party from severe casualties.
