Defence of the Realm (Consolidation) Regulations, 1914, and all other powers thereunto enabling him, as from the date of this Order he hereby prohibits, until further notice, any person, firm or company from carrying out, without a permit issued under the authority of the Admiralty, the Army Council or the Minister of Munitions, any work consisting in or connected with the manufacture, assembling or erection of any new or unused motor internal combustion engine, designed or adapted for mechanical traction, or of any new or unused motor cycle, motor chassis, motor wagon, or of any tractor or other motor vehicles of any kind propelled by mechanical means, subject, however, to the following exception:-

Work required to complete contracts placed by the Admiralty, the War Office, the Minister of Munitions or an Allied Government on or before the 3rd day of November,

For the purpose of this Order the expression "assembling" shall be deemed to include the placing or replacing in position of any part

The Order dated November 3rd, 1916, published in the London Gazette of November 10th, 1916, is hereby cancelled, without prejudice to anything done thereunder.
