At the Council Chamber, *Whitehall*, the 22nd day of *June*, 1917.

By the Lords of His Majesty's Most Honourable Privy Council.

**W**HEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said

Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3, any dealings other than such as are expressly authorised by Paragraph 5 of the Proclamation. A List (The Consolidating List No. 29a), consolidating all previous Lists, revised to date and including the amendments in the Schedule annexed hereto is issued concurrently with this Order. This Consolidation List contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

†NOTE (2).—Where a person or firm mentioned in the List has more than one address in the country or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

NOTE (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25 June and 10 November, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or

firm is not mentioned by name in the Statutory List.

NOTE (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The Lists for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th day of May, 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the

exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

His Majesty the KING has been graciously pleased to award the Edward Medal of the 2nd Class to Charles Slack, deputy overman at the Woodland Colliery, Durham, under the following circumstances:—

On 2nd November, 1916, a fall of roof occurred, completely burying a hewer named Richardson. Slack immediately sent for help, and himself started to remove the stone from Richardson, although the roof was still obviously very dangerous. Almost immediately a further fall occurred, burying Slack except for his legs. He was pulled out by two hewers, and, after recovering himself, returned to Richardson's assistance. He worked for about ten minutes, and then told the other helpers to get clear, as another fall was about to occur. He attempted to prop the falling stone up with his back, and by so doing succeeded in canting it off Richardson's head, which was now exposed, but he himself was again buried. Both men were finally extricated after about one and a half hours' work.

Slack undoubtedly risked his life in saving Richardson.

Also the Edward Medal of the 2nd Class to Robert John Kirkham, Fourth Class Examiner in the Department of Munitions Inspection.

On the 6th February, 1917, Kirkham, who was working in a filling shed at Watford, noticed smoke issuing from a filled 4-inch Stokes bomb. With most commendable presence of mind and courage he picked up the bomb, threw it out of the shed and shut the door. The bomb exploded in the open with sufficient violence to project the steel head, weighing 20 ounces, a distance of 120 yards. The steel propellant container flew 50 yards in the opposite direction. But for Kirkham's action the explosion would have occurred inside the filling shed, in which about 50 persons were working and a quantity of explosive was stored, and it is probable that loss of life would have resulted. Kirkham was well aware of the nature of the bomb and of the destructive qualities of the explosives with which it was filled.

Also the Edward Medal of the 2nd Class to Thomas Luther Burt, Chief of Police in H.M. Factory at Watford.

On the 13th February last an outbreak of fire occurred at the Watford Factory, at which explosives are manufactured. Burt, who was on his round of inspection at the time, at once rushed into the building, which was burning fiercely and full of suffocating smoke. He carried out Mixer Price, and immediately returned to rescue Mixer Morecroft, the smoke being then so dense and the heat so great that he was compelled to crawl along on his hands

and knees before he could reach Morecroft. Afterwards he worked hard in assisting in the removal of explosives from the burning buildings.

Also the Edward Medal of the First Class to the representatives of Dr. Andrea Angel and Mr. George Wenborne, who lost their lives in endeavouring to save the lives of others on the occasion of a fire which broke out at the Silver-town Chemical Works on the 19th of January, 1917, and His Majesty has been graciously pleased to award the King's Police Medal to the representative of Police Constable Edward George Brown Greenoff, who lost his life on the same occasion.

Also the Edward Medal of the 2nd Class to Percy Roberts Havercroft, Albert Henry Tomlinson, John Walker, and Edward Wingfield.

On the 27th August, 1915, a descending cage containing ten men, collided about half-way down one of the shafts of the Waleswood Colliery, near Sheffield, with an empty ascending cage. The impact was extremely violent, severely injuring all the men and breaking the winding ropes. Both cages were, however, wedged together in the shaft, so that, fortunately, neither of them fell to the bottom, though there was serious danger that they might do so at any moment. A hoppit manned by Tomlinson, Havercroft and Walker was at once sent down to effect the rescue of the imprisoned men. All the men were carried from the damaged car along a girder to the hoppit, which made five descents altogether, the rescue occupying about two hours. During the whole of this time Tomlinson, Havercroft, and Walker were exposed to great danger either from the hoppit being upset by the winding ropes swinging in the shaft, or from the damaged cage breaking loose and falling down the shaft.

Wingfield, who was one of the occupants of the descending cage, had both legs fractured, and received a severe wound on the thigh and a wound on the head. He seized hold of another man who had fallen half-way through the bottom of the cage, and held him up until he was rescued. During the whole time he displayed the greatest coolness and bravery, despite his very severe injuries, and insisted on all his fellow-workmen being removed to a place of safety before allowing himself to be taken to the surface.

Also the Edward Medal of the First Class to Alfred John Henney.

On March the 14th, 1917, a bucket containing detonators was discovered to be on fire at the factory at which Henney was employed. He ran to the building, which was full of smoke, crawled through the smoke on his hands and knees until he found the burning bucket. The rope handle was in flames; but he seized it by the rim and carried it outside, where he extinguished the contents. His promptitude and courage averted a most serious disaster.

Also an Edward Medal of the 2nd Class to Herbert John Gollidge.

On the 25th February, 1917, George Weeks, Under Manager of the Braysdown Colliery, near Bath, was ascending the shaft when the cage struck a water pipe which had become unfastened and was projecting from the shaft. The pipe pierced the roof of the cage and severely injured Weeks, at the same time preventing the cage from ascending. Gollidge

was working at a level about halfway down the shaft, which is 608 yards in depth, and about eighty yards above the point at which the accident occurred. Hearing Weeks's moans, he at once got into the shaft and climbed down to the cage by means of the buntons, or girders, which run horizontally round the shaft. Golledge lowered himself from one buntun to the next, the distance between the buntons being on an average 5 feet, or in some cases 6 feet.

On reaching the cage, Golledge rendered first aid to Weeks, and remained with him until the cage could be liberated and brought to the surface, a period of about two hours.

 quired by or on behalf of the Director of  
 Army Contracts.

3. All persons to whom any permit may  
 be issued by or on behalf of the Director of  
 Army Contracts are required to comply  
 strictly with any conditions that may be  
 imposed by the said permit. It shall be the  
 duty of all Tanners to communicate to any  
 person buying on their behalf the conditions  
 of any licence granted to such Tanner and  
 for the time being in force, and it shall be  
 the duty of all parties to any of the transac-  
 tions herein referred to to require or disclose  
 as the case may be all such information as  
 may be required by such parties as aforesaid  
 or by the Director of Army Contracts for the  
 purpose of satisfying them or him that the  
 provisions of this Order have not been contra-  
 vened.

 tion made or given hereunder or with any con-

### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 19TH JUNE 1917.)

#### RADNOR (CONTROL OF DOGS) ORDER OF 1917.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, the Dogs Act, 1906, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

##### *Power to make Regulations.*

1.—(1.) The Local Authority of the District specified in the Schedule to this Order may, in accordance with the provisions of this Order, make Regulations, with a view to the preven-

tion of worrying of cattle (including sheep), for requiring that dogs or any class of dogs shall, during all or any of the hours between sunset and sunrise be kept by the owners thereof under control in manner prescribed by the Regulations.

(2.) The Regulations may apply to the whole or any part of the District, and may exempt any class of dogs either generally or under prescribed conditions.

##### *Confirmation of Regulations.*

2.—(1.) Regulations made under this Order shall not take effect unless and until they have been submitted to and confirmed by the Board of Agriculture and Fisheries.

(2.) Unless the Board otherwise direct, the following provisions shall apply:—

(i.) Notice of intention to apply for confirmation of any Regulations shall be given in one or more of the local newspapers circulating within the District in two successive issues two weeks at least before the making of the application.

(ii.) For two weeks at least before an application, a copy of the Regulations proposed to be confirmed shall be kept at the office of the Local Authority of the District, and be open during office hours thereat to the inspection of ratepayers of the District without fee or reward.

(iii.) The Clerk of the Local Authority shall on the application of any such ratepayer furnish him with a copy of the proposed Regulations on payment of sixpence.

(3.) A copy of any Regulations made by a Local Authority under this Order, signed and certified by the Clerk of the Local Authority to be a true copy and to have been duly confirmed, shall be evidence, until the contrary is proved, in all legal proceedings, of the due making, confirmation, and existence of the Regulations without further or other proof.

##### *Seizure of Dogs where Regulations are Contravened.*

3. Any dog in respect of which an offence is being committed against a Regulation made under this Order may be seized and treated as a stray dog under the powers conferred by section three of the Dogs Act, 1906.

##### *Extension of Definition in Diseases of Animals Act, 1894.*

4. Dogs shall be animals for the purposes of the following sections of the Diseases of Animals Act, 1894 (namely):—

Section forty-three (*police*);  
Section forty-four (*General administrative provisions*);

and also for the purposes of all other sections of the said Act containing provisions relative to or consequent on the provisions of those sections and this Order, including such sections as relate to offences and legal proceedings.

##### *Local Authority to enforce Order.*

5. The provisions of this Order shall be executed and enforced by the Local Authority.

6. This Order may be cited as the RADNOR (CONTROL OF DOGS) ORDER OF 1917.

*Application of Sheep (Double Dipping) Order of 1914.*

1. The provisions of the Sheep (Double Dipping) Order of 1914 (hereinafter referred to as "the principal Order") are hereby applied to the Area described in the Schedule hereto, subject to the modifications contained in this Order.

*Period Prescribed as Double Dipping Period.*

2. The dates between which all sheep in the Area described in the Schedule hereto are to be dipped within the Area by the owner or person in charge of the sheep under and in accordance with Part II of the principal Order, are hereby fixed to be the thirty-first day of August and the fourteenth day of October in each year.

*Modification of Part II of the Principal Order.*

3. Part II of the principal Order shall, in its application to the Area described in the Schedule hereto, be read and have effect as if paragraphs (2) and (3) of Article 5 and Article 6 were omitted, and as if the following paragraph were inserted in Article 5:—

"(2) The dippings shall be carried out on such dates, at such dipping places, and in such manner as shall be required by a Notice signed by an Inspector of the Board or of the Local Authority, and served by post or otherwise on the owner or person in charge of the sheep referred to in the Notice."

*Commencement.*

4. This Order shall come into operation on the twenty-ninth day of June, nineteen hundred and seventeen.

## ADMIRALTY NOTICE TO MARINERS.

No. 608 of the year 1917.

## SCOTLAND NORTH-EAST COAST, ORKNEY AND SHETLAND ISLES.

*Former Notices.*—Nos. 243, 365, 448 and 551 of 1917; hereby cancelled.

Notice is hereby given that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force:—

(1) *Pentland and Moray Firths—Restriction of Traffic; Pilotage Regulations.*

The following regulations have been made with a view to safeguarding the interests of shipping in the Pentland and Moray Firths:—

## I.—RESTRICTION OF TRAFFIC.

1. No vessel, either British, Allied or Neutral, is to be in the shaded area on the accompanying portion of Admiralty Chart No. 2, from half an hour after sunset to half an hour before sunrise, unless at anchor. No vessel, however, is to anchor:—

(a) Anywhere along the coast between Tarbet ness and North Sutor, except within one mile radius of Balintore;

(b) Anywhere off the south shore of the Moray firth between the meridians of Port Gordon and Burghead, except within three-quarters of a mile of the low water mark;

(c) Outside a distance of one mile of the coast in any other portion of the shaded area indicated on the accompanying portion of Admiralty Chart No. 2.

2. Vessels proceeding to ports in the Moray Firth should therefore endeavour to enter the firth in time to reach their destinations not later than half an hour after sunst. Should they not reach their destinations by that time they are to anchor, weather permitting, subject to the restrictions given in clause 1.

3. Any vessel contravening the foregoing regulations will run the gravest risk of being sunk.

*Caution.*—Neutral or Allied vessels are particularly warned that the passage through the Pentland Firth presents very grave risks to a Westbound vessel and are strongly advised not to take it.

## II.—PILOTAGE REGULATIONS.

Pilotage is compulsory at the undermentioned ports for all vessels (including fishing vessels) which have a draught of over eight feet, and it is highly dangerous for any vessel to enter or leave such ports without a pilot. Fishing and other small vessels having a draught of over eight feet are to assemble at the Pilotage stations, and will be conducted into and out of port in groups.

1. Vessels bound for Cromarty and Inverness will be led through the Defences from a position off Tarbet ness by a pilot boat. They should follow directly astern of her.

Local arrangements for leading vessels through the Defences will be made for vessels leaving Cromarty or Inverness.

2. It is dangerous for any vessel to be under way to the south-westward of a line joining Tarbet ness and Findhorn without a pilot.

3. No vessels of any description other than H.M. Ships and Auxiliaries are to be under way between sunset and sunrise in the waters con-

tained between a line drawn from Tarbet Ness to Findhorn, and a line drawn from Fort George to Chanonry point.

(2) *Orkney Isles—Traffic Regulations.*

I.—SCAPA FLOW AND APPROACHES.

1. All entrances are dangerous and entry is absolutely prohibited by any of them except as provided in succeeding paragraphs.

2. Examination services have been established in the entrances to Hoxa and Hoy sounds; vessels directed to enter must communi-

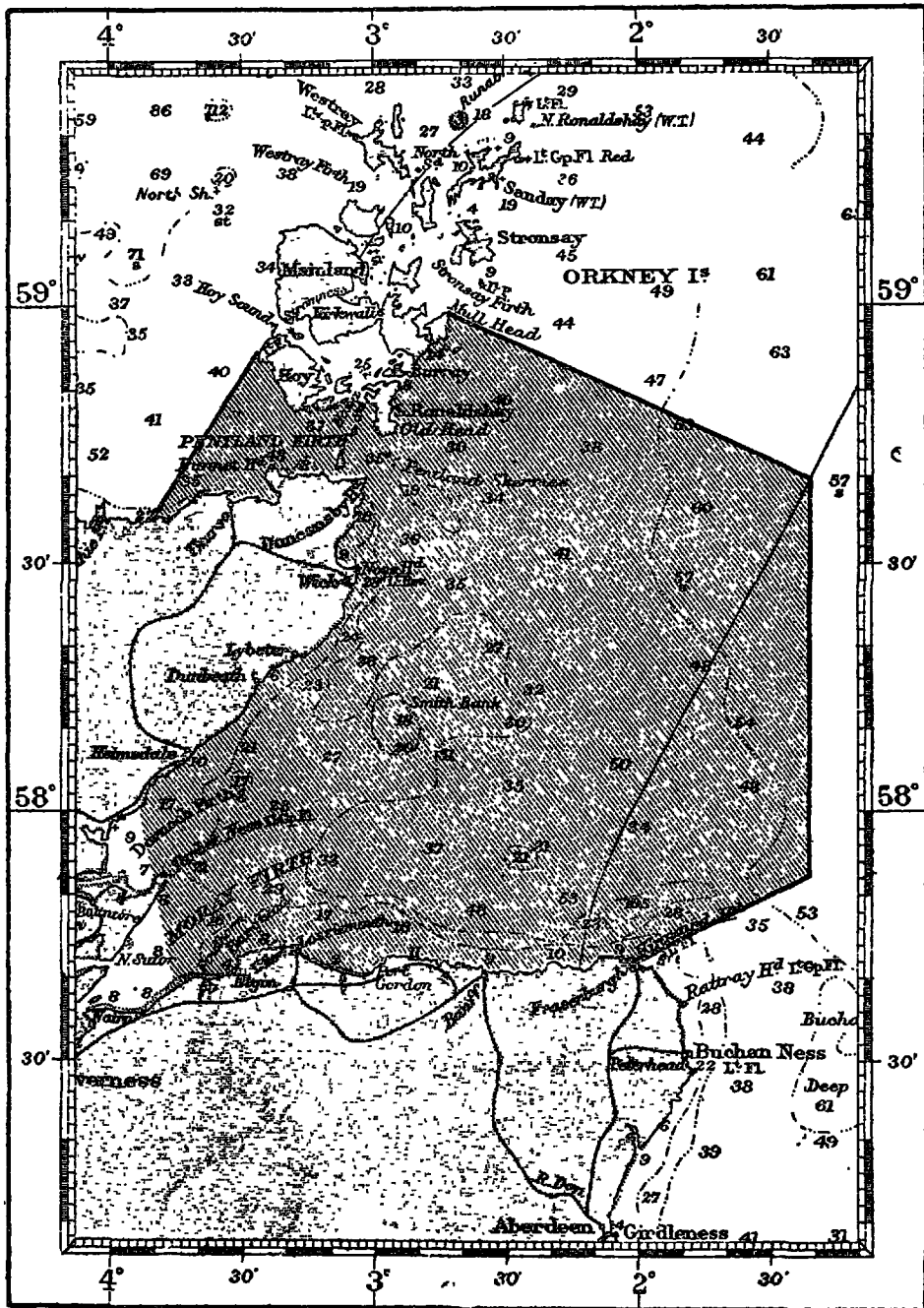
6. Passage through Cantick sound is entirely prohibited.

II.—PORT OF KIRKWALL AND APPROACHES.

1. The Port of Kirkwall shall comprise all enclosed waters of the Wide Firth and Kirkwall bay to westward of Thieves holm.

2. Merchant vessels shall obey all orders given them by the Admiralty Port Officer as regards anchoring or shifting position.

3. No vessel (other than H.M. Ships) shall enter or leave the Port of Kirkwall during



cate with the Examination vessel and follow the instructions received from her very carefully.

3. No vessel is permitted to approach the entrance to Hoxa sound within a radius of 5 miles under any circumstances whatever, except when actually ordered to Scapa Flow.

4. The only vessels permitted to enter Hoy sound from the westward are those ordered to Stromness.

5. Vessels are not permitted to enter Hoxa or Hoy sounds by night or in thick weather.

hours of darkness, *i.e.*, between half an hour after sunset and half an hour before sunrise, except in special circumstances with special permission from the Admiralty Port Officer.

4. During foggy and thick weather, traffic in and out of the port is stopped, and no vessel shall approach the boom from either direction.

5. No vessel (other than H.M. Ships) or boat shall move in the harbour during hours of darkness as aforesaid. And no boat (other than those belonging to H.M. Ships) shall

approach the shore or go alongside any pier in the Port of Kirkwall.

6. All vessels (other than H.M. Ships) entering or leaving the Port of Kirkwall shall be piloted in and out by a Pilot drifter, and are prohibited from entering or leaving harbour unless so piloted, save and except only (1) in the case of such British vessels as have a written exemption therefrom, issued by the Admiralty Port Officer, (2) when a liner is entering the harbour, the Pilot may at his discretion, when circumstances of tide and sea render it advisable, direct such liner to enter the harbour without being piloted, provided always that the gate is open for incoming traffic.

7. Vessels, when cleared, shall wait for the Pilot vessel to conduct them out of port.

8. Drifters engaged on pilot duty will fly the pilot flag (white and red, horizontal).

9. Incoming and outgoing traffic will be regulated by signals hoisted at the yardarm of the Boom trawler, and repeated at Hellier holm lighthouse.

10. Traffic signals are to be strictly obeyed, and no vessel shall approach the entrance against the signal.

11. The following Traffic signals will be displayed at the Boom and at Hellier holm:—

Gate "Open for Incoming Traffic":

By day—two balls, vertical.

By night—a red light.

Gate "Open for Outgoing Traffic":

By day—a cone, point upwards.

By night—a green light.

Gate Closed:

By day—Three balls at Hellier holm.

By night—Three red lights at Hellier holm.

12. Vessels entering will, as a rule, be given priority over those leaving.

13. All outgoing vessels shall pass round the Turning buoy (red and white striped, spherical) moored approximately 285° (N. 66° W. Mag.), one mile from the entrance.

14. Incoming vessels will not pass round the Turning buoy, but will shape course as requisite for the anchorage on entering.

15. No outgoing vessel shall pass the Turning buoy, unless the signal for outgoing traffic is up. If the signal is against it, such vessel shall stop and wait in the neighbourhood of the Turning buoy.

16. No incoming vessel shall pass Hellier holm, unless the signal for incoming traffic is up at Hellier holm. If the signal is against it, such vessel shall wait in Shapinsay sound.

17. Incoming and outgoing vessels shall not pass through the gate simultaneously. If, through any misunderstanding, an outgoing and an incoming ship are approaching the gate simultaneously, then the outgoing ship shall give way, and shall turn round, and return to the Turning buoy, and there wait till such time as the entrance is clear.

18. As a rule only one ship will be conducted out at a time, but under exceptional circumstances, in the event of two ships being conducted out, then the pilot will give instructions as to which ship is to go first and the rear ship shall then keep a full half mile directly astern, and is on no account to close or overhaul or attempt to pass the ship ahead.

19. *Caution.*—Caution is necessary when approaching the boom, as the tidal stream does

not set fairly through the opening and attains considerable velocity especially on the ebb or west-going stream, which sets in a north-westerly direction.

*Variation.*—19° W.

(3) *Shetland Isles—Traffic of Neutral Vessels Prohibited.*

No vessels other than those of British Nationality or those of the Allied Nations, except vessels calling for the purpose of Examination, shall enter any ports or harbours in, or anchor off any part of, the coasts of the Shetland Isles until further notice.

*Note.*—This Notice is a revision of the former Notices quoted above.

*Caution.*

This Admiralty Notice to Mariners is issued under the provisions of the Defence of the Realm Regulations, and failure to comply strictly with the directions contained in it will constitute an offence against those Regulations.

Any person found guilty of such an offence is liable to severe penalties both of imprisonment and fine.

Any person aiding or abetting the commission of such an offence is himself guilty of an offence against the Regulations.

Attention is also drawn to the fact that any infringement of the directions contained in this Admiralty Notice to Mariners is liable to result in the detention of the ship or vessel.
