PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Order in Council, dated the twenty-eighth day of November, nineteen hundred and fourteen, His Majesty was pleased to make regulations (called the "Defence of the Realm Regulations") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm:

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915. the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915, and other enactments:

And whereas the said regulations have been amended by various subsequent Orders in Council:

And whereas it is expedient further to amend the said regulations in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by

and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said regulations:—

- 1. In sub-section (1) of Regulation 2F, for the words "including orders as to maximum and minimum price" there shall be substituted the words "including orders providing for the fixing of maximum and minimum prices."
- 2. At the end of Regulation 2c the following sub-section shall be inserted:—
 - "(5) If in any case the Food Controller is of opinion that it is necessary or expedient to obtain information from any person in connection with any article as to all or any of the matters with respect to which returns may be required under sub-section (1) of this regulation, the Food Controller shall have power, without making an order for the purpose, to require that person to furnish him with that information; and any person who is so required to furnish information shall furnish it accordingly.

"In such a case, all the foregoing provisions of this regulation shall apply to information so given and the giving of such in-

formation as they apply to returns made and the making of returns."

3. Regulation 211 shall be amended as

(1) For the words "to which the powers of the Food Controller under those regulations do not extend" there shall be substituted the words "not being an article of food."

(2) For the words "encouraging or maintaining "there shall be substituted the words "en-

couraging, maintaining or regulating."

4. In Regulation 29c for the words "State at war with His Majesty" there shall be substituted the words "State now at war with His

After Regulation 35B the following Regu-

lation shall be inserted:

"35BB. It shall be lawful for the Admiralty or Army Council to give such directions as they may think proper, either generally or on a particular occasion, as to the burial of the bodies of enemies killed in the course of hostile operations and no inquest shall be held on any body to which directions so given relate.'

6. For Regulation 41AA the following Regu-

lation shall be substituted :-

"41AA. (1) Where a workman who holds, in consequence of his occupation, a certificate issued by a Munitions Recruiting Officer, to the effect that he is not for the time being to be called up for military service, ceases to be employed by a person in Great Britain that person shall, within forty-eight hours after such workman ceases to be employed by him, deliver at or send by registered post to the Munitions Area Recruiting Office from which the workman's certificate was issued or such other address as may be prescribed, a notice signed by him or on his behalf stating the workman's full names, his last known address, the number of his certificate and the date when he ceased to be so employed.

"(2) Where any person in Great Britain takes any such workman as aforesaid into his employment he shall within forty-eight hours thereafter deliver at or send by registered post to the Munitions Area Recruiting Office for the area in which the workman is so taken into employment or such other address as may be prescribed, a notice signed by him or on his behalf stating the workman's full names, his present address, the number of his certificate, the name of the Munitions Area Recruiting Office from which that certificate was issued and the date when the employment

commenced.

"(3) Where whilst any such workman as aforesaid remains in the employment of any person in Great Britain his place of employment is changed from one munitions area to another the person by whom he is employed shall within forty-eight hours after the change deliver at or send by registered post

(a) the Munitions Area Recruiting Office from which the workman's certificate was issued or such other address as

may be prescribed; and

(b) the Munitions Area Recruiting Office for the area to which the workman's place of employment is changed or such other address as may be prescribed; a notice signed by him or on his behalf stat. ing the workman's full names, his present !

address, the number of his certificate, the office from which that certificate was issued and the date of the change of place of employment.

(4) It shall be the duty of every such workman as aforesaid when required, to furnish to his present or last employer such information as may be necessary to enable such employer to comply with the requirements of

this regulation.

"(5) The Army Council may by general or special order exempt any person or class of persons from all or any of the obligations imposed by this regulation and prescribe the addresses to which notices under this regulation are to be delivered or sent.

"(6) If any person fails to comply with any of the requirements of this regulation or gives in or for the purposes of any such notice as aforesaid any false or misleading information he shall be guilty of a summary offence against these regulations."

7. In Regulation 48 after the words "Any person who attempts to commit " there shall be inserted the words "or solicits or incites or endeavours to persuade another person to commit."

"We beg leave humbly to recommend that Your Majesty may be graciously pleased to sanction the establishment of the Rank of Chief Naval Instructor under the conditions set forth in the annexed Schedule.

"The Commissioners Lords Majesty's Treasury have signified their con-

currence in this proposal.

"SCHEDULE.

" Relative Rank.

"Chief Naval Instructors to rank with Captains of 3 years' seniority.

"Pay.

"Pay to be £1 15s. 0d. a day inclusive of all allowances.

" Half Pay.

"Half Pay to be at the rate of 17s. 6d. a day.

" Ret.red Tay.

"Retired Pay to be on the existing scale for Naval Instructors, with an addition of £10 a year for each year's service as Chief Naval Instructor, subject to a maximum of £500 a year.

"Widows' l'ensions, etc.

"Disability, Injury, and Wounds, Pensions and Gratuities, Widows' Pensions and Compassionate Allowances for Children, to be on the scale applicable to Paymasters-in-Chief.

" Retirement:

"Retirement to be compulsory at the age of 60. Optional retirement to be allowed at the discretion of the Admiralty at the age of $5\bar{o}$.

" Number.

"The number of Chief Naval Instructors shall not exceed 4, and vacancies occurring after the first 4 appointments have been made will not be filled without the further concurrence of the Lords Commissioners of the Treasury."

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the pay of Boys First Class, Signal Boys, Boy Telegraphists, and Ship's Steward's Boys, being increased, for the duration of the present war, from 7d. per diem to 9d. per diem, as from the 1st May, 1917.

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas by His late Majesty's Orders in Council bearing dates the 9th day of April, 1908, and the 15th day of February, 1909, Climate Allowance at the following rates was granted to Officers and Men employed in the China Rivers and Persian Gulf, viz.:—

3s. a day to Commissioned Officers.

1s. a day to Warrant Officers.

6d. a day to the rest of Ship's Company.

Payable during the hot season of the year:

"And whereas we are of opinion that the Officers and men serving in Ships employed in the tropical region on the West Coast of Africa, or in craft up the West African Rivers, or at places on the West Coast. should be granted similar allowances in consideration of the climatic conditions under which they are serving:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the payment of Climate Allowance at the above rates to such Officers and Men accordingly during the period 1st April to 30th September of each year, with effect as from the 1st day of April, 1917; payment to be restricted in all cases to those serving within 15 degrees north and 15 degrees south of the Equator; and in the case of those serving off the coast only to be made when within 50 miles thereof.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

"And whereas we consider it desirable that a Family Allowance should be paid during the period of the present War to Chief Officers of Your Majesty's Coast Guard, who rank with Warrant Officer, R.N., and to Ratings of Your Majesty's Coast Guard below the rank of Chief Officer, in respect of their children under the age of 14, or, in the event of such Officers or Ratings being detached from their proper Stations for duty elsewhere, to their families:

"And whereas we are of opinion that provision should be made for the Widow and Child or Children, if any, of each such Officer and Man for a period of 26 weeks from the date on which notification of his death is sent, on the same scale as is provided for the benefit of Widows and Children of Seamen and Marines under Paragraph 5 of Your Majesty's Order in Council bearing date the 10th day of January last:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction payment of such Allowances at rates not exceeding those set forth in the Schedule annexed, to take effect

from the 28th day of June, 1917.

'' The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.

"SCHEDULE,

"(1) A Family Allowance may be paid to Chief Officers of Coast Guard, ranking with Warrant Officer, R.N., and to Ratings below the rank of Chief Officer during residence at their proper Stations at the following rates:-

per week.

if there be one Child under 14 3s. 6d. years of age

if there be two Children under 14 years of age ... 7s. 0d. for each additional Child under

14 years of age an additional 2s. 0d.

"(2) This Allowance may be increased by 3s. a week, and paid to some Member of the Household for each complete period of 7 days or more during which the Officer or Man was detached on duty from his proper Station, provided that he be not in receipt of Subsistence Allowance, and that he declare an allotment of not less than 20s. a week in the case of an Officer, and not less than 5s. a week in the case of a Rating, for payment concurrently with the Allowance.

"(3) In the event of the death of any such Officer or Man, Family Allowance will cease to be payable as from the Thursday following the date of death, and there may be granted to the Widow and Children, if more beneficial to them than the pension for which they would otherwise be eligible under the Regulations issued by the Minister of Pensions, Separation Allowances at the rates provided in Orders in Council dated the 10th January, 1917, and the 13th March, 1917. Such Separation Allowance will be paid concurrently with the allotments in force at the dates of death of the Officers and Men concerned, or, if there be no allotment in force at the date of death, concurrently with such assumed allotment as may, having regard to the circumstances of the case, appear to the Admiralty to be reasonable."

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 18th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 12th day of July, in the year 1917, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint Thomas, Stamford Hill, and of the New Parish of Saint Andrew, Stoke Newington, both in the County of Middlesex, and in the Diocese of London:

London:

"Whereas by the authority of an Order of His late Majesty King George the Fourth in Council, bearing date the 27th day of February, in the year 1828, and published in the London Gazette on the 4th day of July in the same year, a District Chapelry was assigned to the Consecrated Church of Saint Thomas, situate at Stamford Hill, in the Parish of Hackney, in the said County and Diocese, and the said District Chapelry was named 'The Stamford Hill District,' but, as this name was inconvenient, the name of 'Saint Thomas, Stamford Hill,' has commonly been adopted instead of it:

"And whereas the said District Chapelry of Saint Thomas, Stamford Hill, has, under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become a New Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty,

Chapter 94:

"And whereas by the authority of an Order of Her said late Majesty in Council, bearing date the 23rd day of August, in the year 1883, and published in the London Gazette on the 11th day of the following month, a Separate District for spiritual purposes was constituted partly out of the Parish of Stoke Newington, in the said County and Diocese, and partly out of the said New Parish of Saint Thomas, Stamford Hill, and the said District was named 'The District of Saint Andrew, Stoke Newington':

"And whereas the said District of Saint Andrew, Stoke Newington, has become a New Parish of the character contemplated by the above-mentioned Act of the 6th and 7th years of Her said late Majesty, Chapter 37, by the above-mentioned Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and by the above-mentioned Act of the 32nd

and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us, and it appears to us to be expedient, that the boundaries of the said New Parish of Saint Thomas, Stamford Hill, and of the said New Parish of Saint Andrew, Stoke Newington, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Honourable and Right Reverend Arthur Foley, Bishop of London, (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose, that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint Thomas, Stamford Hill, and of the said New Parish of Saint Andrew, Stoke Newington, shall be altered so that all that portion of the said New Parish of Saint Thomas, Stamford Hill, which is described in the Schedule hereunder written, and is delineated and set forth upon the Map or Plan hereunto annexed, and is thereon coloured pink, shall be dissevered from such New Parish, and shall be annexed to and shall in future form part of the said New Parish of Saint Andrew, Stoke Newing-

ton.

"And we further represent, recommend, and propose, that nothing' herein contained shall prevent us from representing, recommending, and proposing, any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

of any other Act of Parliament.

"All which we humbly represent, recommend, and propose, to Your Majesty in Council.

"The SCHEDULE to which the foregoing. Scheme or Representation has reference.

"The territory to be dissevered from the New Parish of Saint Thomas, Stamford Hill, in the County of Middlesex, and in the Diocese of London, and to be annexed to the New Parish of Saint Andrew, Stoke Newington, in the same County and Diocese, being:—

"All that portion of the said New Parish of Saint Thomas, Stamford Hill, which is bounded upon all sides as follows, that is to say, upon the south-west by the said New Parish of Saint Andrew, Stoke Newington, upon the north-west partly by the last-named New Parish, and partly by the New Parish of Saint John, Vartry Road, Stamford Hill, in the said County and Diocese, upon the north, and upon part of the east, by the Consolidated Chapelry of Saint Bartholomew, Stamford Hill, in the said County and Diocese, and upon the remaining part of the east by an imaginary line commencing upon the toundary which divides the said Consolidated Chapelry of Saint Bartholomew, Stamford Hill, from the said New Parish of Saint Thomas, Stamford Hill, at the junction of Ravensdale Road with the Road called Stamford Hill, and extending thence southward along the middle of Stamford Hill for a distance of 50 chains or thereabouts to the boundary which divides the said New Parish of Saint Thomas, Stamford Hill, from the said New Parish of Saint Andrew, Stok:

Newington."

And whereas Drafts of the said Scheme or Representation have been transmitted to the Patrons, and to the Incumbents, of the Cures affected by the arrangements which are contemplated by such Scheme or Representation, and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in

Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar

of the said Diocese of London:

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 12th day of July, in the year 1917, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Staunton, in the County of Gloucester, and in the Diocese of Gloucester:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Staunton is vested for an estate in fee simple, in possession, free from incumbrances, in Henry Arthur Ilbert Machen, of English Bicknor, in the County of Gloucester, Electrical Engineer:

"And whereas the said Henry Arthur Ilbert Machen is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Staunton, now vested in him as aforesaid, should be transferred to and be vested in the Right Reverend Edgar Charles Sumner, now Bishop of Gloucester, and his Successors in the same Bishopric:

"And whereas the said Edgar Charles Sumner, Bishop of Gloucester, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which, by the Acts in the hereinbeforementioned Act recited, or by some or one of them, is made necessary, he, the said Edgar Charles Sumner, Bishop of Gloucester, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Staunton which is hereinbefore mentioned, and hereinafter recommended and proposed, will, in our opinion, tend to make better provision for the Cure of Souls in the Parish or District in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say, in the Parish of Staunton:

"Whereas at certain extremities of the said New Parish of Saint Stephen, Castle Hill, Ealing. and of the New Parish (sometime District Chapelry) of Saint Peter, Mount Park, Ealing, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several Churches of such New Parishes:

Port of Lerwick and Approaches-Traffic Regulations.

Notice is hereby given that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force:-

- The Port of Lerwick shall comprise all enclosed waters between the line joining Kirka-bister lighthouse and Ness of Sound to the southward, and the line joining Easter Rova Head lighthouse, Holm of Beosetter and Holm of Gunnista to the northward.
- 2. Merchant vessels shall obey all orders given them by the Naval Port Authorities as regards anchoring or shifting berth.
- 3. Unescorted vessels arriving off the Port of Lerwick during the hours of darkness are to close the examination drifter or the patrol vessel outside the Port, who will pass them in as soon as possible. They are on no account to anchor unless ordered by the Naval Authorities to do so. The examination vessel carries threered lights, vertical.
- 4. During foggy and thick weather, traffic in and out of the Port is stopped, and no vessels shall approach the obstructions from either direction.
- 5. No vessel (other than H.M. Ships) or boat shall move in the harbour during the hours of darkness as aforesaid, and no boat (other than those belonging to H.M. Ships) shall approach the shore or go alongside any pier inthe Port of Lerwick.
- 6. All vessels (other than H.M. Ships) enter: ing or leaving the Port of Lerwick shall be piloted in and out, unless otherwise ordered by the Naval Authorities.

- 7. Vessels, when cleared, shall wait for the orders from the Naval Authorities before leaving.
- 8. Drifters engaged on Pilot or Examination Duty will fly the Examination Flag, and all vessels arriving are to close the drifter off the Port flying this flag, and obey any orders that they may receive.
- 9. Incoming and outgoing traffic will be regulated by Signals hoisted by the Gate Vessels, which have been placed in position, and at the flagstaff at Kirkabister lighthouse.
- 10. The North Entrance is closed to traffic (other than H.M. Ships).
- 11. Traffic Signals are to be strictly obeyed, and no vessel shall approach the Entrance when the Signals displayed are not in her favour.
- 12. The following Signals will be displayed at the Kirkabister flagstaff and Gate Vessels:—

KIRKABISTER FLAGSTAFF.

Gate "Open for Inward Traffic":

By day—two black balls vertical.

By night—a red light.

Gate "Open for Outward Traffic":
