BY THE KING. A PROCLAMATION

Under the Munitions of War Acts, 1915 and 1916.

GEORGE R.I.

WHEREAS by section three of the Munitions of War Act, 1915, as amended by the Munitions of War (Amendment) Act, 1916, it is provided that the differences to which Part I. of the first-mentioned Act applies are differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting munitions work, and also any differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting employment on any other work of any description, if that Part of that Act is applied to such a difference by His Majesty by Proclamation, on the ground that in the opinion of His Majesty the existence or continuance of the difference is directly or indirectly prejudicial to the manufacture, transport, or supply of Munitions of War; and it is also provided that the said Part of the said Act may be so applied to such a difference at any time, whether a lock-out or strike is in existence in connection with the difference to which it is applied or not: Provided that if in the case of any industry the Minister of Munitions is satisfied that effective means exist to secure the settlement without stoppage of any difference arising on work other than on munitions work, no Proclamation shall be made under the said section with respect to any such difference:

And whereas a difference within the meaning of the said section exists between employers and certain locomotive drivers, firemen and cleaners employed on the Railways in the United Kingdom, as to rates of wages, hours of work, and otherwise as to terms and conditions of or affecting employment on the work carried on by such persons:

And whereas the President of the Board of Trade has investigated the matter and the Minister of Munitions, having considered the results of the investigation made by the President of the Board of Trade and his representations to the Minister of Munitions, is not

satisfied that effective means exist to secure the settlement of the said difference without stoppage, being a difference arising on work other than munitions work:

And whereas in Our opinion the existence or continuance of the said difference is directly or indirectly prejudicial to the manufacture, transport, or supply of Munitions of War:

Now, therefore, We, by and with the advice of Our Privy Council, are pleased to proclaim, direct and ordain, that Part I: of the Munitions of War Act, 1915, shall apply to the said difference.

Given at Our Court at Windsor Castle, this Eighteenth day of August, in the year of our Lord One thousand nine hundred and seventeen, and in the Eighth year of Our Reign.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by Section 80 of the Merchant Shipping Act, 1906, power is given to His Majesty, by Order in Council, to make Regulations as to the manner in which Government Ships may be registered as British Ships under the Merchant Shipping Acts:

And whereas by the said Section it is provided that those Acts shall, subject to any exceptions or modifications which may be made by Order in Council, either generally or as respects any special class of such Ships, apply to such Ships when registered in accordance with such Regulations:

And whereas on account of urgency the Regulations hereinafter contained should come into immediate operation:

Now, therefore, His Majesty, by virtue of the powers in this behalf by the said Act, or otherwise, in Him vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following Regulations shall come into operation forthwith as *Provisional Rules* in accordance with the provisions of Section 2 of the Rules Publication Act, 1893, and shall have effect as regards any Government Ships in the service of the Shipping Controller:—

- 1. An application for registry of a Government Ship in the service of the Shipping Controller shall be made in writing under the hand of the Secretary to the Ministry of Shipping. Such application shall contain the following particulars:—
 - (1) A statement of the name and description of the Ship.
 - (2) A statement of the time when, and place where, the Ship was built; or, if the Ship was foreign built, and the time and place of building are unknown, a statement to that effect, and of her foreign name.
 - (3) A statement of the nature of the title to the said Ship, whether by original construction by or for the Shipping Controller,

- or by purchase, capture, condemnation, or otherwise, and a list of the documents of title, if any, in case she was not originally constructed by or for the Shipping Controller
 - (4) A statement of the name of the Master.
- 2. The Registrar, on receiving such application in respect of a Government Ship in the service of the Shipping Controller, shall:—
 - (1) Enter the Ship in the Register Book as belonging to "His Majesty, represented by the Shipping Controller," and shall also enter therein:—
 - (2) the name of the port to which she belongs:
 - (3) the particulars stated in the application for registration:
 - (4) the details comprised in the Surveyor's Certificate.
- 3. On the registry of a Government Ship in the service of the Shipping Controller the Registrar shall retain in his possession the Surveyor's Certificate and the application for registry, and any documents of title mentioned in such application.
- 4. Upon the transfer of a registered Government Ship in the service of the Shipping Controller by Bill of Sale the Shipping Controller shall be the transferor, and the Bill of Sale shall be in Form A in the proper form prescribed under the Principal Act, omitting the covenant therein contained. Any such Bill of Sale shall be signed by the Secretary to the Ministry of Shipping on behalf of the Shipping Controller.
- 5. The application for a Certificate of Sale referred to in Sections 39 to 42 and Sections 44 to 46 of the Principal Act, may be made in respect of a Government Ship in the service of the Shipping Controller by the Secretary to the Ministry of Shipping on his behalf.
- 6. The person to whom the management of any Government Ship in the service of the Shipping Controller is entrusted by the Shipping Controller shall be registered as provided by Section 59 (2) of the Principal Act.
- 7. Government Ships in the service of the Shipping Controller registered in pursuance of the provisions of this Order in Council are hereby excluded from the category of Ships belonging to His Majesty within the meaning of Sections 557 to 564 of the Principal Act.
- 8. Where any Section of the Merchant Shipping Acts which, by virtue of the Merchant Shipping Act, 1906, and this Order in Council, is applicable to Government Ships in the service of the Shipping Controller imposes any duty or liability or confers any right or power upon or contemplates any act being performed by the owner of a Ship such duty, liability, right or power shall, subject always to the other provisions of this Order in Council, be carried out, borne, or exercised by the Shipping Controller on behalf of His Majesty.
- 9. In this Order in Council the term Merchant Shipping Acts shall mean and include any of the Merchant Shipping Acts, any provision of which is by virtue of the Merchant Shipping Act, 1906, and this Order, applicable to Government Ships.
- 10. Section 1 and Sections 8 to 12 of the Merchant Shipping Act, 1894, shall not apply

to Government Ships in the service of the Shipping Controller registered in pursuance of the provisions of this Order in Council. Provided always that no provision of the Merchant Shipping Acts which, according to a reasonable construction, would not apply in the case of Government Ships in the service of the Shipping Controller shall be deemed to apply to such Ships by reason only that its application is not hereby expressly excluded.

Whitehall, August 19, 1917.

The KING has been pleased to award the Albert Medal of the Second Class to Second Lieutenant John Pitts Campbell, Royal Field Artillery, in recognition of his gallantry in saving life in France in March last.

On the 9th March, 1917, in the Rutoire Plain, near Loos, a British aeroplane fell to the ground and turned completely over, throwing out the pilot and bursting into flames. The machine-gun ammunition caught fire, with the result that bullets were flying in all directions. Lieutenant Campbell ran up and at great personal risk dragged the pilot, who was wounded, out of danger. He then placed him in a neighbouring dug-out, sent for medical assistance and organised a party of stretcher-bearers to carry him to a dressing-station.

Whitehall, August 19, 1917.

The KING has been pleased to award the Albert Medal of the Second Class to Captain William Donald Cheshire, Lancashire Fusiliers, and to Serjeant Albert Ford, Royal Welsh Fusiliers, in recognition of their gallantry in saving life in France.

At Neuve Chapelle, on the 1st May, 1916, while practice with live grenades was being carried out, one of the class, in attempting to throw a grenade from which the safety pin had been withdrawn, struck his hand against the parados, so that the grenade was knocked out of his hand and fell into the trench, in which about twenty men were collected.

Captain (then Lieutenant) Cheshire rushed forward, but was hampered and delayed by the men, who were trying to get clear. Nevertheless, he seized the grenade and threw it over the parapet. It exploded immediately after leaving his hand.

At Gorre, on the 30th March, 1916, while a class of men was under instruction in bombing, a member of the class hit with his bomb the traverse in front of him, so that the smoking bomb fell into the trench. The man immediately ran away, knocking down Serjeant Ford, who was acting as instructor. Ford at once recovered his feet, pushed past the man, and managed to pick up the bomb and throw it clear; it exploded immediately it left his hand.

TRADE BOARDS ACT, 1909.

Paper Box Trade Board (Great Britain).

In accordance with Regulations made under Section 18 of the above Act by the Board of Trade, and dated 27th April, 1910, the Trade Board established for that branch of the Box Trade in Great Britain which is engaged in the making of boxes or parts thereof made wholly or partially of paper, cardboard, chip or similar material have given notice, as required by Section 4 of the above Act, that they have varied the following minimum, or lowest, time rates of wages for female workers:

- (a) for female workers other than homeworkers, from 3¹/₄d. to 4d. an hour.
- (b) for female homeworkers, from 3½d. to 4d. an hour.

The Trade Board have given similar notice that they have varied the minimum time rates of wages for female "learners" (as defined by the Trade Board).

The Trade Board have also given notice that they have varied the minimum time rates of wages for male workers from 6d. to 7d. an hour, and that they have varied the minimum time rates of wages for male "learners" (as defined by the Trade Board).

The Notices setting out the variations which have been made are dated 13th August, 1917, from which date the variations take effect. TRADE BOARDS ACT, 1909.

In accordance with Regulations made under section 18 of the above Act by the Board of Trade, and dated 27th April, 1910, the Trade Board established under the above Act for certain branches of the Machine-made Lace and Net Finishing trade, as defined in Regulations made by the Board of Trade, and dated 16th March, 1914, have given notice, as required by section 4 of the above Act, that they have varied certain General Minimum Piece Rates in accordance with their proposal to vary dated 31st March, 1917.

The Trade Board have given similar notice that they have varied the minimum rates fixed by them and set out in their notice dated 18th August, 1911, in respect to their application to workers who fetch their own work from the warehouse and do not receive it through a middlewoman or middleman.

The Trade Board have given similar notice that they have varied the minimum time rate fixed by them for workers other than learners from $2\frac{3}{4}$ d. per hour to $3\frac{1}{2}$ per hour.

The Trade Board have given similar notice that they have varied in respect of their amount and their application the minimum times rates fixed by them for "Learners" (as defined by the Trade Board), and set out in their notices dated 18th August, 1911, and 2nd November,

ORDER OF THE MINISTER OF MUNITIONS AS TO SUPERPHOSPHATES.

20th August, 1917.

The Minister of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm Regulations and of all other powers enabling him, hereby orders as follows:—

- 1. As on and from the day following the date of this Order the maximum prices for Superphosphate shall be as follows:—•
 - (a) In the case of sales or purchases for delivery in railway trucks at purchaser's or consumer's siding or nearest railway station or ex barge or ship at purchaser's or consumer's wharf, or in the case of sales or purchases for shipment to the Channel Islands, f.o.b. at port of shipment, the prices specified in the Schedule hereto, but less a discount or deduction of 2s. 6d. per ton on sales of two tons and upwards by makers or producers to Manure Mixers, Agricultural Merchants and Dealers, and Co-operative Societies registered under the Friendly Societies Acts.
 - (b) In the case of sales or purchases for delivery at maker's or producer's works free into purchaser's or consumer's carts or wagons for conveyance direct by road to consumer's premises, the prices specified in the Schedule hereto less 10s. per ton.
 - (c) In the case of sales or purchases for delivery ex vendor's store or shop or ex warehouse, railway goods yard or public wharf, the prices specified in the Schedule hereto with the addition of the following amounts according to the quantity of Superphosphate included in the sale or purchase, namely:—

Quantity sold or purchased.

4 tons and over 5s. per ton.

1 ton and over but less than 4 tons 10s. ,, ,,

2 cwts. and over but less than 1 ton 1s. ,, cwt.

Less than 2 cwts. ... 2s. ,, ,,

Provided that such additional prices shall not be charged or paid in the case of sales or purchases of more than one ton for delivery ex railway goods yard or public wharf.

(d) In the case of sales or purchases for delivery by road at consumer's premises from vendor's store or shop or from warehouse, railway goods yard or public wharf, the maximum prices authorised under paragraph (c) above plus cost of or local rates for cartage or haulage.

- 2. The maximum prices fixed by paragraphs (a) and (b) of clause 1 of this Order shall not apply to any sale or purchase by or from a maker or producer for delivery as mentioned in those paragraphs where the quantity of Superphosphate included in the sale or purchase is less than two tons; and none of the provisions of clause 1 hereof shall apply to any sale of Superphosphate for export from the United Kingdom. But save as aforesaid no person shall as on and from the day following the date of this Order until further notice effect or offer to effect any sale or purchase of Superphosphate except for delivery in accordance with the terms specified in one or other of sub-paragraphs (a), (b), (c), and (d) of clause 1 of this Order and at a price not exceeding that prescribed by the said clause and the Schedule hereto as the maximum price (having regard to quantity, quality and date for and terms of delivery) for such sale or purchase.
- 3. The maximum prices fixed by clause 1 of this Order are net prompt cash prices for Superphosphate in maker's or vendor's bags. Where credit is given to the purchaser a reasonable extra charge may be made provided that a price for net prompt cash is quoted on the invoice and does not exceed the maximum price authorised. If purchaser's bags are used, a reasonable allowance shall be made.
- 4. All persons engaged in producing, manufacturing, selling, distributing or storing Superphosphate, or in any manufacture in which the same is used, shall make such returns with regard to their businesses as shall from time to time be required by or under the authority of the Minister of Munitions.
- 5. All the provisions of the Fertilisers and Feeding Stuffs Act, 1906, and the regulations made by the Board of Agriculture and Fisheries in pursuance of the provisions of that Act shall apply mutatis mutandis to this Order.
- 6. For the purposes of this Order Superphosphate shall mean Superphosphate of Lime manufactured from Mineral Phosphate but shall not include Basic Superphosphate, Bone Superphosphate, Dissolved Bones, Bone Meal or Bone Compound, Guanos or Compound Manures

The above prices for all qualities are for orders placed for delivery during December, 1917. In the case of orders placed for delivery during other months the above prices are in each case to be reduced or increased 1s. per ton per month according as the month for delivery precedes or is subsequent to December, 1917, but with a maximum increase of 5s. per ton, e.g., the prices for October, 1917, deliveries will be 2s. less per ton, while the prices for May and June, 1918, deliveries will be 5s. more per ton than the prices set out above.

RULES FOR THE ROYAL NAVAL CORDITE FACTORY, UNDER THE DEFENCE OF THE REALM REGULATIONS.

In pursuance of the powers conferred by Regulation 35A of the Defence of the Realm Regulations, the Lords Commissioners of the Admiralty hereby make the following rules:—

A pplication.

1. These rules shall apply to any person employed or being in the Royal Naval Cordite

Factory. The posting of these rules at the main gates shall be deemed to be notice of their contents to all concerned.

Smoking.

2. No person shall smoke within the Factory except as authorised by the Superintendent, or in accordance with the Factory's General Rules.

Tobacco, Cigars, Cigarettes or Pipes.

3. No person shall bring into the Factory, or have in his possession therein, any Tobacco, Cigar, Cigarette or Pipe except as authorised by the Superintendent, or in accordance with the Factory's General Rules.

Matches and Prohibited Articles.

4. No person shall bring into the Factory matches, or other means of procuring a light or articles likely to cause fire or explosion, except as authorised by the Superintendent, or in accordance with the Factory's General Rules.

Searching.

5. Any Police Constable and anyone authorised by the Superintendent may search at any time any person entering or being within the Factory, and may examine such person's clothing and any bag, basket, parcel or other articles carried by him or her, and any person entering or being within the Factory shall, if so required by any such Police Constable or authorised person, submit to being searched and comply with any reasonable directions or regulations given or made with the object of enabling the search to be carried out, provided that in no case shall any female person be searched by, or in the presence of anyone, but a female person.

Intoxication.

6. No person in a state of intoxication shall be, or shall be allowed to enter or to remain, within the Factory. No person shall bring within the Factory any beer, wine or spirits except as authorised by the Superintendent.

Definition.

7. For the purpose of these rules the expression "Factory" shall include any building and any portion of the land enclosed by the main fence of the Factory, and shall also be deemed to include the wharf and the approach thereto from the Factory.

Penalty.

8. Any person failing to comply with the above rules shall be deemed to be guilty of an offence against the Defence of the Realm Regulations, and shall be liable on summary conviction to imprisonment, with or without hard labour, for a period not exceeding six months, or to a fine not exceeding £100, or both


To all to whom these presents shall come the Ecclesiastical Commissioners for England send greeting:

WHEREAS a new church has lately been built within the Parish of Portland, in the County of Dorset and in the Diocese of Salisbury, and has been consecrated and is known as the Church of All Saints.

And whereas the Right Reverend Frederic Edward, Bishop of Salisbury, as such Bishop, the Right Reverend Charles, Bishop of Oxford, as the Patron in right of his See, of the Rectory of the said Parish of Portland, and the Reverend David Barnes Griggs, Clerk in Holy Orders, as the Rector or Incumbent of the same Rectory, have by an Instrument under their hands, bearing date on or about the nineteenth day of June in the year One thousand nine hundred and seventeen, certithe said Ecclesiastical Commisfied to us, sioners for England, that it would be for the convenience of the said Parish of Portland that the said new Church of All Saints, situate within such parish, should be substituted for the old parish church (known as the Church of Saint George) of the same parish.

Now therefore, we, the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do by this Instrument under our Common Seal, with the consent (testified as hereinafter mentioned) of the said Frederic Edward, Bishop of Salisbury, of the said Charles, Bishop of Oxford, and of the said David Barnes Griggs, hereby declare that the said new Church of All Saints, situate within the said Parish of Portland, and duly conse-crated as aforesaid, shall be and the same is hereby substituted for the said old parish church of the same parish, and that such new church shall henceforth be the parish church of the said Parish of Portland in lieu of the said old parish church of the same parish as fully in all respects as if the said new Church of All Saints, so hereby substituted, had been originally the parish church of the same parish; and we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned) do hereby transfer all the endowments, emoluments, and rights of or, belonging to the said old parish church of the said Parish of Port land or of or belonging to the Rector or Incumbent thereof, to the said new Church of All Saints (now being by virtue of these presents the parish church of the said Parish of Portland) and to the Rector or Incumbent thereof and his successors for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners for England, have set our Common Seal, and the said Frederic Edward, Bishop of Salisbury, and the said Charles, Bishop of Oxford, have respectively set their hands and affixed their Episcopal Seals, and the said David Barnes Griggs has set his hand and affixed his seal this twenty-sixth day of July in the year One thousand nine hundred and seventeen.



ADMIRALTY NOTICE TO MARINERS.

No. 819 of the year 1917. ENGLAND, EAST COAST.

River Humber and Approaches—Pilotage and Traffic Regulations.

Former Notice.—No 699 of 1917; hereby cancelled.

Mariners are hereby warned that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force:—

- 1. That portion of the Humber which lies between two straight lines, drawn from shore to shore, as follows:—(1) a line drawn 225° (S. 61° W. Mag.) through Spurn lighthouse, (2) drawn 344° (North Mag.) from the east side of Barrow haven, will be referred to as the "port" in these regulations.
- Shipowners and local agents are warned that their vessels should be directed to conform to the following regulations:—
 - (I.) Except under exceptional circumstances merchant vessels will be free to enter or leave the port during the hours of Official day.
 - (II.) Before entering the port merchant vessels must receive permission and the necessary instructions from the Examination steamer, and before leaving they must obtain permission through the Collector of Customs at Hull, Grimsby, or Goole, as the case may be.
 - (III.) Shipowners and local agents are advised to time the arrival of their vessels at the port for daylight.
 - (IV.) Vessels desiring to enter the port from seaward are, unless previously met by the Examination steamer, to proceed to the Southern Examination anchorage (except

during strong northerly or easterly winds, when they should proceed to the Northern Examination anchorage) and there anchor.

(V.) The Examination steamer will be met in the Examination area between Bull light-vessel and Chequer Shoal buoy.

The Examination steamer will be distinguished by the following means:—

By Day.—A white ensign, and at the foremast head the special flag mentioned in Part II. of Admiralty Notice to Mariners No. 1 of 1917. When the port is closed 3 red balls will be hoisted in addition to the special flag.

By Night.—Three lights vertically, 3 feet apart, conspicuously displayed at the end of a yard so as to shew an unbroken light round the horizon. When the port is closed these lights will be red, when it is open they will be white

Note.—These lights are in addition to the ordinary navigation lights.

(VI.) There are two Examination anchorages. The northern is to be used in strong northerly and easterly winds. The southern is to be used under all other conditions.

The Northern Examination anchorage comprises those portions of Hawke road and Middle shoal included between the intersection of the following lines of bearing:—

- (1) Skeffling church bearing 18° (N. 34° E. Mag.)
- (2) Skeffling church bearing 4° (N. 20° E. Mag.)
- (3) Spurn lighthouse bearing 120° (S. 44° E. Mag.)
- (4) Extreme of Spurn point bearing 115° (S. 49° E. Mag.)

The Southern Examination Anchorage comprises the area bounded as follows:—

- (1) On the north by the Bull sand.
- (2) On the south by the three fathom contour line northward of Tetney haven.
- (3) On the east by the line joining the Bull light-vessel and entrance to Tetney haven.
- (4) On the west by a line parallel to and 7 cables from the eastern limit (3).

Note.—When the Southern Examination anchorage is full of shipping further arrivals should anchor eastward of and as near to it as possible.

The Examination area is that portion of the river enclosed by an irregular line drawn from the Bull light-vessel to the extreme of Spurn point, thence to the Chequer Shoal buoy, thence to a point 210° (S. 46° W. Mag.) of and distant 7 cables from Bull light-vessel and thence to Bull light-vessel.

3. All pilotage certificates granted to masters and mates for the whole or any part of the Humber Pilotage district are suspended and further all vessels (irrespective of draught, size, or nationality, but with the exception of those provided for in paragraph 4) bound to or from any place on the Humber must be conducted by licensed pilots over the whole or any part of the waters between Hull and the Outer Pilotage station of the Humber Pilotage district, which station, until further notice, will be situated in the neighbourhood of the Bull light-vessel.

- 4. In the case of lighter inter-dock traffic and of small British vessels engaged in local traffic above Immingham, pilotage by licensed pilots is not compulsory.
- 5. During the hours of official night, and during fog with visibility of less than half-amile, no traffic is permitted to move on the Humber below Paull point.
- 6. Every vessel shall endeavour to approach the Humber in sufficient time to enable such vessel to obtain a pilot and arrive at her destination, or at a position in which she is permitted to anchor, before the commencement of official night, but should occasions arise when a vessel is delayed through unforeseen or unpreventable circumstances from arriving in time, she may approach the Examination steamer, from whom she will receive directions as to anchoring until the end of official night. The Examination steamer will be found in the neighbourhood of the Bull light-vessel after the commencement of official night. In the event of an incoming vessel being unable immediately to find the Examination steamer in these circumstances, she is to remain in the vicinity of the Bull light-vessel, but shall not cross the line drawn 225° (S. 61° W. Mag.) through Spurn lighthouse without permission. Outward bound vessels shall not pass Hawkins point later than 45 minutes before the commencement of official night.
- 7. Vessels when leaving the Humber must proceed direct to sea. Should it be necessary to wait for the weather to moderate or clear, they must remain inside the river at an authorised anchorage.

The pilot lobbies will be notified when the existence of fog outside the river is known.

8. All vessels proceeding into or out of the Humber must be navigated by way of Hawke and Sunk roads passing to the northward of the Bull light-vessel, except those outward-bound from Grimsby, which may cross the Middle shoal, passing at once into the channel north of the Middle.

Note.—The five-fathom channel through the Sunk and Hawke roads is very narrow at the western entrance and also at a point north of the Middle light-vessel; deep-draught vessels steaming against the tide when approaching the buoys marking these portions of the channel should endeavour to avoid passing other vessels between them by easing engines to allow ships with the tide under them to get through first. Smaller vessels outward-bound should pass close to the southward of the buoys marking the south side, and those inward-bound close to the northward of the buoys marking the north side, of the narrow portions of the channel, provided always that their draught of water and the state of the tide will admit.

- 9. Sailing vessels of 50 tons register and upwards when entering or leaving the Humber must be towed through the Boom Defence gateways. Should tugs not be available, inward-bound vessels may anchor north-westward of the No. 2 Lower Middle light-float at a distance of not more than 1½ miles from it, but they must not bring the before-mentioned light-float to bear to the southward of 128° (S. 36° E. Mag.).
- 10. All vessels entering or leaving Grimsby docks must pass to the southward of the No. 4

Lower Burcom buoy except those making use of the channel southward of the Burcom shoal (hereinafter called the Burcom channel), which are exempted from this condition, but no vessel may cross the Burcom shoal between the No. 5 Middle Burcom and No. 4 Lower Burcom buoys. Vessels using the Burcom channel must pass into and out of its western end to the eastward of No. 6 Upper Burcom buoy, and through a gateway at its eastern end 220 feet wide, each side of which is marked by a dolphin surmounted by a black triangle supported on a white pole. No vessel is permitted to tow more than two craft at one time through this gateway.

Vessels making us of this gateway are cautioned to keep well in the middle of the opening, and are subject to the following regulations:—

- (1) Vessels navigating against the tide must in all cases give way to those navigating with the tide.
- (2) No vessel must approach the defences in this part of the river nearer than a quarter of a mile except to pass through the before-mentioned gateway or to enter or leave the docks or old outfall.
- (3) No vessel may tow more vessels at one time than she can safely navigate through the gateway, and under no circumstances is the tow to comprise more than two craft.
- (4) Distant signals will be shown from the flagstaff on the West Pier at the Grimsby Dock entrance as follows:—
 - (a) Two black balls will denote that the gateway is open.
 - (b) Three black balls will denote that the gateway is closed.
 - (c) No signal being hoisted denotes that traffic is suspended.

When signal (b), three black balls, is hoisted, no vessel may approach the gateway, and when traffic is suspended no vessels, other than H.M. Ships on special duty, may use the gateway.

- 11. Prohibited Anchorage areas:-
- (I.) Anchorage is prohibited for all vessels between two lines:—
 - (a) Joining Stone Creek Coast Guard flagstaff and the eastern extremity of the eastern jetty at Immingham.
 - (b) Joining the riverward beacon of the two centre measured mile beacons on Sunk island and the northernmost of two clumps shown southward of Stallingborough on Admiralty Chart No. 109. The latter line passes through the position of No. 6 Upper Burcom buoy.
- (II.) No merchant vessel shall anchor (except when granted special permission) between the before-mentioned prohibited anchorage area (I.) and the line of transit of the eastern measured mile beacons on Sunk island produced to the Lincolnshire shore or (except as provided for in paragraph 9) to the northward of the line of the Killingholme leading lights, or within 1½ cables of any of the Admiralty mooring buoys.
- (III.) Anchorage is prohibited between the following lines:—
- (a) A line joining New Clee railway station and Patrington church.

- (a) A line joining Middle light-vessel and No. 4 Lower Burcom buoy, extended to both banks of the Humber.
- (IV.) Anchorage is prohibited to merchant vessels to the southward of a line joining No. 4 Lower Burcom buoy and Spurn lighthouse, or to the eastward of a line joining Cleethorpes pier pavilion and Skeffling church, except so far as the Examination anchorages are concerned.
- (V.) No vessel of any description may anchor on the south side of the Bull sand between the western limit of the Southern Examination anchorage described in paragraph 2 of this notice and a line drawn through the Cleethorpes Sewer outfall beacon (on which a red light is exhibited in peace time) in a direction 60° (N. 76° E. Mag.), passing through a point 299° (North-west Mag.) distant 7 cables from Spurn lighthouse; nor on the north side of the Bull sand between the before-mentioned line of bearing passing through the Cleethorpes Sewer outfall and a line joining Spurn lighthouse and the Bull light-vessel produced to the Bull sand; nor within 3 cables of the No. 4 Lower Burcom buoy.
- 12. No neutral vessel may lay alongside any of the piers or jetties in the Humber at night without special permission.
- 13. No merchant vessels or boats, etc., will be allowed to approach within a quarter of a mile of any defence work (except to pass through the Boom gateways or to enter or leave the old outfall or docks at Grimsby) or to go alongside any Government ship, vessel, lighter, or any other Government craft, or any Government establishment, without special permission. All vessels proceeding up and down the Humber are to pass at a distance at least three cables from H.M. ships, if the depth of water and circumstances of navigation permit.
- 14. All vessels employed in laying moorings, raising wrecks, etc., must be passed at slow speed, propelling engines being eased at least 300 yards before reaching such vessels and so continued for 150 yards after passing them. While the said mooring or wreck-raising craft are at work they will each fly a red flag.
- 15. Anchor lights are to be reduced in power and screened as prescribed in Admiralty Notice to Mariners No. 581 of 1917.

Vessels anchored in the Humber westward of a line joining Cleethorpes pier pavilion and Skeffling church are to exhibit anchor lights as mentioned above, except that between Immingham and the before-mentioned line they are to be reduced in brilliancy so as to be invisible at any greater distance than half-a-mile. Eastward of the line joining Cleethorpes pier pavilion and Skeffling church no lights whatever are to be exhibited.

This order will not absolve the Masters of craft at anchor from keeping a sharp look-out and giving warning on the approach of any craft under way.

Anchor lights authorised by these orders are never on any account to be extinguished; the order "Out Lights" will not apply to them.

Bow and masthead steaming lights are to be as prescribed in Admiralty Notice to Mariners No. 581 of 1917. Other lights are to be as prescribed in Admiralty Notice to Mariners No. 581 of 1917, and this order also applies to vessels in dock or alongside quays and jetties. Notwithstanding anything in these orders, dredgers may be permitted to work at Hull and Immingham at night provided all their lights are extinguished within half-an-hour of issue of the general order "Out Lights."

The above orders apply to vessels of every description, other than H.M. ships. The latter should, however, comply so far as the visibility of anchor lights eastward of Immingham is

concerned.

- 16. No vessel is permitted to tow more than three craft at one time through a gateway of the Boom defence, or more than two through the gateway in the Burcom channel described in paragraph 10. Owners of tugs may apply to the Humber Conservancy Board for pilot licences for the masters of their vessels which will enable them to pilot their own vessels and river craft comprising their tow (in certain parts of the river). The number of craft towed will be restricted according to the power of the tug.
- 17. Humber Rule No. 18 is to be strictly enforced. No sound signals other than navigation signals authorised by the Regulations for Preventing Collisions at Sea, and by Humber Rules Nos. 14 to 16 (inclusive), at all times of the day or night, and No. 17 during the day only, are on any account to be used by vessels in any part of the Humber, the Old Harbour at Hull, or within any of the docks at Hull, Immingham and Grimsby.
- 18. Owners of small vessels plying in the vicinity of the Humber are instructed not to paint their craft light grey, and are hereby directed to have any vessels so coloured repainted. They are warned that small vessels painted grey run a great risk of being fired upon in mistake for submarines. Vessels painted black run the least risk.
- 19. Fishing in the Humber.—No vessel is allowed to fish in the Humber below Hull without a permit from the Admiralty port officer; all fishing, shrimping, trawling, or whelking in this portion of the river in areas other than those for which permits are granted is prohibited.

Pleasure boats will be granted fishing permits on application to the Admiralty Port Officer. The holding of these permits will remove the restriction as to the limits within which pleasure boats may ply for hire contained in paragraph 20 below, provided they do so with the object of catching fish.

No registered fishing boat or mechanically propelled craft will be granted a pleasure permit except for the purpose of fishing.

No able-bodied professional fishermen or boatmen between the ages of 18 and 60 may be employed on land or sea in connection with any boat for which a pleasure permit has been issued.

Nothing in this notice will exempt vessels from any obligation to register or procure licences as now required by local authorities.

20. Pleasure boats of every description on the Humber must be provided with permits to be provided by the Admiralty Port Officer. Dock Offices, Immingham.

Regulations affecting small craft in the vicinity of Cleethorpes:—Pleasure boats may ply for hire at Cleethorpes only between the Eastern and Western Sewer Outfall beacons, and must keep within a distance of one mile from the shore, except under the conditions stated in paragraph 19. Notwithstanding anything in these orders, rowing boats may pass along the shore at Cleethorpes, but they must keep within 400 yards of the high-water mark of spring tides.

- 21. Excursions by Water.—Excursions by water are limited to the River Humber above Hull and Rivers Ouse and Trent. Excursion steamers will not be allowed to ply without a permit from the Admiralty Port Officer, Dock Offices, Immingham, and in no case are they to pass to the eastward of an imaginary line joining Victoria Dock entrance, Hull, and the east beacon on Skitter Ness.
- 22. Patrol of Internal Waterways.—The internal waterways of the port will be policed by Naval patrol vessels and by the Humber Conservancy Board under the direction of the Naval authorities.

Captains and Masters of Merchant Vessels and persons in charge of barges or boats of any kind are hereby warned to observe any orders which may be given to them by Naval patrol vessels or the duly authorised officers of the Humber Conservancy Board.

- 23. All instructions given by Officers in command of H.M. ships, Patrol vessels, or Examination steamers, or the duly authorised officers of the Humber Conservancy Board, are to be implicitly and promptly obeyed even' should they conflict with these orders.
- 24. Warning.—Warning is hereby given that vessels disobeying the above regulations will be liable to be fired on.

Variation.—16° W.

Note—This Admiralty Notice to Mariners is a revision of the former Notice quoted above.

Caution.

This Admiralty Notice to Mariners is issued under the provisions of the Defence of the Realm (Consolidation) Regulations, 1914, and failure to comply strictly with the directions contained in it will constitute an offence against those Regulations.
