ORDER OF THE SECRETARY OF STATE UNDER REGULATION 14A OF THE DEFENCE OF THE REALM REGULATIONS IMPOSING RESTRICTIONS ON PERSONS PROCEEDING TO OR FROM TORY ISLAND.

Whereas the Admiralty are of opinion that in view of the public safety and defence of the realm it is desirable to impose restrictions on persons proceeding to or from Tory Island.

Now, therefore, I, the Right Honourable Sir George Cave, one of His Majesty's Principal Secretaries of State, in virtue of the powers conferred on me by Regulation 14A of the Defence of the Realm Regulations, do hereby make the following Order:—

(1) No person shall embark on any ship, vessel or boat of any description proceeding to or from Tory Island, or land in the island without the permission of the Competent Military Authority, Northern District, Irish Command, Belfast, provided that the grant of any such permission shall not exempt an alien from any of the requirements of the Aliens Restriction Order with regard to the obtaining of permission to land or embark at any port in the United Kingdom or otherwise.

(2) This Order shall come into force on the 1st day of November, 1917.
