PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 20th day of November, 1917, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased, by Your Order in Council bearing date the 18th day of August, 1917, to sanction the promotion of a limited number of Naval Instructors to the rank of Chief Naval Instructor on the Active List:

"And whereas we consider it desirable that provision should be made for granting, at our discretion, the rank of Chief Naval Instructor on retirement to Naval Instructors who have the necessary qualifying service for the higher rank on the Active List:

"And whereas we further consider that the rank of Chief Naval Instructor should be granted to Naval Instructor James Robert Clark, C.B., now on the Retired List, as a recognition of his services to the Royal Navy:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to approve of these proposals, with effect, in the case of Mr. Clark, as from the 9th day of August, 1917.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 8th day of November, in the year 1917, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint Anne, Liverpool, in the County of Lancaster, and in the Diocese of Liverpool:

"Whereas by the authority of an Instrument bearing date the 29th day of January, in the year 1831, prepared in accordance with the provisions of the Act of the 10th year of His late Majesty King George the Fourth, Chapter 11 (local), and being made under the hand and seal of the late Right Honourable and Most Reverend John Bird, then Bishop of Chester, and afterwards Archbishop of Canterbury, certain parts of the Parish of Liverpool, in the said County of Lancaster, and at that time in the Diocese of Chester but now in the said Diocese of Liverpool, were assigned as Ecclesiastical Districts to 8 Consecrated Churches situate in the said Parish of Liverpool, and one of such Ecclesiastical Districts was known as the District of Saint Anne, Liverpool:

"And whereas the said District of Saint Anne, Liverpool, has, under the provisions of the Liverpool and Wigan Churches Act, 1904, become a New Parish of the character contemplated by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, by the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us, and it appears to us to be expedient, that the boundaries of the said New Parish of Saint Anne, Liverpool, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend Francis James, Bishop of the said Diocese of Liverpool (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose, that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint Anne, Liver-

pool, shall be altered so that all that portion of the said Parish of Liverpool which is described in the Schedule hereunder written, and is delineated and set forth upon the *Map* or *Plan* hereunto annexed, and is thereon coloured *pink*, shall be dissevered from such Parish, and shall be annexed to and shall in future form part of the said New Parish of Saint Anne, Liverpool.

"And we further represent, recommend, and propose, that nothing herein contained shall prevent us from representing, recommending, or proposing, any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the New Parish of Saint Anne, Liverpool, in the County of Lancaster, and in the Diocese of Liverpool, being:—

"All that isolated portion of the Parish of Liverpool, in the said County and Diocese, which is bounded upon all sides as follows, that is to say:—upon the north-west by the said New Parish of Saint Anne, Liverpool, upon the north-east by the New Parish of the Holy Trinity, Liverpool, upon the south by the New Parish of Christ Church, Liverpool, and upon the west by the New Parish of Saint Stephen, Liverpool, all in the said County and Diocese."

And whereas Drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation, and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Liverpool.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Crowle, in the County of Lincoln, and in the Diocese of Lincoln:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Crowle is vested for an estate in fee simple, in possession, free from incumbrances, in the Venerable John Wakeford, Archdeacon of Stow:

"And whereas the said John Wakeford is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Crowle, now vested in him as aforesaid, should be transferred to and be vested in the Right Reverend Edward Lee, now Bishop of Lincoln, and his Successors in the same Bishopric:

"And whereas the said Edward Lee, Bishop of Lincoln, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which, by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said Edward Lee, Bishop of Lincoln, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Crowle, which is hereinbefore mentioned, and hereinafter recommended and proposed, will, in our opinion, tend to make better provision for the Cure of Souls in the Parish or District in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say, in the Parish of Crowle:

"Now, therefore, with the consent of the said John Wakeford (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Edward Lee, Bishop of Lincoln, (in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Crowle, now vested in him the said John Wakeford as aforesaid, shall be transferred to the said

Edward Lee, Bishop of Lincoln, and his Successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Edward Lee, Bishop of Lincoln, and his Successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any, of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of a share of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Saint John the Evangelist, Spittal, in the County of Northumberland, and in the Diocese of Newcastle:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint John the Evangelist, Spittal,

is vested in the Right Reverend Herbert Louis, now Bishop of Newcastle, in right of his See:

"And whereas the Charity Commissioners, by an Order dated the 26th of January, 1917, in the matter of the Charity consisting of the endowment for a Lectureship at Berwick-upon-Tweed, founded by the Will dated the 30th March, 1625, of Richard Fishborne, and being under the management of the Mercers' Company of the City of London (hereinafter called 'the said Mercers' Company') have directed that from and after the transfer of the next, and every alternate, turn of Patronage of the said Benefice of Saint John the Evangelist, Spittal, from the Bishop of Newcastle to the said Mercers' Company, the income of the Lectureship shall be paid as to £130 per annum to the Incumbent for the time being of the Benefice of Berwick-upon-Tweed, in the Town and County of the Town of Berwick-upon-Tweed, and in the Diocese of Newcastle, towards the stipend of an Assistant Curate for that Parish, and as to the residue to the Incumbent for the time being of the said Benefice of Saint John the Evangelist, Spittal, in augmentation of the income of that Benefice:

"And whereas the said Herbert Louis, Bishop of Newcastle, in consideration of the advantage that would accrue to the said Benefice of Saint John the Evangelist, Spittal, under the terms of this Order as a result of the transfer of the next, and every alternate, turn of Patronage of and presentation to the said Benefice, now vested in him as aforesaid, to the said Mercers' Company, is consenting to such transfer, and in token of such consent, and also in token that the same transfer has that consent of the Bishop of the Diocese which, by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said Herbert Louis, Bishop of Newcastle, has executed this Scheme as hereinafter mentioned:

"And whereas the Right Honourable and Most Reverend Cosmo Gordon, Archbishop of York, is consenting to the transfer of Patronage hereinbefore mentioned, and hereinafter recommended and proposed, and in token of his consent thereto (which, by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary) he, the said Archbishop, has executed this Scheme as hereinafter mentioned:

"And whereas in the circumstances thus set forth it appears to us that the transfer of the Patronage of the said Benefice of Saint John the Evangelist, Spittal, which is hereinbefore mentioned, and hereinafter recommended and proposed, will tend to make better provision for the Cure of Souls in the Parish or District in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say, in the New Parish of Saint John the Evangelist, Spittal:

"Now, therefore, with the consent of the said Herbert Louis, Bishop of Newcastle, (and in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), and with the consent of the said Cosmo Gordon, Archbishop of York, (in testimony whereof he has signed this Scheme, and sealed the same with his Archiepiscopal Seal), and with the consent of the said Mercers' Company (in testimony of which consent they have caused their Common or Corporate Seal to be affixed to this Scheme) we, the said Ecclesias-

tical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the next turn of Patronage of and presentation to the said Benefice of Saint John the Evangelist, Spittal, and every alternate turn of Patronage thereafter, now vested in the said Herbert Louis, Bishop of Newcastle, as such Bishop, shall be transferred to the said Mercers' Company, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Mercers' Company for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 15th day of November, in the year 1917, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, Sections 6 and 8, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for authorizing the sale and disposal of certain property formerly belonging to the Bishopric of Oxford, and now vested in us:

"Whereas under an Act of the 6th and 7th years of His late Majesty King William the 4th, Chapter 37, and another Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, and another Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and by virtue of an Order of Her said late Majesty in Council, made under the provisions of the said Acts, bearing date the 24th day of June, 1856, and duly published in the London Gazette on the 1st day of the following month, the hereditaments and premises situate and being within the Parish of Burford, in the County of Oxford, particularly described in

the Schedule annexed to the said Order, which theretofore belonged to the Bishopric of Oxford, became vested in us:

"And whereas so much of the said hereditaments and premises as was not assigned as part of the endowment of the Bishopric of Oxford by virtue of an Order of Her said late Majesty in Council, made under the provisions of an Act of the 23rd and 24th years of Her said late Majesty, Chapter 124, bearing date the 7th day of February, 1877, and duly published in the London Gazette on the 27th day of the same month, is now vested in us in fee simple, free from any outstanding beneficial lease or grant, for the purposes and subject to the provisions applicable to other hereditaments vested in us, but on account of its character and situation is unsuitable and inconvenient to be held or applied for the purposes for which estates vested in us are applicable under the Acts by which our proceedings are governed:

"And whereas with a view to the advantageous appropriation of that portion of the said hereditaments and premises which is now vested in us as aforesaid, or of the proceeds thereof, for the ultimate improvement of our common fund, it is expedient that that portion of the said hereditaments and premises, or such part or parts thereof as we shall at any time, and from time to time, think fit, should be sold or disposed of, and accordingly that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as shall appear to us advisable:

"Now, therefore, we humbly recommend and propose that we may be authorized and empowered, by Instrument or Instruments in writing, duly executed according to law, from time to time to sell or dispose of, and duly to convey, according to the provisions of the said Act of the 6th and 7th years of Her said late Majesty's reign, the whole or any part of that portion of the said hereditaments and premises theretofore belonging to the said Bishopric of Oxford, and now vested in us as aforesaid, with its appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his, her, or their heirs, executors, administrators, or assigns, or otherwise, as he, she, or they shall direct or appoint, and for such consideration as shall, upon due calculation and inquiry, appear to us to be just and reasonable; it being our intention to invest the proceeds of such sale from time to time as occasion may arise in the purchase of other lands, tithes, rent-charges, tenements, or hereditaments, or of some estate or interest therein, convenient to be held by us for the purposes of the Acts by which our proceedings are governed as aforesaid, and in the meantime to invest the said proceeds in some Government or Parliamentary Stock or other Public Securities in England.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament.

"All which we humbly recommend and propose to Your Majesty in Council."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Oxford.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidating List, No. 41A) consolidating all previous Lists, revised to date and including the amendments in the Schedule annexed hereto, is issued concurrently with this Order. This Consolidating List contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

†NOTE (2).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

NOTE (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to enquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of tele-

graphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making enquiries would specify the particular trade or trades for which substitutes are required.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The Lists for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington; who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

*NOTE (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappij" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name followed by the general descriptive term "Handel Maatschappij" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappij van den Berg & Company, and Naamlooze Venootschap de Komeet v/h. Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

DEFENCE OF THE REALM (LIQUOR CONTROL).

GENERAL ORDER OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) REGULATING THE SALE AND SUPPLY OF INTOXICATING LIQUOR ON CHRISTMAS DAY IN ENGLAND AND WALES.

We the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm hereby make the following General Order:—

Areas to which the Order Applies.

1. This Order applies to all areas or parts of areas situate in England or Wales to which the Defence of the Realm (Liquor Control) Regulations, 1915, have been applied.

Hours during which Intoxicating Liquor may be Sold on Christmas Day.

2. The hours during which intoxicating liquor may (subject to the provisions of Article 3 hereof) be sold and supplied on Christmas Day in licensed premises and clubs whether for consumption on or off the premises shall be as follows:—

(a) In such part of the Western Border Area as is situate in England, the hours between 12.30 p.m. and 2.30 p.m. and 6.30 p.m. and 9 p.m. for consumption on the premises, and the hours between 12.30 p.m. and 2.30 p.m. and 6.30 p.m. and 8 p.m. for consumption off the premises.

(b) In the Welsh Area and the West Gloucestershire Area, the hours between 12.30 p.m. and 2.30 p.m. and between 6 p.m. and 9 p.m. for consumption on the premises, and the hours between 12.30 p.m. and 2.30 p.m. and between 6 p.m. and 8 p.m. for consumption off the premises.

(c) In each of the other areas, the hours during which by the provisions of Article 2 of the Orders of the Board for the said Areas such sale or supply for consumption on or off the premises is permitted on Sundays.

And Article 2 of each of the said Orders of the Board shall be read as if the provisions of this Article were inserted therein.

Sale of Spirits for Consumption off the Premises Prohibited.

3. No spirits to be consumed off the premises shall be sold or supplied in any licensed premises or club or be dispatched or taken therefrom on Christmas Day, and Article 3 of each of the said Orders shall be read as if the provisions of this Article were inserted therein.

TOXICATING LIQUOR FROM LICENSED PREMISES.

We the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm hereby make the following General Order:—

Areas to which the Order Applies.

1. This Order shall apply to all areas or parts of areas situate in England or Wales to which the Defence of the Realm (Liquor Control) Regulations, 1915, have been applied.

Duration of the Order.

2. This Order shall be in force on the 17th, 18th, 19th, 20th, 21st, 22nd, and 24th days of December, 1917.

Effect of Order.

3. During such time as this Order is in force the provisions of the Article entitled "Saving Provisions" in the Orders of the Board for the aforesaid areas authorising the dispatch from licensed premises in the forenoon of intoxicating liquor for delivery at a place more than five miles distant shall apply to the dispatch of such liquor for delivery at any place notwithstanding that the same be not more than five miles distant: Provided always that nothing herein shall be deemed to authorise the dispatch of spirits on Saturday, the 22nd day of December.

Other Provisions of the Order to Remain in Force.

4. Save as by this Order expressly provided, the provisions of each of the said Orders shall remain in full force.

GENERAL LICENSE FOR PURCHASE OF POTASSIUM COMPOUNDS FOR MEDICINAL PURPOSES.

The Controller of Potash Production hereby announces that in accordance with the powers conferred on him by the Order of the Minister of Munitions of October 17th, 1917, relating to Potassium Compounds, he licenses until further notice the purchase by any person of potassium compounds coming within the terms of the Order, notwithstanding that such purchases may exceed an aggregate of 3 lbs. per month, *provided that the compounds so purchased are used solely in B.P. form or in B.P. preparations for purely medicinal purposes.*

By this general license retail druggists, hospitals and similar institutions, medical men and others, are relieved of the onus of applying for individual licenses to purchase compounds coming within the conditions indicated in italics above, and wholesale druggists and others may supply such compounds for use as above set out without the necessity of verifying that the purchaser holds an individual license to purchase or take delivery.

It will, however, be necessary for the wholesaler in making his returns to the Controller to

state the aggregate amount and value of his sales of compounds for purely medicinal purposes during the period covered by each return.

Special forms of return will be provided for this purpose.

All sales of compounds other than those exceeding 3 lbs. aggregate per month per person and the sales for medicinal purposes hereby licensed, must be conducted strictly under purchasers' licenses as prescribed by the Order, and, together with an aggregate statement of sales under 3 lbs., and for medicinal purposes, must be brought out on the returns as at present.

ORDER.

APPLYING REGULATION 30A TO TUNGSTEN ORES, MOLYBDENITE AND METAL, AND PRODUCTS THEREFROM, AND REQUIRING RETURNS.

1. In exercise of the powers conferred upon him by Regulation 30A of the Defence of the Realm Regulations, the Minister of Munitions hereby orders that the war material to which the regulation applies shall include war material of the following classes and descriptions, namely:—

All tungsten-bearing ores and tungsten metal and alloys and salts derived or produced therefrom, and all molybdenite and molybdenum metal and alloys and salts derived or produced therefrom.

2. In exercise of the powers conferred on him by the Defence of the Realm Regulations and all other powers thereunto enabling him, the Minister of Munitions hereby orders as follows:—

(1) Every person, firm or company holding any stock of any of the material specified in clause 1 of this Order shall within fourteen days from the date hereof furnish full particulars of any such stock to the Controller of Non-Ferrous Materials Supply, Ministry of Munitions, 8, Northumberland Avenue, London, W.C. 2 (hereinafter referred to as the Controller).

(2) Every owner, lessee or licensee of a mine or mines producing tungsten bearing ores or molybdenite, situate in the United Kingdom, shall within fourteen days from the date hereof and once in every week thereafter make to the Controller, on and in accordance with the form prescribed by the Controller, a return showing particulars of his weekly output and deliveries of tungsten ore concentrates and stocks on hand at the end of each week.

(3) Every merchant, importer or broker who receives consignments from outside the United Kingdom of tungsten-bearing ores and/or molybdenite ores shall within fourteen days from the date hereof and once in every week thereafter make to the Controller, on and in accordance with the form prescribed by the Controller, a return showing all shipments afloat and all parcels landed or in warehouse during the seven days preceding the day of the return.

(4) Every person, firm or company who treats any ore to which this Order applies or manufactures any material or article therefrom, shall within fourteen days from the date hereof and once in every week thereafter make to the Controller on and in accordance with the form prescribed by the Controller a return showing stock in hand, receipts and consumption of such ore and stock in hand, output and deliveries of manufactures from such ore.

(5) Every person, firm or company who in any manufacture used tungsten, or molybdenum metal or any alloy thereof shall on the 1st December, 1917, and thereafter on the first day of every calendar month make to the Controller a return on and in accordance with the form prescribed by the Controller, showing the quantity of tungsten or molybdenum metal or alloy thereof received by him from the producer, the quantity consumed by him in such manufacture during the preceding month and the stock in hand at the end of the said month.

(6) Notwithstanding the above no return is required from any person whose total stock in hand and not intended to be used in connection with the manufacture or alloy of steel or other metal, has not during the period for which a return would but for this exception have been required exceeded in the case of—

Tungsten Ore Concentrates (not exceeding 50 per cent. WO_3 or its equivalent), 1 cwt.

Molybdenite (not exceeding 50 per cent. MoS_2 or its equivalent), 1 cwt.

Tungsten and/or Molybdenum Salts, 28 lbs.

Tungsten and/or Molybdenum metal or alloys thereof, 14 lbs.

3. Every return made by any person for the purpose of this Order shall be signed by such person, or, if the return is made on behalf of a firm or company, shall be signed by a partner, director, manager or other responsible official, and every statement contained therein shall be true and accurate.

4. Applications for permits under this Order shall be made to:—The Controller of Non-Ferrous Materials Supply, A.M.2/K., Ministry of Munitions, 8, Northumberland Avenue, W.C. 2.

5. This Order may be cited as the Tungsten and Molybdenite Order, 1917.

Explanatory Note.

As from the date of the above Order it is an offence under the Defence of the Realm Regulations, for any person, except as authorized by a permit issued under such Order, to buy, sell or deal in, or offer or invite an offer, or propose to buy, sell or deal in, or enter into negotiations for the sale or purchase of or other dealing in any of the war material to which the Order relates.

Permits under the above Order will be issued on conditions which will from time to time be stated by the Controller and which will be endorsed on the permit. The prescribed forms for returns may be obtained on application to the Controller.

All ore to which the above Order applies imported into the United Kingdom will be taken possession of by the Minister of Munitions and at a price which will be notified from time to time by the Minister of Munitions.

Ores to which the above Order applies imported into the United Kingdom under a contract made before the 1st September, 1915, will be released by the Minister of Munitions for delivery in pursuance of such contract, but only for delivery to a consumer for manufacture in his own works and in no case for re-sale.

All other ores must be dealt with as directed by the Controller. Ores ready for delivery will be sampled and assayed by analysts appointed or approved by the Minister of Munitions.

Directions as to delivery and shipment will be given through the official brokers.

All ores of which possession is taken by the Minister of Munitions will be distributed through the official brokers, who will distribute parcels to authorised manufacturers of tungsten products.

The Minister of Munitions will from time to time fix the maximum prices at which ores and products to which the above Order applies may be bought and/or sold. Permits to sell for export will be granted only to manufacturers or producers for sale to a consumer at a price approved by the Controller.

Application for permits to export to Allied Countries must be made through La Commission Internationale de Ravitaillement.

No application for a permit to purchase will be considered unless the applicant states in detail:—

(a) The class and quantity of material it is proposed to purchase.

(b) The use to which the material is to be put.

(c) The period for which the supply will suffice.

(d) The name of the manufacturer by whom the material is to be supplied.

ARMY COUNCIL ORDER.

WOMEN'S BOOTS: HEIGHT OF UPPERS.

In pursuance of the powers conferred upon them by the Defence of the Realm Regulations and of every other power thereunto enabling them, the Army Council hereby require all persons engaged in the manufacture or sale of boots to comply with the following regulations, that is to say:—

1. No person shall, without a permit issued by or on behalf of the Director of Raw Materials, cut or cause to be cut from leather or from any other material whatsoever at any time after 1st January, 1918, any uppers capable of making boots for women with uppers exceeding 7" in height, if of leather, or 8" in height, if of any other material, from the seat of the heel to the highest point of the top of the upper, whether in pursuance of any contract entered into at any date prior to the date hereof or otherwise.

2. No person shall, without a permit issued by or on behalf of the Director of Raw Materials, purchase or sell, or offer to purchase or sell, at any time after 1st February, 1918, any boots for women with uppers exceeding 7" in height, if of leather, or 8" in height, if of any other material.

All vessels bound to or from Falmouth harbour must pass between the above light-buoys and maintain a course 0° (*N. 17° E. Mag.*) and 180° (*S. 17° W. Mag.*), respectively, for a distance of a quarter of a mile from the light-buoys.

Vessels approaching from the eastward, after passing the meridian of Penare head, must keep to the southward of the parallel of lat. $50^{\circ} 03'$ N. before attempting to pass through the gateway.

Any instructions given by the patrol vessels should be strictly observed. Vessels proceeding eastward must obtain instructions as to the route to be followed before attempting to leave the anchorage.

Inward-bound vessels will have priority over outward-bound vessels in respect of passage through the gateway. Vessels entering Falmouth harbour must close the Drifter, sta-

tioned about half a mile to the southward of the two light-buoys defining the gateway.

This Drifter regulates inward-bound and outward-bound traffic. When no signals are exhibited by day or night by this Drifter, inward-bound traffic may proceed to pass through the gateway.

To indicate that the gateway is clear for outward-bound vessels, the Drifter will display by day a black shape and by night two horizontal white lights.

During fog three long blasts on the steam whistle, repeated at intervals of five minutes, will indicate that the gateway is clear for outward bound traffic.

Vessels approaching Falmouth in foggy weather should be careful to sound the regulation fog-signal and to proceed with great caution when within a depth of 30 fathoms at all states of the tide.

When the gateway is clear for inward-bound traffic, no outward-bound vessel may approach within half a mile of the gateway; and when the signals indicate that outward-bound traffic may pass through the gateway, no inward-bound vessels may approach within half a mile of the gateway.

During the hours of darkness all vessels entering or leaving Falmouth harbour must exhibit their side-lights.

(2) *Penzance Bay—Light-Buoys established; Traffic Regulations.*

Two light-buoys have been established to mark a gateway in the approach to Penzance bay, as follows:—

(a) Eastern light-buoy:

Position.—At a distance of $14\frac{1}{2}$ cables, 103° (S. 60° E. Mag.), from St. Paul church.

Lat. $50^{\circ} 05' N.$, long. $5^{\circ} 30\frac{1}{2}' W.$

Description.—A conical light-buoy, painted red, exhibiting a *flashing green light every five seconds.*

(b) Western light-buoy:

Position.—At a distance of approximately 600 feet, 270° (N. 73° W. Mag.), from the eastern light-buoy (a).

Description.—A can light-buoy, painted in red and white chequers, exhibiting an *occulating red light every ten seconds.*

All vessels bound to or from Penzance bay must pass between the above light-buoys and maintain a course 0° (N. 17° E. Mag.) and 180° (S. 17° W. Mag.), respectively, for a distance of a quarter of a mile from the light-buoys.

Vessels approaching from the eastward must keep to the southward of the parallel of lat. $50^{\circ} 02' N.$, until reaching a position about 3 miles southward of the gateway, which should then be steered for. Any instructions given by the patrol vessels should be strictly observed.

Inward-bound vessels will have priority over outward-bound vessels in respect of passage through the gateway. Vessels entering Penzance Bay must close the Drifter, stationed about half a mile to the southward of the two light-buoys defining the gateway.

This Drifter regulates inward-bound and

outward-bound traffic. When no signals are exhibited by day or night by this Drifter, inward-bound traffic may proceed to pass through the gateway.

To indicate that the gateway is clear for outward-bound vessels, the Drifter will display by day a black shape and by night two horizontal white lights.

During fog three long blasts on the steam whistle, repeated at intervals of five minutes, will indicate that the gateway is clear for outward-bound traffic.

Vessels making Mounts bay in foggy weather should be careful to sound the regulation signal and to proceed with great caution when within a depth of 25 fathoms at all states of the tide.

When the gateway is clear for inward-bound traffic, no outward-bound vessel may approach within half a mile of the gateway; and when the signals indicate that outward-bound traffic may pass through the gateway, no inward-bound vessel may approach within half a mile of the gateway.

During the hours of darkness, all vessels entering or leaving Penzance bay must exhibit their side-lights.

Before attempting to leave Penzance bay, outward-bound vessels must obtain instructions as to the route to be followed.

Notice is hereby given that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force:—

(1) *Pentland and Moray Firths—Restriction of Traffic; Pilotage Regulations.*

The following regulations have been made with a view to safeguarding the interests of shipping in the Pentland and Moray firths:—

I.—RESTRICTION OF TRAFFIC.

1. No vessel, either British, Allied or Neutral, is to be in the shaded area indicated on the accompanying portion of Admiralty Chart No. 2, from half an hour after sunset to half an hour before sunrise, unless at anchor. No vessel, however, is to anchor:—

(a) Anywhere along the coast between Tarbet Ness and North Sutor, except within one mile radius of Balintore;

(b) Anywhere off the south shore of the Moray firth between the meridians of Port Gordon and Burghead, except within three-quarters of a mile of the low-water mark;

(c) Outside a distance of one mile of the coast in any other portion of the shaded area.

2. Vessels proceeding to ports in the Moray firth should therefore endeavour to enter the firth in time to reach their destinations not later than half an hour after sunset. Should they not reach their destination by that time they are to anchor, weather permitting, subject to the restrictions given in clause 1.

3. Any vessel contravening the foregoing regulations will run the gravest risk of being sunk.

Caution.—Neutral or Allied vessels are particularly warned that the passage through the Pentland firth presents very grave risks to a Westbound vessel and are strongly advised not to take it.

II.—PILOTAGE REGULATIONS.

1. Pilotage is compulsory at the ports of Cromarty and Inverness for all vessels (including fishing vessels) which have a draught of over eight feet, and it is highly dangerous for any vessel to enter or leave without a pilot. Fishing and other small vessels having a draught of over eight feet are to assemble at

the Pilotage stations, and will be conducted into and out of port in groups.

Vessels bound for Cromarty and Inverness will be led through the defences from a position off Tarbet ness by a pilot boat. They should follow directly astern of her.

Local arrangements for leading vessels through the defences will be made for vessels leaving Cromarty or Inverness.

2. It is dangerous for any vessel to be under way to the south-westward of a line joining Tarbet ness and Findhorn without a pilot.

3. No vessels of any description other than H.M. Ships and Auxiliaries are to be under way between sunset and sunrise in the waters contained between a line drawn from Tarbet ness to Findhorn, and a line drawn from Fort George to Chanonry point.

(2) Orkney Isles—Traffic Regulations.

I.—SCAPA FLOW AND APPROACHES.

1. All entrances are dangerous, and entry is absolutely prohibited by any of them except as provided in succeeding paragraphs.

2. Examination services have been established in the entrances to Hoxa and Hoy sounds; vessels directed to enter must communicate with the Examination vessel and follow the instructions received from her very carefully.

3. No vessel is permitted to approach the entrance to Hoxa sound within a radius of 5 miles under any circumstances whatever, except when actually ordered to Scapa Flow.

4. The only vessels permitted to enter Hoy sound from the westward are those ordered to Stromness.

5. Vessels are not permitted to enter Hoxa or Hoy sounds by night or in thick weather.

6. Passage through Cantick sound is entirely prohibited.

II.—PORT OF KIRK WALL AND APPROACHES.

1. The Port of Kirkwall shall comprise all enclosed waters of the Wide Firth and Kirkwall bay to westward of Thieves holm.

2. Merchant vessels shall obey all orders given them by the Admiralty Port Officer as regards anchoring or shifting position.

3. No vessel other than H.M. Ships shall enter or leave the Port of Kirkwall during hours of darkness, *i.e.*, between half an hour after sunset and half an hour before sunrise, except in special circumstances with special permission from the Admiralty Port Officer.

4. During foggy and thick weather, traffic in and out of the port is stopped, and no vessel shall approach the boom from either direction.

5. No vessel other than H.M. Ships or boat shall move in the harbour during hours of darkness as aforesaid. And no boat other than those belonging to H.M. Ships shall approach the shore or go alongside any pier in the Port of Kirkwall.

6. All vessels other than H.M. Ships entering or leaving the Port of Kirkwall shall be

piloted in and out by a Pilot drifter, and are prohibited from entering or leaving harbour unless so piloted, save and except only (1) in the case of such British vessels as have a written exemption therefrom, issued by the Admiralty Port Officer, (2) when a liner is entering the harbour. the Pilot may at his discretion, when circumstances of tide and sea render it advisable, direct such liner to enter the harbour without being piloted, provided always that the gate be open for incoming traffic.

7. Vessels, when cleared, shall wait for the Pilot vessel to conduct them out of port, or proceed as directed by the Naval Authorities.

8. Drifters engaged on pilot duty will fly the pilot flag (white and red, horizontal).

9. Incoming and outgoing traffic will be regulated by signals hoisted at the yardarm of the Boom trawler and repeated at the Hellier holm lighthouse.

10. Traffic signals are to be strictly obeyed, and no vessel shall approach the entrance against the signal.

11. The following Traffic signals will be displayed at the Boom and at Hellier holm:—

Gate "Open for Incoming Traffic":

By day—Two balls, vertical.

By night—A red light.

Gate "Open for Outgoing Traffic":

By day.—A cone, point upwards.

By night—A green light.

Gate Closed:

By day—Three balls at Hellier holm.

By night—Three red lights at Hellier holm.

12. Vessels entering will, as a rule, be given priority over those leaving.

13. All outgoing vessels shall pass round the Turning buoy (red and white striped, spherical) moored approximately 285° (*N. 56° W. Mag.*), one mile from the entrance.

14. Incoming vessels will not pass round the Turning buoy, but will shape course as requisite for the anchorage on entering.

15. No outgoing vessel shall pass the Turning buoy, unless the signal for outgoing traffic is up. If the signal is against it, such vessel shall stop and wait in the neighbourhood of the Turning buoy.

16. No incoming vessel shall pass Hellier holm, unless the signal for incoming traffic is up at Hellier holm. If the signal is against it, such vessel shall wait in Shapinsay sound.

17. Incoming and outgoing vessels shall not pass through the gate simultaneously. If, through any misunderstanding, an outgoing and an incoming ship are approaching the gate simultaneously, then the outgoing ship shall give way, and shall turn round, and return to the Turning buoy and there wait till such time as the entrance is clear.

18. As a rule only one ship will be conducted out at a time, but under exceptional circumstances, in the event of two ships being conducted out, then the pilot will give instructions as to which ship is to go first and the rear ship shall then keep a full half mile directly astern,

and is on no account to close or overhaul or attempt to pass the ship ahead.

19. *Caution.*—Caution is necessary when approaching the boom, as the tidal stream does not set fairly through the opening and attains considerable velocity especially on the ebb or west-going stream, which sets in a north-westerly direction.

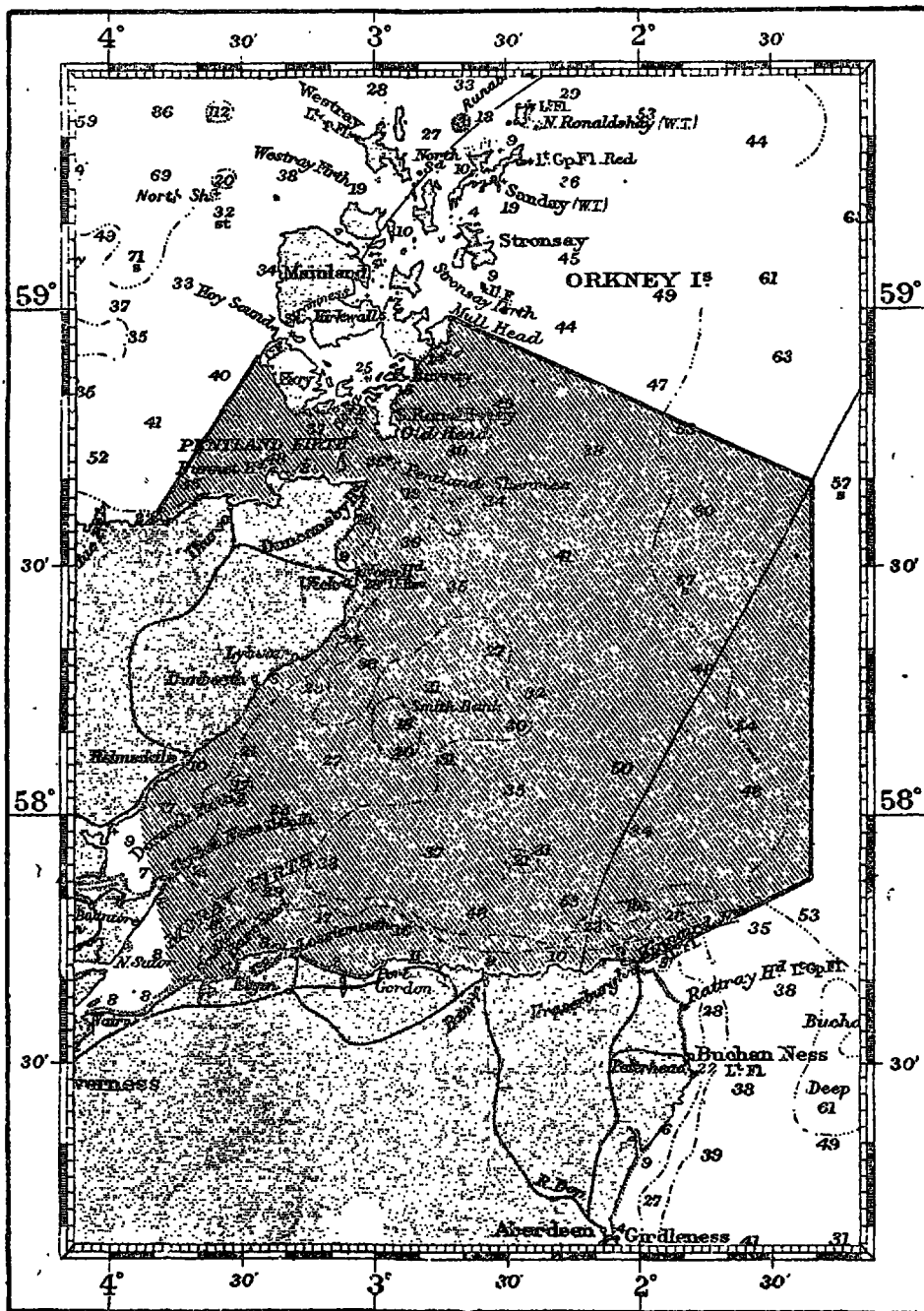
