

Japan (Consular and Marriage Fees) Order in Council, 1906"—

"83k. On the release of goods by a Consular Officer under the British Re-export Scheme (Switzerland):—

"(a.) Tissues for dyeing, mercerising, bleaching, &c., at the rate of quarter of 1 per cent. of the import value.

"(b.) Handkerchiefs for embroidery at the rate of 1 centime per dozen."

3. In all copies of the Orders in Council referred to in the preceding articles which may be printed after the commencement of this Order, the fee directed by this Order to be added to the tables of fees annexed to the said Orders shall be added thereto.

4. This Order shall come into operation on the 1st day of February, 1918.

And the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein.

The KING's Most Excellent Majesty in Council.

WHEREAS it is enacted by Section 60 of "The Supreme Court of Judicature Act, 1873," that it shall be lawful for His Majesty, by Order in Council, from time to time to direct that there shall be District Registrars of the High Court in such Places as shall be in such Order mentioned for Districts to be thereby defined, and for the purposes in the said Section referred to, and that His Majesty may thereby appoint that any Person in the said Section referred to shall and may be a District Registrar of the High Court for the said purposes:

And whereas Her late Majesty Queen Victoria was pleased, by Her Order in Council of the 19th day of May, 1899, to order that there should be a District Registry of the said High Court at (among other places) *Pembroke Dock*, and that the District of the said District Registry should be the Court District of the County Court of *Pembroke* held at *Pembroke Dock*:

Now, therefore, His Majesty, by virtue and in exercise of the powers in that behalf by the Supreme Court of Judicature Act, 1873, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. As from and after the date of this Order coming into effect the said District Registry at *Pembroke Dock* shall cease to exist, and there shall be a District Registrar of the High Court

in the Town and County of *Haverfordwest*, and the Registrar of the County Court of *Pembrokeshire* holden at *Haverfordwest* shall be, and he is hereby, appointed such District Registrar, and the District shall be the District for the time being of the County Court of *Pembrokeshire* holden at *Haverfordwest*, *Pembroke Dock* and *Narberth*.

2. This Order in Council shall take effect from the 1st day of February, 1918, and may be cited as "The District Registries (*Haverfordwest*) Order in Council, 1918."

WHEREAS Her late Majesty Queen Victoria was pleased, by "The County Courts (Admiralty Jurisdiction) Order in Council, 1899," to order that certain County Courts should have Admiralty Jurisdiction:

And whereas a Representation has been made by the Lord Chancellor stating that it is expedient to amend the said Order:

Now, therefore, His Majesty, by virtue and in exercise of the powers in that behalf by the County Courts Admiralty Jurisdiction Act, 1868, or otherwise in His Majesty vested, having taken the said Representation into consideration, is pleased, by and with the advice of His Privy Council, to order and appoint, and it is hereby ordered and appointed, as follows:—

1. This Order may be cited as "The County Courts (Admiralty Jurisdiction) Order in Council, 1918."

2. The County Court of *Pembrokeshire* held at *Pembroke Dock* shall cease to have Admiralty Jurisdiction, and such Jurisdiction shall be transferred to the County Court mentioned in the First Column of the Schedule hereto annexed.

3. The Districts of the County Courts, the names of which are printed in the Second Column of the Schedule hereto annexed, are hereby assigned to the Court which is hereby appointed to have Admiralty Jurisdiction as the District for Admiralty Purposes.

4. The First Schedule annexed to "The County Courts (Admiralty Jurisdiction) Order in Council, 1899," shall be read with the substitution of the Schedule annexed to this Order for so much of the Schedule annexed to the County Courts (Admiralty Jurisdiction) Order in Council, 1899, as applies to the Court Districts mentioned in the Second Column of the Schedule hereto annexed.

5. This Order shall come into operation on the 1st day of February, 1918.
