In the Matter of the ENGLISH AND AUSTRALIAN COPPER COMPANY Limited and Reduced, and in the Matter of the Companies (Consolidation) Act, 1908.

NOTICE is hereby given, that the Order of the High Court of Justice, Chancery Division, dated the 15th day of January, 1918, confirming the reduction of the capital of the above named Company from £105,000 to £35,000, and the Minute approved by the Court showing with respect to the capital of the Company as altered the several particulars required by the above statutes, was registered by the Registrar of Companies on the 5th day of February, 1918. The said Minute is in the words and figures following:—
