DEFENCE OF THE REALM REGULATIONS.

Whereas under Regulation No. 29B of the Defence of the Realm Regulations, the Army Council, with the concurrence of a Secretary of State, may, from time to time, by Order, deelare any area to be a Special Military Area for the purposes of the said Regulations.
