## ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 13th March, 1918.)

Whereas by the 21st Section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Subdistricts:

- 1. And where is it is expedient that Shoreditch Registration District should be re-divided into two Sub-districts to be constituted with due regard to the Wards of the Metropolitan Borough of Shoreditch, as follows:
  - (a) A Sub-district to be called and known as Shoreditch South-West Sub-district, and to consist of Moorfields, Church, Hoxton, and Wenlock Wards, and

(b) A Sub-district to be called and known as Shoreditch North-East Sub-district, and to consist of Whitmore, Kingsland, Haggerston, and Acton Wards;

Now, therefore, I, Sir Bernard Mallet, K.C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect

3.. This Order shall come into operation on the first day of April, Nineteen hundred and

eighteen.
