that, whenever any Archdeacon who may be entitled to receive the said yearly sum of £200 shall resign or otherwise avoid his Archdeaconry, such yearly sum shall be apportionable between such Archdeacon or his Representatives (as the case may be) and the Archdeacon who shall next be collated to the same Archdeaconry.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending or proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas Notices of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Archdeacons affected by the Scheme, that is to say, the Archdeacon of Barnstaple and the Archdeacon of Totnes, and they have severally expressed their approval of the same:

And whereas the said Scheme has been ap-

proved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Exeter.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 14th day of February, 1918, in the words and figures following, that

is to say:—
"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of West Pinchbeck, in the County of Lincoln, and in the Diocese of Lincoln:

"Whereas by the authority of an Order of Her said late Majesty in Council, bearing date the 7th day of March, 1851, and published in the London Gazette on the 11th day of the same month, a District Chapelry was assigned to the Consecrated Church of Saint Bartholomew, situate at West Pinchbeck, in the Parish of

Pinchbeck, in the said County and Diocese, and the said District Chapelry was named 'The District Chapelry of West Pinchbeck':

"And whereas the said District Chapelry of West Pinchbeck has, under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become a New Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us,

and it appears to us to be expedient, that the boundaries of the said New Parish of West Pinchbeck should be altered in the manner

which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend Edward Lee, Bishop of Lincoln, (in testimony whereof he signed and sealed this Scheme or presentation), we, the said Ecclesiastical Commissioners, humbly represent, mend, and propose, that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of West Pinchbeck shall be altered so that all those portions of the Parish of Spalding, of the Parish of Cowbit, both in the said County and Diocese, and of the said Parish of Pinchbeck, which are described in the Schedule hereunder written, and are delineated and set forth upon the Map or Plan hereunto appended, and are thereon coloured pink, shall be dissevered from such Parishes, and shall be annexed to and shall in future form part of the said New Parish of West Pinchbeck.

"And we further represent, recommend, and propose, that nothing herein contained shall prevent us from representing, recommending, or proposing, any other measures re-lating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of

any other Act of Parliament.

"All which we humbly represent, recommend, and propose, to Your Majesty in Council.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the New Parish of West Pinchbeck, in the County of Lincoln, and in the Diocese of Lincoln,

"1. All those detached portions of the Parish of Spalding, and of the Parish of Cowbit, both in the said County and Diocese. which, taken together, are bounded upon all sides as follows, that is to say: —upon the north, upon the east, and upon part of the south-east, by the said New Parish of West Pinchbeck, upon the remaining part of the south-east partly by an isolated portion of the Parish of Pinchbeck and partly by the Particular District of Saint Nicholas, Deeping Fen, both in the said County and Diocese, and upon the west partly by the Parish of Bourne, partly by the Parish of Morton, partly by the Parish of Hacconby, partly by the Parish of Dunsby, and partly by the Parish of Rippingale, all in the said County and Diocese.

"2. And also all that isolated portion of the said Parish of Pinchbeck which is bounded
