Saint Thomas, Wincobank, and the said New Parish of Brightside all meet, and extending thence, first south-westward along the middle of the old course of the River Don, and then first south-westward, and then southward, along the middle of the River Don (thereby following in part the boundary which divides the said New Parish of Saint Thomas, Wincobank, from the said New Parish of Brightside) for a distance in all of 41 chains or thereabouts to the centre of Brightside Bridge which carries Weedon Street across the River Don at which point the said imaginary line commenced."

And whereas Drafts of the said Scheme have, in accordance with the provisions of the firstly herein-before mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Sheffield.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 7th day of March, 1918, in the words and figures following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Saint Helen, Whitley, in the County of Northumberland, and in the Diocese of Newcastle:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Helen, Whitley, is vested for an estate in fee simple, in possession, free from incumbrances, in the Right Honourable Wentworth Canning Blackett, Viscount Allendale, (hereinafter called 'the said Lord Allendale'):

"And whereas the said Lord Allendale is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said benefice of Saint Helen, Whitley, now vested in him as aforesaid, should be transferred to and be vested in the Right Reverend Herbert Louis, now Bishop of Newcastle, and

his Successors in the same Bishopric:

"And whereas the said Herbert Louis, Bishop of Newcastle, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said Herbert Louis, Bishop of Newcastle, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Saint Helen, Whitley, which is hereinbefore mentioned, and hereinafter recommended and proposed, will, in our opinion, tend to make better provision for the Cure of Souls in the Parish or District in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say, in the Consolidated Chapelry or New

Parish of Saint Helen, Whitley:

"Now, therefore, with the consent of the said Lord Allendale (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Herbert Louis, Bishop of Newcastle, (in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), We, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Helen, Whitley, now vested in him, the said Lord Allendale, as aforesaid, shall be transferred to the said Herbert Louis, Bishop of Newcastle, and his Successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Herbert Louis, Bishop of Newcastle, and his Successors in the same Bishopric for ever.

And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them.
