## ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 27th April, 1918.)

Whereas by the 21st Section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-districts:—

1. And whereas it is expedient, in order that the county borough and parish of Blackpool may be wholly included within one Registration Sub-district, that the part of that county borough and parish, which, prior to the 1st instant, the date when the Blackpool Improvement Act. 1917, took effect, formed part of Carleton Civil Parish, should be transferred from Fleetwood Sub-district of Fylde Registra-

tion District to Blackpool Sub-district of the same Registration District.

- 2. Now, therefore, I, Sir Bernard Mallet, K.C.B., Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.
- 3. This Order shall come into operation on the first day of May, nineteen hundred and eighteen.
