ARMY COUNCIL ORDER.

THE SEA ISLAND COTTON ORDER, 1918.

In pursuance of the powers conferred upon them by the Defence of the Realm Regulations, the Army Council hereby order as follows:—

1. No person shall, without a permit issued by or on behalf of the Director of Raw Materials, purchase, sell or make or take delivery of or payment for any West Indian Sea Island or Carolina Sea Island Cotton, or any Article wholly or partly manufactured therefrom.
