His Majesty the KING has been graciously pleased to confer the Distinguished Flying Cross on the undermentioned Officers of the Royal Air Force:—

Lieutenant Edward Eric Turner.

Whilst piloting his machine during a hostile air raid he displayed great determination and skill in manœuvring at a height of 11,000 feet under heavy enemy fire, which enabled his Observer to bring effective fire on an enemy aeroplane, resulting in its being driven to the ground.

Lieutenant Henry Balfour Barwise.

Whilst acting as Observer to Lieutenant E. E. Turner on patrol duty, during a hostile air raid, he showed great courage and ability. Although exposed to severe fire from the enemy he took prompt advantage of the skilful piloting of his machine, which enabled him to bring effective fire on his antagonist, as a result of which the enemy aeroplane was badly damaged and forced to land.
