Provision for Movement through Area by Road.

2. For the purposes of the Principal Order and this Order, sheep shall not be deemed to be moved out of the Area described in the Schedule hereto, where they are moved through the Area from a place outside the Area to another place outside the Area by the main road from Blair Atholl via Pitlochry to Dunkeld.

Commencement.

3. This Order shall come into operation on the first day of August, nineteen hundred and eighteen.

CORN PRODUCTION ACT, 1917. AGRICULTURAL WAGES BOARD (ENGLAND AND WALES).

PROPOSAL TO FIX RATES OF WAGES FOR SHEP-HERDS, STOCKMEN, WAGGONERS AND MILKMEN IN NORTHAMPTONSHIRE.

The Agricultural Wages Board (England and Wales), duly established and constituted under Section 5 (1) of the above Act, and the Regulations made by the Board of Agriculture and Fisheries, dated the 8th November, 1917, having had regard to the provisions of subsections (6) and (7) of the said Section, hereby give Notice as required by subsection 4 of the said Section, and by paragraph 4 of the Agricultural Wages Regulations, 1918, that they propose to make the following Order:—

1. The rates of wages fixed by the Board as applicable to employment in the area comprising the administrative counties of Northampton and Soke of Peterborough, and the county borough of Northampton, as set out in the Orders of the Board dated the 16th May and the 2nd July, 1918, shall not apply to any workman employed in the said area wholly or mainly as a Shepherd, Stockman, or Waggoner, or as a Milkman who syste-

matically works overtime in connection with the feeding and milking of cows.

- 2. The wages payable for employment of any male workman of 18 years of age and over employed in the said area wholly or mainly as a Shepherd, Stockman, or Waggoner, or as a Milkman who systematically works overtime in connection with the feeding and milking of cows, shall be not less than wages at the rate of 36s. for a week consisting of the hours of employment, whether on weekdays or on Sunday, customary in the said area in the case of a workman so employed.
- 3. The differential rates for overtime in the case of employment of any workman to whom this Notice applies shall be as follows, that is to say:
 - (a) In respect of overtime employment on weekdays, $8\frac{1}{2}$ d. per hour.
 - (b) In respect of overtime employment on a Sunday, 10d. per hour.
- 4. For the purpose of the application of the above rates all employment in excess of the hours of employment customary in the area in the case of a Shepherd, Stockman, or Waggoner, or as a Milkman who systematically works overtime in connection with the feeding or milking of cows, as the case may be, is hereby defined to be overtime employment.
- 5. For the purpose of the above rates the hours of work shall not include meal times, but shall include any time during which by reason of weather conditions an employer has prevented from working a workman who was present at the place of employment and ready to work.

The Agricultural Wages Board, as required by Section 5 (4) of the above Act, and by paragraph 4 of the above-mentioned Regulations will consider any objections to the above proposed Order which may be lodged with them within one month from the date of this Notice. All objections should be in writing, and should be addressed to the Secretary, the Agricultural Wages Board (England and Wales), 80, Pall Mall, London, S.W.1. The objections should state precisely, and so far as possible with reasons, what is objected to.
