#### TRADE BOARDS ACT, 1909.

##### TIN BOX AND CANISTER TRADE (GREAT BRITAIN).

In accordance with Regulations made under Section 18 of the above Act, by the Board of Trade, and dated 27th April, 1910, the Trade Board established under the above Act and the Trade Boards Provisional Orders Confirmation Act, 1913, for the Tin Box and Canister Trade in Great Britain as defined in the Regulations made by the Board of Trade and dated the 12th June, 1914, hereby give notice that they propose to vary certain minimum time rates of wages for female and male workers at present fixed as follows:—

##### A.—Female Workers.

1. For Female Workers of 18 years of age

and upwards (and others to whose employment the minimum rate of 19s. 6d. per week is applicable under the terms of paragraph A (a) and (b) of Section I. of Schedule I. of their Notice dated the 8th October, 1917), from 19s. 6d. to 23s. 10d. per week.

2. For Female Workers of 18 years of age and upwards who have been employed in the trade for an aggregate period of less than 12 months and who cannot suitably be employed on piece-work, from 16s. to 19s. 6d. per week.

3. For Female Workers of 17 and under 18 years of age, from 16s. to 19s. 6d. per week.

4. For Female Workers of 16 and under 17 years of age, from 13s. to 15s. 9d. per week.

5. For Female Workers of 15 and under 16 years of age, from 10s. to 12s. 3d. per week.

6. For Female Workers under 15 years of age, from 7s. to 8s. 6d. per week.

##### B.—Male Workers.

1. For Male Workers of 22 years of age and upwards (and those to whose employment the minimum rate of 34s. 8d. per week is applicable under the terms of paragraph B (a) of Section I. of Schedule I. of their Notice dated the 8th October, 1917), from 34s. 8d. to 39s. per week.

2. For Male Workers of 21 and under 22 years of age, from 30s. 6d. to 34s. 3d. per week.

3. For Male Workers of 21 years of age and upwards who have been employed in the trade for an aggregate period of less than 12 months and who cannot suitably be employed on piece-work, from 28s. to 31s. 6d. per week.

4. For Male Workers of 20 and under 21 years of age, from 26s. 6d. to 29s. 9d. per week.

5. For Male Workers of 19 and under 20 years of age, from 23s. to 25s. 9d. per week.

6. For Males Workers of 18 and under 19 years of age, from 19s. 6d. to 22s. per week.

7. For Male Workers of 17 and under 18 years of age, from 16s. to 18s. per week.

8. For Male Workers of 16 and under 17 years of age, from 13s. to 14s. 6d. per week.

9. For Male Workers of 15 and under 16 years of age, from 10s. to 11s. 3d. per week.

10. For Male Workers under 15 years of age, from 7s. to 7s. 9d. per week.

The Notice setting out the proposals is dated 27th July, 1918, and objections may be lodged within three months from 29th July, 1918.

#### TRADE BOARDS ACT, 1909. PAPER BOX TRADE BOARD (GREAT BRITAIN).
