In virtue of the powers conferred upon me by paragraph 2 of Regulation 14c of the Defence of the Realm Regulations, I hereby order that the ports at which persons proceeding as passengers from Great Britain to Ireland shall embark and the routes by which they may travel shall be those specified in the Schedule to this Order, hereinafter referred to as the authorised ports and routes, and no person proceeding as a passenger as aforesaid shall embark except at an authorised port or travel by other than an authorised route:
