At the Council Chamber, Whitehall, the 20th day of September, 1918.

By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, and amended on the 16th day of January, 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the lastmentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 61A) consolidating all previous Lists, up to and including that of the 9th August, 1918, together with List 62 of 23rd August, and List 63 of 6th September, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

Note (2).—Where a person or firm mentioned in the List has more than one address in the country or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

Note (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Nore (4).—In order to minimise as far as possible any inconvenience which may be caused to the British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter The Department is, however, preabroad. pared on Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of tele-graphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making enquiries would specify the particular trade or trades for which substitutes are required. General enguiries for connectionsabroad newshould be addressed to The Comptroller General, Department of Overseas Trade (Development and Intelligence), 73, Basinghall Street, London, E.C. 2.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

Note (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms, such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatchappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

1. No sale of Flax Seed for sowing shall, without a permit issued by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, be made by a wholesale dealer to a wholesale dealer, by a retail dealer to a retail dealer, or by a farmer to a retail or wholesale dealer.

2. No wholesale dealer shall sell or deliver any Flax Seed for sowing to a retail dealer at a price exceeding the actual cost price of such seed to the said wholesale dealer by more than 7s. 6d. per bag of 189 lbs., together with the actual cost of transport and an allowance in respect of such actual and necessary charges as may be approved by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, provided that no allowance shall be made in respect of commission paid or payable to agents in Ireland.

3. No retail dealer shall sell or deliver any Flax Seed for sowing to a farmer at a price exceeding the actual cost price of such seed to the said retail dealer by more than 10s. per bag of 189 lbs., together with the actual cost of transport, as may be approved by or on behalf of the Department of Agriculture and Technical Instruction for Ireland.

4. Every retail dealer shall, so long as he shall have any Flax Seed for sowing on sale, display prominently at the shop or other place of sale a statement or statements showing the prices at which he is selling such Flax Seed at such shop or place, and when he is selling such Flax Seed at such shop or place, and when he is selling different lots of Flax Seed for sowing at different prices, the statement or statements shall be in such form or shall be so displayed as to show clearly which are the prices for each lot.

5. All persons engaged in any of the transactions herein referred to shall furnish such particulars as to his business as may be required by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, verified as may be directed by the said Department.

6. In this Order the expression "Flax Seed for sowing " shall mean such Flax Seed now or hereafter situated in or in course of transit to Ireland, and shall include all such Seed capable of being sown for fibre, and the ex-pressions "wholesale dealer," "retail dealer," and "farmer" shall mean any person carrying on business in Ireland as a wholesale dealer, retail dealer, or farmer, as the case may be.

7. This Order may be cited as the Sale of Flax Seed (Ireland) Order, 1918.

8. The Sale of Flax Seed (Ireland) Order, 1917, and the Flax Seed (Control) Notice, 1917, are hereby cancelled.

John Allan, Donkeyman, M.M.R., No. 942760.

The account of the services, in respect of which this medal has been conferred, is as follows : -

As the R.F.A. "Mixol " was dropping alongside to fuel one of H.M. Battle Cruisers on the 19th June, 1918, an Able Seaman slipped and fell overboard between "Mixol" and the Cruiser; "Mixol" was only about ten feet clear of the Cruiser, and was closing at the time.

Donkeyman John Allan, who was standing on the fore well deck of "Mixol," saw the man fall and that he was struggling in the water. Although it was clear that the man in the water was in imminent danger of being crushed between the two ships, Allan at once jumped overboard in the clothes he was wearing to save him. He assisted the Able Seaman to keep afloat until a rope was thrown, which he gave to him, the Able Seaman being hauled on board before Allan took the rope himself. The ship was in an open anchorage, and

the temperature of the water was 50°.

#### GENERAL ORDER OF THE LOCAL GOVERNMENT BOARD.

THE PUBLIC HEALTH (TUBERCULOSIS) REGULATIONS (No. 2), 1918.

To the Mayor, Aldermen, and Commons of the City of London, in Common Council assembled ;

- To the Councils of the several Metropolitan Boroughs, Municipal Boroughs, and other Urban Districts in England and Wales;-
- To the Councils of the several Rural Districts in England and Wales;-
- To all Medical Boards under the control of the Ministry of National Service ;--

And to all others whom it may concern.

Whereas by the Public Health (Tuberculosis) Regulations, 1912 (hereinafter referred to as "the Regulations of 1912"), as altered by the Public Health (Notification of Infec-tious Disease) Regulations, 1918, We, the Local Government Board, prescribed Regulations with a view to the treatment of persons affected with Tuberculosis, and for preventing the spread of the disease, and for the notification of the prescribed particulars of cases of the disease to the prescribed Medical Officers of Health:

Now, therefore, in the exercise of the powers conferred upon Us by the several Statutes in that behalf, We do by this Our Order alter the Regulations of 1912 and do make the following Regulations; that is to say,-

ARTICLE I.-Expressions in these Regulations, unless the contrary intention appears, have the same meaning as the like expressions have in the Regulations of 1912.

ARTICLE II.—The Regulations of 1912 as altered as aforesaid shall apply to the notification to the proper Medical Officer of Health by the Chairman of any National Service Medical Board, or by some member of the Medical Board designated by the Chairman, of every case of tuberculosis diagnosed by the Medical Board, in the same way as they apply to the notification by a Medical Practitioner in pursuance of Article V. of the Regulations of 1912:

Provided that the fee to be paid for each notification made in pursuance of this Article shall be one shilling, and that no fee shall be payable to any person who holds a commission in any of His Majesty's Forces and is receiving pay in respect thereof.

ARTICLE III.-This Order may be cited as the Public Health (Tuberculosis) Regulations (No. 2), 1918, and shall be in force during the continuation of the present War.

#### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 18TH SEPTEMBER 1918.)

#### CORNWALL AND DEVON (CONTROL OF DOGS) ORDER OF 1918 (No. 3).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, the Dogs Act, 1906, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:---

#### Provision for movement of Dogs out of Cornwall and Devon.

1. Notwithstanding the provisions of Article 1 of the Cornwall and Devon (Control of Dogs) Order of 1918 (hereinafter referred to as " the principal Order "), a dog may be moved out of the area comprising the administrative counties of 'Cornwall and Devon and the county boroughs of Exeter and Plymouth, if accompanied by a licence of the Board authorising such movement signed by an Officer of the Board, but subject to such conditions as to the detention and isolation of the dog or otherwise as the Board may think necessary or desirable and shall be specified in the licence.

#### Seizure of Dogs in case of Default.

2.—(1) If a dog has been moved in contravention of the principal Order or having been moved with a licence under this Order is not detained and isolated as required by the conditions of the licence, an Inspector of the Board may seize the dog, and thereupon the Board shall detain and isolate it at the place of detention specified in the licence (if any) or any other place of detention selected by them for such time as the Board think necessary or expedient.

(2) If the owner of the dog does not, within ten days after the expiration of the period of detention specified in the licence (if any) or such other period as the Board may think necessary or expedient and notify to the owner, claim the said dog from the Board and pay to them their expenses of detaining and isolating the dog, the Board may destroy or otherwise dispose of the dog as they think expedient.

#### Offences.

3.—(1) If a dog which is being moved or has been moved with a licence under this Order is not muzzled or confined or is not detained and isolated as required by the conditions of the licence, the owner of the dog, and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(2) If a person with a view unlawfully to evade or defeat the operation of the principal Order or this Order or of the conditions of a licence under this Order, allows a dog to stray, he shall be deemed guilty of an offence against the Act of 1894.

(3) If the owner or person in charge of a dog fails to give, produce, or do any notice, licence, or thing which by this Order, or by the conditions of a licence thereunder, he is required to give, produce, or do, he shall be deemed guilty of an offence against the Act of 1894.

#### Short Title, etc.

4. This Order may be cited as the Cornwall and Devon (Control of Dogs) Order of 1918 (No. 3), and shall be read with the principal Order.
