

then forced his way through the flames and kicked the hose overboard, getting his clothes ignited as he did so. Having extinguished his burning clothing by jumping overboard, he climbed inboard again and assisted in getting the motor launch in tow.

This man displayed initiative and disregard of danger, and by his prompt action he probably averted a serious accident. Had the depth charges detonated, very great damage would have been done and lives undoubtedly lost.
