By the Lords of His Majesty's Most Honourable Privy Council.

, No. 66.

HEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, subsection one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, and amended on the 16th day of January, 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last-mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 61a) consolidating all previous Lists, up to and including that of the 9th August, 1918, together with List No. 62 of 23rd August, List No. 63 of 6th September, List No. 64 of 20th September, List No. 65 of 4th October, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

Note (2).—Where a firm is mentioned in the List, every partner in the firm is also included in the List, and all dealings with any partner in the firm, as well as all dealings with the firm, are prohibited: and conversely, all dealings with a firm, any partner in which is mentioned in the List, are also prohibited.

Note (3).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

Note (4).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June, and 10th November, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia, or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Note (5).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. siderable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to enquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making enquiries would specify the particular trade or trades for which substitutes are required. General enquiries for new connections abroad should be addressed to The Comptroller General, Department of Overseas Trade (Development and Intelligence), 73, Basinghall Street, London, E.C. 2.

Note (6).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

Note (7).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

The KING has been pleased to award the Albert Medal in Gold in recognition of the gallantry of Sergeant David Emmitt Coyne, of the 31st Battalion, Australian Imperial Force, in saving life in France at the cost of his own life.

On the night of the 15th May, 1918, in order to test some Mills grenades, Sergeant Coyne threw one of them, but it failed to clear the parapet and fell into the trench in which there were a number of other men. Sergeant Coyne shouted to them to run for their lives, and endeavoured to find the bomb in order to throw it away, but owing to the darkness he was unable to lay his hand on it in time and, the men not being clear of the trench, he deliberately

threw himself on to the top of it and let it explode under him, receiving fatal injuries, but saving the lives of his comrades.

INSTRUCTION ISSUED BY THE ROAD TRANSPORT, BOARD PURSUANT TO PARAGRAPH 1 OF THE ROAD TRANSPORT (No. 2) ORDER, 1918.

Limitation of Road Transport Delivery by Retailer to Customer.

Where goods are delivered by a retailer to a customer by means of a vehicle to which Regulation 2JJJ\* of the Defence of the Realm Regulations applies, such delivery shall be limited to a place not exceeding 10 miles from the retailer's premises or place of business where the goods are loaded on to the vehicle; provided that any retailer whose premises or place of business are situated within the Metropolitan Police District or City Police District may deliver to the residence of any customer within either of these districts, notwithstanding that such delivery may exceed 10 miles in distance from such premises or place of business.

The limits of distance prescribed by this instruction will not apply where means of transport by rail or common carrier do not

exist.

This instruction shall take effect as from the 18th November, 1918.

#### ARMY COUNCIL ORDER.

REGULATION OF THE SALE AND USE OF Unthreshed Oats in Great Britain.

In pursuance of the powers conferred on them by the Defence of the Realm Regulations and all other powers them enabling, the Army Council hereby order that:-

1. Producers having in their possession un-threshed oats grown by them may use a reasonable quantity as feed for their own

- 2. Farmers desirous of purchasing unthreshed oats must make application to the D.P.O.S. of the county or district concerned for a licence to do so, stating the name and address of the producer from whom they desire to purchase the same and the quantity required. Such unthreshed oats must not be used for any purpose other than the consumption by stock in the purchaser's possession, and must not be re-sold.
- 3. The above are the only instances where the consumption of unthreshed oats is permissible outside possible Army requirements.

CORNWALL AND DEVON (CONTROL OF DOGS) ORDER OF 1918 (No. 6).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, the Dogs Act, 1906, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

#### PART I.

Prohibition of Movement of Dogs out of certain Areas.

1.-(1) No dog shall be moved:-

- (i.) out of the area comprising the administrative counties of Cornwall and Devon and the county boroughs of Exeter and Plymouth; or
- (ii.) out of the Scheduled District (No. I) described in the First Schedule hereto; unless it is accompanied by a licence of the Board authorising such movement signed by an Officer of the Board, and any such licence

Officer of the Board, and any such licence may be subject to such conditions as to the detention and isolation of the dog or otherwise as the Board may think necessary or desirable and shall be specified in the licence: Provided

that this Article shall not apply to:—

(a) the movement of a dog under a licence granted by the Board under the Importation of Dogs Order of 1914 to a port in Great Britain for shipment, or to a place of detention for the purpose of detention and isolation: or

.(b) the movement of a dog through the said area or District by railway from a place outside the area or District to another place outside the area or District without unnecessary delay and without being re-booked within the area or District.

Seizure of Dogs in case of Default.

- 2.—(1) If a dog has been moved in contravention of this Order or any Order hereby revoked or having been moved with a licence under any such Order is not detained and isolated as required by the conditions of the licence, an Inspector of the Board may seize the dog, and thereupon the Board shall detain and isolate it at the place of detention specified in the licence (if any) or any other place of detention selected by them for such time as the Board think necessary or expedient
- (2) If the owner of the dog does not, within ten days after the expiration of the period of detention specified in the licence (if any) or such other period as the Board may think necessary or expedient and notify to the owner, claim the said dog from the Board and pay to them their expenses of detaining and isolating the dog, the Board may destroy or otherwise dispose of the dog as they think expedient.

#### PART II

Control of Dogs in Scheduled District No. I.

- 3.—(1.) A dog in the Scheduled District-No. I described in the First Schedule heretoshall at all times—
  - (a) whilst in or on any public place be efficiently muzzled with an effective wire cage muzzle, and shall also, whilst in or on any such place in the Area described in the Second Schedule hereto, be led by a person with a collar and chain or other attachment;

(b) whilst in or on any other place, be kept under control by being

(i) confined in a kennel or other enclosure from which the dog cannot escape; or

(ii) secured to some premises by a collar and chain; or

(iii) efficiently muzzled with an effective wire cage muzzle; or

(iv) led by a person with a collar and chain or other attachment.

(2) The provisions of this Article shall not apply to any dog confined in a suitable hamper, crate, box, or other receptacle, so constructed as to render it impossible for such dog while so confined to bite any person or animal.

Control of Dogs in Scheduled District No. II.

- 4.—(1.) A dog in the District described in the Third Schedule hereto, herein referred to as the Scheduled District No. II., shall at all times—
  - (a) whilst in or on any public place be efficiently muzzled with an effective cage muzzle, made either of wire or of leather: Provided that until the fifteenth day of November, nineteen hundred and eighteen, a dog in or on any such place in Scheduled District No. II need not be muzzled if it is led by a person with a collar and chain or other attachment;

(b) whilst in or on any other place, bekept under control by being—

(i) confined in a kennel or other enclo sure from which the dog cannot escape; or(ii) secured to some premises by a collar

and chain; or

(iii) efficiently muzzled with an effective cage muzzle, made either of wire or of leather; or

- (iv) accompanied by the owner or some person deputed by him and under effectual control.
- (2) The provisions of this Article shall not apply to—
  - (a) any pack of hounds while being exercised under the supervision of two or more competent attendants; or
  - (b) any dog in charge of a competent person while being used for sporting purposes, or for the capture or destruction of vermin, or for the driving or tending of cattle or sheep; or
  - (c) any dog confined in a suitable hamper, crate, box, or other receptacle, so constructed as to render it impossible for such dog while so confined to bite any person or animal.

Seizure, Detention, and Disposal of Uncontrolled Dogs.

5.—(1) Any dog in the Scheduled District-No. I. or No. II., which is not muzzled, or kept under control, as prescribed by this Order, may be seized by the Local Authority or by the police, and any dog so seized shall be dealt with by the Local Authority as follows:

- (i) If the dog is diseased or suspected, or has been bitten by a diseased or suspected dog, it shall be forthwith slaughtered.
- (ii) If the dog has been exposed to the infection of rabies it shall be detained, slaughtered, or otherwise dealt with as the Local Authority think expedient, but so that the dog shall not, while detained by the Local Authority, be allowed to come in contact with any other animal.
- (iii) In any other case the dog shall be treated as a stray dog seized under the powers conferred by section three of the Dogs Act, 1906.
- (2) No dog so seized shall be given or sold for the purposes of vivisection.
- (3) Every dog shall, for the purposes of this Article, be deemed to have been exposed to the infection of rabies which has been in the same shed, stable, building, kennel, field, or other place, or otherwise in contact with any diseased or suspected dog, or which has in any other way been exposed to the infection of rabies.

#### .Commencement of Part II.

6. This part of this Order shall come into operation on the twenty-fourth day of October, nineteen hundred and eighteen.

#### PART III.

### GENERAL.

#### Offences.

- 7.—(1) If a dog is moved in contravention of Article 1 of this Order, the owner of the dog, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the dog, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the dog is moved shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
- (2) If any dog in the Scheduled District. No. I. or No. II. is not muzzled, or kept under control, as prescribed by this Order, the owner of the dog, and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
- (3) If a dog which is being moved or has been moved with a licence under this Order is not muzzled or confined or is not detained and isolated as required by the conditions of the licence, the owner of the dog, and the person for the time being in charge thereof, shall, cach according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
- . (4.) If a person with a view unlawfully to evade or defeat the operation of this Order or of the conditions of a licence under this Order. allows a dog to stray, he shall be deemed guilty of an offence against the Act of 1894.
- (5.) If the owner or person in charge of a dog fails to give, produce, or do any notice, licence,

or thing which by this Order, or by the conditions of a licence thereunder, he is required to give, produce, or do, he shall be deemed guilty of an offence against the Act of 1894.

(6.) A licence under any Order hereby revoked shall have effect as a licence under this Order.

#### Interpretation.

8. In this Order—

"The Act of 1894" means the Diseases of Animals Act, 1894.

Animals Act, 1894.
"Diseases" means rabies, "diseased"
means affected with rabies, and "suspected"
means suspected of rabies.

"Public place" includes any street, highway, thoroughfare, public bridge, royal park, public park garden or pleasure ground, common, uninclosed land, or other place to which the public have for the time being access.

Other terms have the same meaning as in the Rabies Order of 1897.

#### Revocation of existing Orders.

9. The restrictions imposed by this Order are substituted for those imposed by the Cornwall and Devon (Control of Dogs) Orders of 1918 (Nos. 1 to 5), and those Orders are accordingly hereby revoked.

#### Local Authority to Enforce Order.

10. The provisions of this Order shall be executed and enforced by the Local Authority.

11. This Order may be cited as the Cornwall and Devon (Control of Dogs) Order of 1918 (No. 6).
