## BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Udo Eldon Emil Willmore-Wittmer.

Revocation of Certificate of Naturalization.

Whereas I am satisfied that the above named, Udo Eldon Emil Willmore-Wittmer, to whom a Certificate of Naturalization was granted on the 17th day of January, 1913, was on the second day of May, 1917, sentenced by District Court-Martial, held at Cleethorpes, to be imprisoned with hard labour for one year, and, further, that the continuance of the said Certificate is not conducive to the public good.

Now, therefore, by this Order, made in pursuance of the powers conferred on me by Section seven of the British Nationality and Status of Aliens Act, 1914, I revoke the said Certificate of Naturalization so granted to the said Udo Eldon Emil Willmore-Wittmer, and I direct such revocation to have effect from the date hereof; and I further order the said certificate to be given up and to be cancelled.

## HORWOOD HOUSE, WITHAM, ESSEX.

Certificate as an Industrial School.

The Secretary of State for the Home Department hereby gives notice that he has issued a Certificate under the provisions of the Children Act, 1908, that the premises known as Horwood House, Witham, Essex, are fit for the reception of boys or girls sent to an Industrial School in pursuance of the provisions of the Children Act, 1908, or of the Elementary Education Act, 1876.

The Certificate which bears date the 30th instant provides that no child shall be admitted who is over the age of eight years and states that the number of inmates resident in the School at any one time, whether sent thereto in pursuance of the said provisions or not, shall not exceed ten.
