ORDER OF THE BOARD OF
AGRICULTURE AND FISHERIES.

(DATED 13TH NOVEMBER 1918.)

LIVERPOOL (BIRKENHEAD) IRISH ANIMALS
LANDING-PLACE ORDER OF 1918.

1. The Board of Agriculture and Fisheries,
by virtue and in exercise of the powers vested
in them under the Diseases of Animals Acts,
1894 to 1914, and of every other power
enabling them in this behalf, do hereby revoke
the Orders described in the Schedule hereto,
and do hereby define the following part of the
Port of Liverpool as a Landing-Place for Irish
animals; that is to say:—

All that space at Birkenhead situate partly
in the county borough of Birkenhead and
partly in the county borough of Wallasey,

which is coloured pink on the plan (No. 32194)
sealed by the Board of Agriculture and
Fisheries for the purposes of this Order, and
deposited at the office of the Board.

2. This Order shall come into operation on
the fifteenth day of November, nineteen hun-
dred and eighteen.

3. This Order may be cited as the LIVER-
POOL (BIRKENHEAD) IRISH ANIMALS LANDING-
PLACE ORDER OF 1918.
