

behalf of the Entertainments Protection Association, of 67 and 68, Chancery Lane, W.C. 2, in the county of London, made application under Section 42 (1) of the Finance (No. 2) Act, 1915 (hereinafter called "the principal Act"), to the Commissioners of Inland Revenue for an increase of the statutory percentage as respects the class of trade or business hereinafter defined, that is to say:

"The business of carrying on music hall entertainments, excluding (1) the production and/or running of theatrical plays, and excluding also (2) the public exhibition of pictures or other optical effects by means of cinematograph or other similar apparatus, if such production, running, or exhibition constitutes substantially the whole of the entertainment."

And the Commissioners of Inland Revenue having referred the case to the Board of Referees appointed for the purpose of Part III of these Acts by the Treasury And the Board having heard the Applicant and the Commissioners of Inland Revenue by their duly-appointed representatives upon the merits of the said application, and having dealt with the case

The Board Doth Order that as from the commencement of the principal Act the statutory percentage as respects the class of trade or business hereinbefore defined shall be increased:

1. In the case of any trade or business carried on or owned by a company or other body corporate to 11 per cent.;

2. In the case of any other trade or business:—

(a) for accounting periods ending prior to the first day of January, 1917, to 11 per cent. plus 1 per cent.;

(b) for accounting periods ending after the thirty-first day of December, 1916, to 11 per cent. plus 2 per cent.;

except that for the purposes of sub-section (2) of section forty-one of the principal Act the statutory percentage shall be 11 per cent. plus 1 per cent.;

with the addition, in cases 1 and 2 (b) for accounting periods ending after the thirty-first day of December, 1916, of 3 per cent. for the purposes of sub-section (1) of section forty-one of, and paragraph 4 of Part II of the Fourth Schedule to, the principal Act.

Special Acts (Extension of Time) Act, 1915:

Further extending time limited by Clause 29 of the Chesterfield (Chester Street Area) Town Planning Scheme.

BOROUGH OF CHESTERFIELD.

To the Mayor, Aldermen, and Burgesses of the Borough of Chesterfield;—

And to all others whom it may concern.

WHEREAS by virtue of Clause 29 of the Chesterfield (Chester Street Area) Town Planning Scheme, as approved by an Order issued by Us, the Local Government Board, and dated the 4th day of September, 1916, and of an Order dated the 31st day of October, 1917, issued by Us under Section 1 of the Special Acts (Extension of Time) Act, 1915 (hereinafter referred to as "the Act of 1915"), the time within which claims (other than those referred to in the proviso to the said Clause) under Section 58 of the Housing, Town Planning, &c., Act, 1909, for compensation or in respect of any increase in value of property are required to be made, expired on the 4th day of September, 1918;

And whereas in pursuance of Section 1 of the Act of 1915, the Mayor, Aldermen, and Burgesses of the Borough of Chesterfield, acting by the Council, applied to Us before the expiration of the time limited as aforesaid for an Order extending that time:
