NATIONAL INSURANCE (HEALTH)

ACTS, 1911 to 1918.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by paragraph (F) of the First Schedule to the National Insurance Act, 1913, and by the National Insurance (Joint Committee) Regulations, 1913, to make regulations amending the National Health Insurance (Payments to Insurance Committees) Regulations, 1914, and providing for the establishment of a Fund to be called the Discharged Soldiers' Sanatorium Benefit Fund.
