7 HEREAS it is provided by Section 2 of VV the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th, day of May, 1917, and made under Sec-

tion 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

And whereas by subsequent Orders of Council and by the Proclamation, dated the 18th day of December, 1918, the said Proclamation was amended and added to in certain particulars :

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:

That the Proclamation, dated the 10th day of May, 1917, as amended and added to by subsequent Orders of Council and by the Proclamation, dated the 18th day of December, 1918, should be further amended by making the following amendments in and additions to the Schedule to the same:

CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD.

27th December, 1918.

The KING has been graciously pleased to institute a Military Division of the Most Excellent Order of the British Empire to date from the creation of the Order, i.e., the 4th June, 1917.

The following classes of persons will be eligible for appointment to the Military Division of the Order:-

All commissioned, warrant and subordinate Officers subject to the Naval Discipline Act or employed under the Order of the Admiralty, and all commissioned and warrant Officers recommended by any Commander-in-Chief in the field or elsewhere, or by the General Commanding, Independent Force, Royal Air Force, or employed under the War Office or Air Ministry, or under the Administrative Headquarters of Dominions or Overseas Forces, or employed under the Ministry of Munitions or the Ministry of National Service on work which, but for the creation of those Departments, would have been performed by the War Office; and all members of the Naval, Army, Dominions, or Overseas Nursing Services, or officials of the Women's Royal Naval Service, Queen Mary's Army Auxiliary Corps, or the Women's Royal Air Force, and such commandants of the Women's Legion or similar organisations as are under contract with or employed by the Admiralty, War Office or Air Ministry.

Persons already appointed to the Order who are qualified for the Military Division will, on the recommendation of the First Lord of the Admiralty, the Secretary of State for War or the Secretary of State for the Royal Air Force, as the case may be, be transferred to the Military Division.

The Insignia for both Military and Civil Divisions will be the same, but the ribbon of the Military Division will be distinguished by a vertical red stripe in the centre of the existing ribbon.

GENERAL ORDER OF THE LOCAL GOVERNMENT BOARD.

THE PUBLIC HEALTH (ACUTE ENCEPHALITIS LETHARGICA AND ACUTE POLIO-ENCEPHALITIS) REGULATIONS, 1918.

To the Mayor, Aldermen, and Commons of the City of London, in Common Council assembled;—

To the Councils of the several Metropolitan Boroughs, Municipal Boroughs and other Urban Districts in England and Wales;—

To the Councils of the several Rural Districts in England and Wales;—
To all Medical Practitioners;—

And to all others whom it may concern.

Whereas We, the Local Government Board, are empowered by Section 130 of the Public Health Act, 1875, as amended by the Public Health Act, 1896, from time to time to make, alter and revoke Regulations with a view to the treatment of persons affected with any epidemic, endemic, or infectious disease, and for preventing the spread of the disease; and to provide for the enforcement and execution of the Regulations;

And whereas Acute Encephalitis Lethargica and Acute Polio-Encephalitis are epidemic and infectious diseases;

And whereas it appears to Us to be expedient that such Regulations as are hereinafter set forth should be made in relation to Acute Encephalitis Lethargica and Acute Polio-Encephalitis:

Now therefore, We, by this Our Order, and in the exercise of the powers conferred upon Us by the Public Health Act, 1875, the Public Health (London) Act, 1891, and the Public Health Act, 1896, and of every other power enabling Us in that behalf, do make the following Regulations, that is to say:—

ARTICLE I.—In these Regulations, unless the contrary intention appears:—

(a) The expression "Local Authority" means, as the case may be, the Mayor, Aldermen, and Commons of the City of London in Common Council assembled, the

Council of a Metropolitan Borough, the Council of a Municipal Borough or other Urban District, or the Council of a Rural District;

- (b) The expression "District" means the District subject to the jurisdiction of the Local Authority for the purposes of the Public Health (London) Act, 1891, or the Public Health Act, 1875, as the case may be;
- (c) The expression "Medical Practitioner" means a duly qualified Medical Practitioner;
- (d) The expression "the Act of 1889" means the Infectious Disease (Notification) Act, 1 89, and the expression "the Act of 1891" means the Public Health (London) Act, 1891.

ARTICLE II.—These Regulations shall come into operation on the 1st day of January, 1919, and shall continue in operation for the period of one year from that date and shall be enforced and executed in every District by the Local Authority.

ARTICLE III.—Subject as provided in these Regulations, and subject to the provisions of Section 5 of the Local Government (Emergency Provisions) Act, 1916, every Local Authority and Medical Practitioner, shall, under these Regulations, have the same powers and duties in relation to the notification to the Medical Officer of Health—

(1) of cases of Acute Encephalitis Lethargica, as they have under the Act of 1889 or the Act of 1891, as the case may be, and

(2) of cases of Acute Polio-Encephalitis, as they have under the Act of 1889,

in the case of infectious diseases to which those Acts respectively apply.

ARTICLE IV.—The Certificate to be sent by a Medical Practitioner to the Medical Officer of Health of a case of Acute Encephalitis Lethar gica or of Acute Polio-Encephalitis, shall be in that form prescribed by the Public Health (Notification of Infectious Disease) Regulations, 1918, which is appropriate to the case.

ARTICLE V.—Nothing in these Regulations shall require a Medical Practitioner to notify any case of Acute Encephalitis Lethargica or of Acute Polio-Encephalitis which has already, to his knowledge, been notified to the Medical Officer of Health.

ARTICLE VI.—The Local Authority shall forthwith cause notice to be given to every Medical Practitioner practising within the District of the Local Authority of the duties imposed upon him by these Regulations.

ARTICLE VII.—This Order may be cited as "The Public Health (Acute Encephalitis Lethargica and Acute Polio-Encephalitis) Regulations, 1918."
