ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(Dated 4th February 1919.)

IMPORTATION OF DOGS (AMENDMENT) ORDER ог 1919.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:-

- 1.—(1) Notwithstanding the provisions of Article 1 of the Importation of Dogs Order of 1914 (hereinafter referred to as "the principal Order "), a dog may be landed in Great Britain if its landing is authorised by a licence granted by the Army Council or by some person specially authorised by the Army Council, subject to the following conditions, which shall be inserted in the licence, namely:
 - (a) the dog shall be moved from the place of landing direct to the kennels of the Royal Society for the Prevention of Cruelty to Animals at Hackbridge, in the county of Surrey, and not elsewhere;

(b) the dog shall, while being so moved, be confined in a suitable hamper, crate, box,

or other suitable receptacle;

(c) the movement of the dog to the above-mentioned place of detention shall take place under the superintendence of a person specially authorised by the Army Council; and

(d) the dog shall be detained and isolated at the above-mentioned place of detention for a period of six calendar months after

its landing.

- (2) The Army Council or authorised person may insert in a licence under this Order such other conditions as are authorised by Article 3 of the principal Order.
- 2. The provisions of the principal Order which relate to licences granted by the Board
