AMENDMENT.

With reference to London Gazette dated 1st February, 1919, the following is the correct statement of services for which the Military Cross was awarded to T./Lt. Eric Otto Dawber, R.F.A.:—

For outstanding gallantry while in charge of an advanced party of signallers on 18th-19th September, 1918, with the Seres Division in the battle of Doiran. During the attack on Grand Couronne he continually traversed the exposed slopes, taking messages to and fro over ground swept by machinegun and intense shell fire. His party being with the advanced battalion, he continued to obtain and transmit information in this manner for twenty-four hours on end, and only by his personal exposure and exertion was it possible for the advanced units to keep in touch.
