BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Carl Ernst Alfred Kaethner. Revocation of Certificate of Naturalization.

Whereas I am satisfied that Carl Ernst Alfred Kaethner, to whom a Certificate of Naturalization numbered 19081 was granted on the 27th May, 1910, has shown himself by speech to be disaffected and disloyal to His Majesty,
