Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited :

And whereas by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December, 1918, and the 12th day of March, 1919, the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :-

That the Proclamation, dated the 10th day of May, 1917, as amended and added to by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December, 1918, and the 12th day of March, 1919, should be further amended, so as to provide that, notwithstanding the Order of Council of the 1st day of October, 1918, as amended by subsequent Orders of Council, which has the effect of placing on List "C" all goods not included in Lists "A" or "B" of Prohibited Exports, all articles not included in the aforesaid List "A" or List "B" may be exported to Jugo-Slavia, Montenegro and Albania without licence, except the articles mentioned in the Order of Council of the 21st day of March, 1919, as constituting List "D" of Prohibited Exports so far as those articles are not already included in Lists "A" or "B.'

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
