HEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th day of May, 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain. articles to certain or all destinations was pro-

And whereas by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December, 1918, and the 12th day of March, 1919, the said Proclamation was amended and added to in certain par-

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect: -

That the Proclamation, dated the 10th day of May, 1917, as amended and added to by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December, 1918, and the 12th day of March, 1919, should be further amended, so. as to provide that, notwithstanding the Order of Council of the 1st day of October, 1918, as amended by subsequent Orders of Council, which has the effect of placing on List "C" all goods not included in Lists "A" or "B" of Prohibited Exports, all articles not included in the aforesaid List "A" or List "B" may be exported to Bosnia, Herzegovina, and those parts of Dalmatia not covered by the Proclamation of the 10th day of February, 1919, relating to the resumption of trade with certain parts of Austria-Hungary without licence, except. the articles mentioned in the Order of Council of the 21st day of March, 1919, as constituting List "D" of Prohibited Exports so far as those articles are not already included. in Lists "A" or "B."

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

And whereas by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December, 1918, and the 12th day of March, 1919, the said Proclamation was amended and added to in certain particu-

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:-

That the Proclamation, dated the 10th day of May, 1917, as amended and added to by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December, 1918, and the 12th day of March, 1919, should be further amended by making the following amendments in and additions to the Schedule to the same:—

- (1) That the following headings should be deleted:
 - (A) Iron angles, channels, joists, tees and other sectional material;
 - (A) Iron bars, including flats, rounds and other sections and shapes;
 - (A) Iron bridgework, pierwork and constructional material;

(A) Iron ingots;

(A) Iron plates and sheets;

Provisions and victuals which may be used as food for man, the following:-

(A) Fish, except the following:-Bloaters (tinned) and bloater paste, chinchards, herrings (tinned), kippers
