

humbly lay before Your Majesty in Council, the following Scheme with respect to the name of the Archdeaconry of North Wilts, in the Diocese of Bristol, and also with respect to the Rural Deaneries of Clifton and Stapleton, both within the Archdeaconry of Bristol, in the said Diocese of Bristol:

"Whereas by an Order of His late Majesty King Edward the Seventh in Council, bearing date the 10th day of August, 1904, and published in the London Gazette on the 12th day of the same month, a new Archdeaconry was created within the said Diocese of Bristol and such new Archdeaconry was named 'The Archdeaconry of North Wilts':

"And whereas it has been represented to us by the Right Reverend George, Bishop of Bristol, first, that the name of the said Archdeaconry of North Wilts has been found to be unsatisfactory and to lead to confusion with the Archdeaconry of Wilts, in the Diocese of Salisbury, and that a change in the name of the Archdeaconry from North Wilts to Swindon is desirable and should be carried into effect, and secondly, that the arrangements which are hereinafter recommended and proposed with respect to the said Rural Deaneries of Clifton and Stapleton, within the said Archdeaconry of Bristol, is also desirable and should be carried into effect, and we are of opinion that the same may properly be carried into effect:

"Now, therefore, with the consent of the said George, Bishop of Bristol, (in testimony whereof he has set his hand and Episcopal Seal to this Scheme), We, the said Ecclesiastical Commissioners, humbly recommend and propose that, as from the day on which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette, and without any assurance in the law other than such duly gazetted Order, first, the said Archdeaconry of North Wilts shall cease to be called by that name and that such Archdeaconry shall thenceforth be called 'The Archdeaconry of Swindon,' and secondly, within the said Archdeaconry of Bristol the Parishes of Stoke Bishop, Shirehampton and Avonmouth shall be transferred from the said Rural Deanery of Stapleton to the said Rural Deanery of Clifton.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other matter or thing with respect to the matters aforesaid, or any of them, by virtue of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas notices of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Archdeacons affected by the Scheme, that is to say, to the Archdeacon of Bristol and to the Archdeacon of North Wilts, and they have severally expressed their approval of the same:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Bristol.

The following Statutes made by the University of Cambridge, on the 26th day of May, 1919, have been submitted for the approval of His Majesty in Council, and Notice of their having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877."

STATUTES to alter and amend the Statutes in relation to the University of Cambridge made under the Universities of Oxford and Cambridge Act, 1877, 40 and 41 Vic. Ch. 21, which amending Statutes are now submitted for the approval of His Majesty the King in Council.

We, the Chancellor, Masters and Scholars of the University of Cambridge, in pursuance of the power given to us by the 53rd Section of the said Act, do hereby alter and amend the Statutes made under the said Act in relation to our said University in manner following:—

*Statute A.—Chapter II.*

By repealing Section 1A, intituled "Advanced Students in Arts" and Section 5A, intituled "Advanced Students in Law," and substituting for such repealed Sections the following Section to form an amended Section 1A.

*Research Students.*

1A. Research Students who are graduates of the University shall keep by residence at least three terms, provided that the University may allow such Students to count for this purpose residence which has been kept before admission as a Research Student. Research students who are not graduates of the University, shall keep by residence at least six terms, except in so far as the remission of three terms may be granted by the University for special reasons.

Research students shall pursue such studies and satisfy such conditions as the University may from time to time prescribe by Grace. Having done all that is required by the Statutes and Ordinances of the University, they may be admitted to the title of Doctor Designate in Philosophy, and shall afterwards be created Doctors of Philosophy at the time prescribed by the University.
